New Business:

Discussion: Sunken Boat in Harbor

The Bureau of Parks and Lands will then start the process of removal. Daryen said he would send sample letters to the assessors for review.

Discussion: Proposed Monhegan Boatline Scheduling for Winter 20/21

They stated they were waiting to see if they received a grant they applied for before they made a decision and that they would decide the schedule month by month as we are in a State of Emergency.
