#### **CITIZEN COMMENTS:**

# A. Mr. Hollis Smith, Laker Tire, 431 Madison, Russells Point

Mr. Smith provided council with a written request asking the Ordinance & Rules Committee to review the ordinance regarding storage of tires. He noted that his used tires are picked up every three weeks to be recycled; however he does not have the space to store them in an enclosed area as required by the current ordinance. Ms. Joan Maxwell had researched this request prior to the meeting and asked if this could be considered recycling materials in accordance with the ORC. Mr. Hollis also noted complaints with the Code Enforcement Officer regarding the denial of his recent submission for a sign permit, stating that initial talks with Mr. Kranenburg lead him to believe that this would be approved. Mayor Reames has been in contact with Mr. Kranenburg regarding this issue and noted that the initial discussion of the placement, number and size of the signs would have been acceptable; however the submitted application contained various changes which exceeded the limits of the sign ordinance. Mr. Hollis asked if the sign ordinance could also be reviewed. Mr. Steve Reid moved to refer any further discussion regarding these ordinances to the Ordinance and Rules Committee for review and that Mr. Kranenburg, Code Enforcement Officer is present for the meeting. Ms. Joan Maxwell seconded the motion.

Chief Freyhof reported the following updates:

• He will have his year-end report ready for the next council meeting.

- He is working on establishing an inventory of police department equipment.
- He is working on two grants one for (2) mobile repeaters; and one to replace the mobile/portable radios.
- The Kevlar vests will expire this year and they are researching possible grants to pay for a portion of them.
- Council will be presented with the Chief's candidate to replace Officer Lewis for completion of the 2902 police grant.
- There are currently five or six impounds that could be sold on GovDeals this year.
- There is a police levy committee meeting January 24, 2014 at 9:00 at Aunt Millies Restaurant.

#### **OLD BUSINESS:**

# A. 316 Westview Property Owned by Ms. Janice Rogers

Ms. Janice Rogers was permitted an additional thirty day extension by the Logan County Health Department to obtain an inspection report by a structural engineer for the property. The next hearing is scheduled for Wednesday, February 5, 2014.

#### A. Wilhelmina Schouten Bonds

After the death of Ms. Schouten, various documents have been copied and sent to the Village Solicitor for review the agreements of the two municipal building bonds payable to Ms. Schouten.

Mayor Reames closed the nominations. Since there was only one member wishing to remain as a nominee, a written ballot was not required. Mayor Reames called for a vote of those in favor of Mr. Reid presiding as President Pro-Tem for 2014.

The vote: 6 yeas - 0 nays.

## E. Martin Luther King Holiday

Mayor Reames asked council if they wished to re-schedule the January 20, 2014 meeting due to the Martin Luther King Holiday. Council agreed to hold the meeting as scheduled.

#### **ADDITIONAL COMMENTS:**

## A. Lack of Communication

Councilman Reid expressed his concern of a lack of communication between the Mayor and Council in regards to a recent press release by the Mayor asking residents to check for, and report, standing or pooling water around their homes and neighboring homes. The press release was issued because

abnormal amounts of water usage were reported by the water department. It was thought that this may be due to broken water lines caused by the recent cold front and below zero temperatures. Council asked that they be informed of these types of situations.
