**Approval of Minutes:** Marsha Landers made first motion; seconded by Penny Duffee. Approved unanimously.

Treasury Report: No report given. Next report will be given at January meeting.

#### **Old Business:**

Report given on the items PSSC provided for the Welcome Bags for the 2020 and 2021 National Specialties. The small mesh bags contained a note pad with PSSC logo, pen with PSSC name, and a breakfast bar. Our donations were well received.

#### **New Business:**

**Wicket:** The PSSC has purchased an official wicket at a good price since being a dog club. A seminar will be scheduled at the May 2022 dog show at the Interstate Center as to how to use the wicket (including the rights, obligations, and procedures in measuring a dog).



**Guest Introduction:** Guest Darcie Mair, who was in attendance at this meeting, was introduced to club members. Darcie comes from Indiana and is a proud owner of a miniature Schnauzer, Standard Schnauzer, and a Giant Schnauzer.

**Xylitol:** Information from the American Kennel Club Government Relations Department was presented on the danger of Xylitol found in various products that dogs might ingest. It is important for dog clubs and members to contact their legislators in support of HR 5261, called the "Paws Off Act," which amends the Federal Food, Drug, and Cosmetic Act to deem foods containing xylitol as misbranded unless the label or labeling of such foods contains a warning specifying the toxic effects of xylitol on dogs if ingested.

Xylitol (or "birch sugar") is a chemical compound most commonly used as a sugar substitute in chewing gum, dental products, peanut butter, baked goods, and other human foods. Xylitol is harmful to dogs because, unlike humans, it is quickly absorbed into the bloodstream and may result in sudden release of insulin from the pancreas. The rapid release of insulin into a dog's bloodstream may cause hypoglycemia. In dogs, this may occur within 10-60 minutes of ingestion of xylitol and if untreated, can quickly become life-threatening.

AKC suggests that clubs and members contact their members of Congress and ask them to support or consider co-sponsoring HR 5261, the "Paws Off Act", to require that food products in the U.S. containing xylitol include a warning label about the toxicity and potentially deadly effects of xylitol on dogs.

**Epilepsy Research:** Penny Duffee presented information on epilepsy in Standards Schnauzers. She has worked with the AKC Canine Health Foundation (CHF) to establish the *Duffee Standard Schnauzer Epilepsy Research Fund* DAF that will focus on researching genetic markers suspected to be responsible for epilepsy in Standard Schnauzers. Further research is necessary to verify what DNA markers might cause such epilepsy and, if found from research, will allow breeders to identify

dogs that are carriers of the gene for epilepsy, and those that will develop the disorder. This Fund provides a foundation for ongoing research on epilepsy in Standard Schnauzers and is open for donations through the AKC CHF.

## Do You Know What It Means When Your Dog Sits on your Feet?

This may sound as new, but your dog does this for a reason. It could be due to loneliness or stress they are suffering from, or they want to show you how much they love you by doing this. There could be several reasons why your Standard Schnauzer sits on your feet.

#### To show their submission

Among all the pet animals, your dog is considered as the most loyal pet. It is also proved that they carry more emotional intelligence than any other pet animal. They know how to surrender themselves in a true sense without any expectations. These qualities make them the most lovable pets. They demonstrate their total submission by wagging their tail and by licking their owners' feet. This is one way through which they want to say how much respect they carry for their owners. Also, they want to let others know that I am under the guidance of my caretaker. So, sitting at or on your feet makes them feel proud and they want to say that you are my security blanket.

#### To get your attention

Dogs use various body language to convey their message. Many times, they are seeking your attention and want your undivided love. Dogs like to get a human touch or cuddling their bodies. This makes them feel calm. By sitting at or on your feet, they might try to communicate their needs. Perhaps, you forgot to fill their water bowl or its time for a meal.

Dogs are more attentive than a human being. Seeking your attention can have some genuine reason. They are capable to observe any incident that would prove to be dangerous much before it happens. So, it could be possible that they want to drag your attention towards any unexpected incident that can harm you. So, paying attention to a dog's body language can keep you safe.

#### To gain some information

By nature, your dog is a very curious pet and may want to unfold the hidden reality behind every scene. Many times, it happens while having our meal something left over at our feet. And as your dogs have a very sensitive nose and they can get the smell of that piece of food, even if they are far away. If they find that smell pleasant and they will immediately run for it.

Dogs are also attracted to the sweat of our feet as its salty taste appeals to them. Whenever a dog licks or smells the sweat of human feet they try to gather information about that person and they remember it for a long time. Dogs have strong scent receptors present in their noses. That's why to catch the real culprit of crime, police use dogs to identify the criminal if they find any of the criminals belonging as evidence.

#### • To comfort you

Dogs are insanely intuitive when it comes to our own emotions. When we're feeling stressed or unwell, our dogs can often sense that and won't leave our sides. Our dogs can't share comforting words to help us feel better, but they may sit on or lay at your feet to offer you support.

#### Feeling uneasy

Most pet owners are not aware of their dog's mental health. Many times, it happens that your dog is feeling uneasy, or something scares him. They want to feel safe and protected. So naturally right up close to your feet make them feel calm and secure. In case if you notice such scary behavior of your dog, then immediately calm them down. Give them gentle rub under the chin and reassure everything is going to be fine. If possible, offer your warm hug as it works wonder and calms them down instantly.

#### To mark their ownership

By sitting on your feet, your dog is claiming to the world that you belong to them. Those who have more than one dog might have noticed this. They compete with each other to get the best spot near you and want to prove that I am increasingly closer to my owner. No doubt this behavior may be your dog's way to show his or her regard for you—you are the parent and guardian. Perhaps there is an element of possession, but your beloved pooch naturally feels both of you belong to each other.

#### To guard you

Dogs are genetically inclined to guard the leaders. They know how to pay respect to their owners. By sticking close to you they believe they are guarding you. They believe they are making you feel safe and protected by being so close to you. They do all kinds of stuff to make you feel good and make your day. They feel that it is a matter of pride for them.

#### To show their affection

By parking themselves on your feet, they want to tell you that not to go anywhere or don't leave me alone. This way, they can truly be the center of your attention. Such acts make your bond between you and your dog much stronger. No pet owners want to leave their pets alone but there are few instances where we are forced to do so. Even you might have noticed whenever you return from all day long your puppy just wants to be close to you. After all, for them you are not just a pet owner, you are the whole world.

#### Conclusion:

Standard Schnauzers can certainly learn that if they sit on or lie at your feet, they are more likely to get your attention. It is a normal reaction to look at or talk to your dog when they choose to sit on top of your feet. Or you dog may have learned that you give them physical attention in the form of petting or ear rubs as they sit at or on your feet. This positive reinforcement makes it more likely that your Standard Schnauzer will continue to sit on or by your feet.

#### Paws off Xylitol: It's Dangerous for Dogs!

Your 6-month old puppy will eat anything not tied down. Or your older dog got a hold of a cinnamon bun and got hideously ill; it turned out the glaze on the bun was made with an artificial maple syrup that contained xylitol.

Chances are you know that **xylitol**, an artificial sweetener, is toxic to dogs. But you may be surprised by what types of products can contain xylitol. While you'd never intentionally feed this stuff to Rover, accidents can happen.

You may have heard you should never leave sugarless gum or mints that have xylitol in them anywhere dogs can get them. This includes in your purse, in the car, on your bedside table, or anywhere else your dog may have access to.

**Xylitol**, also known as 'birch sugar' or 'wood sugar' (it's made from birch and other wood products), is more and more commonly used in products for humans. It's often used in candies and baked goods meant for diabetics. But increasingly, it's used in regular baked goods, because it's heat-stable and doesn't caramelize like regular sugar does. **Xylitol is frequently** not listed on a food ingredient label.



# Are you aware MANY MORE foods, medicines, supplements, and oral health products contain xylitol? It's commonly found in:

- Peanut butters and other nut butters. This one is particularly scary since many people use peanut butter to stuff their dogs' Kong or other food-puzzle toys. Always check the label of nut butters and any other food you use in a Kong or food-dispensing toy!
- Toothpastes, mouthwashes, breathe mints.
- Cough syrup and cough drops.
- Children's and adult chewable vitamins.
- Supplements and over-the-counter medications. It has been found in a melatonin supplement to help with sleep; imagine if the bottle was on a bedside table and a dog helped themselves to the bottle?
- "Skinny" low-calorie, keto, or low-carb ice cream.
- "Low-calorie" desserts of any kind (cookies, cakes, "energy" bars).

#### It also doesn't take very much xylitol to seriously sicken or kill your dog.

According to the U.S. Food and Drug Administration, symptoms of xylitol toxicity in a dog include vomiting, followed immediately by symptoms associated with the sudden lowering of your dog's blood sugar, such as decreased activity, weakness, staggering, incoordination, collapse, and seizures.

In dogs, xylitol is quickly absorbed into the bloodstream, and can cause a strong insulin release, which can lead to liver failure. The increase in insulin leads to hypoglycemia (lowered sugar levels), an effect can occur within 10 to 60 minutes






**of eating xylitol**. Untreated, this hypoglycemia can quickly be life-threatening. Elevated liver enzymes and liver failure can be seen within a few days.

The FDA advises: "If you think your dog has eaten xylitol, take him to your vet or an emergency animal hospital immediately. Because hypoglycemia and other serious adverse effects may not occur in some cases for up to 12 to 24 hours, your dog may need to be hospitalized for medical monitoring."

#### **Prevention is key**

The best way to prevent your dog from an accidental poisoning is to <u>not buy</u> products that contain xylitol, so they





But if you do have mints, toothpaste, cookies, or anything else in your home that contains xylitol, you must manage xylitol like a loaded gun in a house full of toddlers. Keep any xylitol item in a closed cabinet where the dog cannot possibly reach, never just on a counter that a dog might be able to jump up and reach. If your dog is not a "counter surfer," you may be casual about items like toothpaste or maybe mints

on a coffee table. But a guest's dog may be different – and all counter-surfers start somewhere, usually with some food item. You'd hate for your dog's first foray into helping himself to a xylitol-containing food or supplement to be his last meal ever.

## URGE CONGRESS TO SUPPORT NEW XYLITOL PET SAFETY LABELING REQUIREMENTS

Bipartisan legislation has been introduced in Congress called the **Paws Off Act of 2021 (HR 5261)** that would require manufacturers of any product containing xylitol to include a warning label.

Contact your member of Congress. Ask them to support HR 5261, the "Paws Off Act".

ASPCA Animal Poison Control Center (open 24/7) at (888) 426-4435, and/or your local vet or an emergency vet. Tip: it's a good idea to keep all these numbers saved on your phone!

According to the American Society for the Prevention of Cruelty to Animals (ASPCA) animal poison control center, xylitol poisoning calls have increased dramatically over the last 15 years. In 2018, the ASPCA registered 6,760 xylitol-related calls, more than 30 times the number of calls related to xylitol in 2005.


