- 1. The GeoView GPR results are in. I have attached them to this email for your viewing. You will see both homes side by side where the four anomalies appear. #1 is the most severe and stretches across both properties. #3 reaches onto the Golf Course easement and very slightly under the path. See attached for a compilation site map of the property.
- 2. I reported property disturbances in January, February and March to Community Watch (352 753-0550) and asked they be marked.
- 3. The Florida Health-Marion County representative returned this week to follow up on health & safety issues at the untreated pool at 17086 and the hot tub/spa at 17092.
- 4. TECO (Gas Company) removed the gas meter from the property and will return in the future to cut lines.
- 5. Last week Haden Wrobel's investor, Lynn, visited his properties expecting them to be almost ready for sale.
- 6. Battalion Chief, Jackie Tuggerson, of The Villages Public Safety Department arrived this morning with his men and placed caution tape on the back across both properties.
- 7. Marion County Taxes (2018/2019) have not been paid by Mr. Wrobel.
- 8. April 20 the current permit will run out for both properties and Marion County may transfer the case to their Code Enforcement Department. However, it is also possible that it might be extended if the recent Engineering Report is approved.
- 9. The District 4 Board of Supervisors meets this Friday, March 13th at the Savannah Center at 1:30 PM. Mr. Savage, Marion County Building Manager, is expected to attend. The public may ask questions.
