### Approval of Minutes

#### By Laws

Frank G made the motion to accept the revised by laws and Mike M. 2<sup>nd</sup> the motion. It was voted on by the board members in attendance and unanimously approved.

The following by laws were proposed and voted on:

1.

XIX. 3. If ejected from the game or gym, the intramural or travel player, coach, assistant coach, parent or spectator is also suspended for the next game regardless of league.

#### Marc made a motion to approve. Greg 2<sup>nd</sup> the motion. 4 for and 2 against. Approved.

2. XX K. Any league participant ejected must be reported by the Coach to the Director. Failure to immediately report any player ejections by a Coach to the League Director and/or allowing a player to play a game he would otherwise be ineligible to play, will result in the coach being suspended for 1 game.

#### Steve made the motion to approve. Maria 2<sup>nd</sup> the motion. Unanimously approved.

3. Under both XVI: Advisory Board Positons 7&8 – The travel director will be required to notify the advisory board of all travel league placements.

#### Steve made the motion to approve. Greg 2<sup>nd</sup> the motion. Unanimously approved.

#### **Board Positions**

General Member – Duties include advising the full board on matters pertaining to the WTPR Basketball program. Individual must be a prior board member within the last 10 years. It is a 2 year term with voting rights.

#### Steve made the motion to approve. Stephanie 2nd the motion. Unanimously approved.

League Scheduler – A paid stipend position. Duties include maintaining gym schedules and assigning for the leagues, also working in conjunction with Parks and Rec to secure space in the Washington Township schools (elementary-high). Also, the scheduler is required to let league directors know when unscheduled space becomes available. It is a two year, non-voting position.

Stephanie made the motion to approve. Mike 2nd the motion. Unanimously approved.

#### Finances

Greg Fath reported that Boiler Fees will not leave enough funds in the Trust account and it will be necessary to raise registration fees for the 2016-2017 season.
