## Conduct in Cemetery

### No person shall:

- Orive any vehicle, on other than established drives, except for maintenance personnel.
- Deposit rubbish or debris on cemetery grounds, except at a designated place or in receptacles provided.
- Pick or mutilate any flowers, either wild or domestic, or disturb any tree, shrub, or other plant materials.
- Consume alcoholic beverages in a cemetery or carry same upon the premises.
- Permit any animals, that is dogs, cats, etc. to enter or remain in the cemetery.
- ♦ Use any form of advertising on cemetery premises.
- Discharge a firearm in or adjacent to the cemetery. This prohibition shall not apply to authorized volleys at burial services.
- ♦ No admittance after sunset.

#### **Funerals:**

All funerals within the cemetery shall be under the directions of the superintendent of the cemetery or one of his assistants. No internment equipment except that authorized by the Township shall be used. The Cemetery Management reserves the right to remove funeral designs and floral pieces as soon as they become unsightly.

### Conduct in Cemetery Cont.

The Superintendent of the Cemetery shall not be held responsible for errors in locations of graves when orders are given by telephone. No graves shall be opened except by workmen employed by the Township. Funeral directors are to arrange the time of funeral so that the cemetery workmen can complete internment by 4:30 pm.

#### **General Internment Restrictions:**

Six containers of cremated remains may be buried in a grave that does not and will not contain a body. No more than 3 containers of cremated remains may be buried in one grave which contains a previously interred body. Two containers of remains may be buried in advance of a body interment.

Unauthorized burial of ashes is prohibited.

#### **Decoration of Lots:**

Lot decorations shall be deemed to include all structures, ornaments, plantings, or other embellishments, with the exception of markers, which are placed on cemetery lots with the intention of improving their appearance. Because certain types of individual lot decorations are not in harmony with the development of the cemetery as a whole or because they may intensify maintenance problems, the Township enforces certain rules regarding the decoration of cemetery lots.

Flags: will be permitted on lots in flush marker sections one day preceding Memorial Day and one day after. No other lot decoration of any description will be permitted on lots in flush marker section.

Only one shepherd's hook will be allowed per plot. It must have a simple, step down insertion, no driven/hammered apparatus will be allowed. Boxes, etc. over 20 lbs will not be allowed and will be permanently removed.

ALL DECORATIONS CAN BE PLACED BEFORE MOTHER'S DAY AND NEED TO BE REMOVED BY SEPTEMBER 30th. Location of markers on a lot: Markers may be placed at either the head of the grave, or at the foot of the grave, or both. All markers must be centered over the head or foot, width wise, and must be located at least 6 inches away from other markers. No marker shall embrace two or more graves, except on a two or three grave lot where a double marker is permitted.

No burials shall be made on Sunday or legal holidays.

All burials must be made by the Sexton and recorded in the Township's Clerk's office. Please call number below.
