The Amana Colonies will be holding a Public Hearing to review an application for a State Revolving Fund (SRF) loan from the Iowa Department of Natural Resources, and to make available to the public the contents of an environmental information document and City's project plan. These documents include design and environmental information related to the proposed improvements to the City's water supply system.

The proposed project involves the construction of new wells, installation of new water mains, water treatment, pressure pumping station, demolition of 5 water towers, and one new water tower.

Be mindful of children and adults walking and riding bikes on streets and on the trail before and AFTER the fireworks display.

Amana Recreational Trail on the 4th

On Tuesday, July 4 a section of the Amana Kolonieweg recreational trail will be closed while volunteers set up the fireworks display and clean up afterward.

Please do not use the trail from the Lily Lake bridge (north shore) to the mill race, in other words the trail along the east shore of the lake, as crews will be assembling the fireworks and cleaning up afterward. Please remember motor vehicles are not allowed on the trail at any time. Your cooperation is greatly appreciated.

Village Streets Seal Coated by County

lowa County recently completed its 2017 repair of Amana Colony streets.

lowa County Éngineer Nick Amelon reported that during the past couple of weeks asphalt streets in Amana, East Amana, Middle Amana, High Amana and West Amana were coated with a layer of oil and a layer of small rock chips which was then compressed.

Over time the "chip and seal" will compress further. Chip and seal coating smoothes the street and seals cracks, thus adding to its longevity, Amelon explained. The total project cost was between \$165,000 and \$175,000. This project will be paid for with money from the Amana Colonies Road Use Tax Fund, he added.

No other projects are planned in the Amana Colonies this year, Engineer Amelon told the Amana Bulletin Monday.

Only those previously seal coated or asphalt streets were seal coated in the seven villages. Concrete streets in Amana, Homestead, South, Amana and High Amana were not seal coated, because of course, to do so would not be helpful.

As noted, this project was paid for via the Amana Colonies Road Use Tax Fund. About \$1.1 million is in the Amana Colonies Road Use Tax Fund, Engineer Amelon reported Monday.

The Amana Colonies Road Use Tax Fund was created in 1961 and is provided for in the lowa Code, Section 312.8 pertaining to road use taxes and allocations. The fund increases about \$125,000 each year through motor fuel taxes collected in the Amana Colonies plus license fees and vehicle registrations collected from Amana Colony residents. Statewide all such fuel taxes and motor vehicle fees are collected by state and then apportioned according to lowa law to various road funds at the state, county and city level. The amount that would have gone to the seven villages of the Amana Colonies were they incorporated is allocated to the lowa County Supervisors for use on streets and roads in the Amana villages. It is kept separate from other county road use funds, and it may not be used for salaries or other projects outside of the villages.

Since becoming Iowa County Engineer four years ago, Amelon has overseen two road projects in the

Amana Colonies. Last week's seal coating project and two or three years ago pot holes and cracks in the villages were fixed with a "slurry seal." The slurry sealing cost about \$100,000. So in four years about \$265,000 has been spent on Amana Colony roads/ street repairs. As Amelon said, this is on par with the amount of money spent by lowa County on other county streets and roads.

Some residents had hoped for a more extensive repair or even replacement of "F Street" the back street in the village of Amana. Indeed about 6 years ago there was discussion of perhaps undertaking a major revamp of the street. Nothing came of those discussions and as of now, Amelon said, there is no plan to make improvements to Amana's "back street."

There are a few smaller projects in the Colonies being considered for next year, Amelon said. He is taking a look at several projects but has not made a decision as to which projects might be undertaken in 2018. He is seeking input from Amana Colony residents while considering projects, he noted.
