#### Mercedes Benz






### Johnny Depp- Actor

Chenault attended the Waldorf School of Garden City, New York. He graduated from Bowdoin College with a degree in History in 1973. Three years later, he graduated from the Harvard Law School.

Chenault began working at the law firm of Rogers & Wells in New York City following his graduation from Harvard. He soon moved on from the firm. After a brief stint in legal practice, he joined Bain & Company as a consultant. He worked as an attorney before transitioning into business, joining American Express in 1981. Chenault was named CEO of American Express in 2001, becoming one of the first African Americans to hold this position in a Fortune 500 company. American Express said that Chenault age 66, will be replaced by Stephen Squeri, 58, on February 01, 2018.

OJ Simpson, NFL Player and same as Kenneth Chenault of American Express The Nevada Department of Corrections, in an effort to ensure public safety and reduce the potential for incident, released Orenthal James Simpson #1027820, on October 1, 2017, at 12:08 AM from Lovelock Correctional Center."

OJ Simpson spent 9 years in prison. He was granted parole in July, having been sentenced to 33 years on a 12-count charge stemming from a hotel room armed robbery of sports memorabilia.

Simpson, of course, had been acquitted 13 years earlier in the murders of Nicole Brown and Ronald Goldman, though a 1997 civil trial found him accountable for the deaths.

National Football League (NFL) player, broadcaster, and actor Orenthal James "O. J." Simpson was tried on two counts of murder for the June 12, 1994, deaths of his ex-wife Nicole Brown Simpson and restaurant waiter Ron Goldman. A certificate of the death of Nicole Simpson is below.


