To the Sherburn and Welcome City Councils,

The department logged 108 calls for service for the month of August. This brings the total for the year to 983. In comparison, we were at 967 at this point in 2012 and 905 in 2011. The last few months have had slightly lower monthly totals, but I still believe we are on pace for a higher yearly total.

Response time was excellent for the month. We averaged less than a minute for response time in the month of August. As is the past, however, the lower number of calls will directly affect the response time numbers slightly.

We have started using the Jamar Radar Recorder that was purchased earlier this summer. These units were purchased in cooperation with the Fairmont Police Department and allow us to track traffic information in various areas of the cities. Data collected will tell us the speed of every vehicle that passes through the study area and if high rates of speed are common or not. There have been a few areas in both communities that continually get complaints about the speed of vehicles, so this will help us in determining if there is an enforcement issue or not. I will include a couple of the reports next month.
