Quick Points of Interest

Public Service Announcement from FBI Newark



Dec 4th - FBI Newark alerts residents who received a COVID-19 test at Infinity Diagnostic Laboratory in Ventour to be retested and reach out to our office.

As stated on the [U.S. Food and Drug Administration's website](https://www.fda.gov/food/rapid-testing), "rapid" finger-prick blood tests for COVID-19 are antibody tests and should not be used for diagnosing active cases of COVID-19. Only a test that uses a nasal swab or saliva should be used to diagnose active cases of COVID-19.

If you were recently tested for COVID-19 at Infinity Diagnostic Laboratory, located at 6715 Atlantic Avenue, Ventour, NJ, you are urged to be retested as soon as possible. If you were tested using a finger prick blood test at that location, please contact the FBI at NK-Victim-Assistance@FBI.gov.

Your response is voluntary but would be useful in a federal investigation. Based on the response provided, you may be contacted by the FBI and asked to provide additional information.

CDC Updates Quarantine Guidelines

Options to Reduce Quarantine for Contacts of Persons with SARS-CoV-2 Infection Using Symptom Monitoring and Diagnostic Testing

Updated Dec. 2, 2020 - Local public health authorities determine and establish the quarantine options for their jurisdictions. CDC currently recommends a quarantine period of 14 days. However, based on local circumstances and resources, the following options to shorten quarantine are acceptable alternatives.

- The quarantine can end after Day 10 without testing and if no symptoms have been reported during daily monitoring.
 - With this strategy, residual post-quarantine transmission risk is about 1%, with an upper limit of about 10%.
- *When diagnostic testing resources are sufficient and available*, then quarantine can end after Day 7 if a diagnostic specimen tests negative and if no symptoms were reported during daily monitoring. The sample may be collected and tested within 48 hours before the time of planned quarantine discontinuation (e.g., the anticipation of testing delays), but quarantine cannot be discontinued earlier than after Day 7.
 - With this strategy, the residual post-quarantine transmission risk is about 5%, with an upper limit of about 12%.

In both cases, additional criteria (e.g., continued symptom monitoring and masking through Day 14) must be met and are [outlined in the full text](#).

NHTSA - Critical Vehicle Recall Information - Chevrolet Bolt

Owners of select Model Year 2017-2019 Chevrolet Bolt vehicles should park their cars outside and away from homes until their cars have been repaired due to a new recall for fire risk.

GM has issued a recall of 50,932 Chevrolet Bolt vehicles for the potential of an unattended fire in the high-voltage battery pack underneath the back seat's bottom cushion. The affected vehicles' cell packs have the potential to smoke and ignite internally, which could spread to the rest of the car and cause a structure fire if parked inside a garage or near a house.

These vehicles can catch fire even if they are turned off, parked, and disconnected from a charging unit. NHTSA has confirmed five known fires with two injuries; at least one of the fires spread from the vehicle and ignited a home. Until these recalled vehicles have been repaired, the safest place to park them is outside and away from homes.

New Jersey Division of Highway Traffic Safety Kicks Off “Drive Sober or Get Pulled Over” Campaign Against Impaired Driving

Starting December 4th, law enforcement agencies across the state will be patrolling New Jersey roads looking for drunk and impaired drivers as part of the annual “Drive Sober or Get Pulled Over” holiday campaign, which runs through January 1, 2021.

Of the 559 people killed in traffic crashes in New Jersey last year, nearly a quarter of them – 129 – lost their lives in crashes involving drunk drivers. According to the NHTSA, drunk driving crashes claim the lives of more than 10,000 people nationwide each year.

New Jersey’s campaign is part of a nationwide effort to reduce crash risks during the holiday season. To assist with New Jersey’s enforcement efforts, the Division has awarded grants totaling \$656,340 to 114 agencies across the state to fund enhanced patrolling and high-visibility sobriety checkpoints throughout New Jersey during December.

“This has been a year of tremendous loss for New Jersey residents impacted by the COVID-19 pandemic, and we are all feeling especially grateful for the loved ones with us this holiday season,” said Attorney General Gurbir S. Grewal. “Help ensure that everyone can safely celebrate this year by driving sober and unimpaired. Drunk driving crashes are tragic and preventable. We are stepping up patrols and enforcement to keep New Jersey roadways safe for all who use them this holiday season.”

“Our mission is to ensure that travelers on New Jersey roadways reach their destinations safely – especially during the holiday season when crash risks increase,” said Eric Heitmann, Director of Division of Highway Traffic Safety. “We pursue this mission through programs like Drive Sober or Get Pulled Over that raise public awareness of the dangers of impaired driving and provide law enforcement with funding for enhanced enforcement. This season make sure a designated driver is part of your holiday celebration plans. Anyone driving under the influence can count on encountering a law enforcement presence on the State’s roadways.”

Last year, the Drive Sober or Get Pulled Over holiday campaign resulted in 1,380 DWI arrests (alcohol and/or drugs) statewide; participating police agencies issued 4,960 and 2,023 speeding and seats belt summonses respectively. Many departments reported noteworthy accomplishments, including 14 agencies making 13 or more DWI arrests during the campaign.



Some Words from the Director – Eric Heitmann

December is here, bringing holiday cheer, the hustle and bustle of the busy shopping season and the anticipation of COVID-safe small gatherings with loved ones!

Here at the New Jersey Division of Highway Traffic Safety, we want to help preserve the magic of the season by ensuring that all holiday travelers reach their destinations safely by pledging to drive sober as we participate in our annual “Drive Sober or Get Pulled Over” enforcement mobilization, obeying the speed limits on our roadways, and saying NO to risky driving behaviors.

During the pandemic, statistics have shown that alcohol and drug use has increased in correlation with a rise in anxiety, depression, and other mental health disorders, which has led to more people driving under the influence. Other worrisome statistics show that even though our roadways are less crowded with more people staying at home, the number of fatalities has remained consistent to pre-COVID times due to an increased number of drivers speeding and a decreased use of seatbelts. Traveling at high speeds without seatbelt use has resulted in an increased number of crashes where people are killed from being ejected from their vehicles.

We want everyone to arrive at their destination ALIVE. You can help prevent crashes and deaths related to impaired driving and other risky roadway behaviors by reminding drivers to have a safety plan.

Please convey the following tips to highway users through your social media and websites to help ensure a holiday season that is safe and fun for all:

- Before drinking, designate a sober driver.
- If you are impaired in any way, use the National Highway Traffic Safety Administration’s “SafeRide” app to call a taxi or a friend. The app is available on [Google Play](#) for Android devices and Apple devices on the [iTunes store](#). Remember, buzzed driving is drunk driving.
- If you are hosting a small gathering, make sure all guests leave with a sober driver.
- If you see a drunk driver on the road, call law enforcement immediately.
- Always wear your seat belt, no matter what seat you are sitting in or how long your trip is.
- Obey all speed limits, even if the roadway seems emptier than usual. Speed limits are created with your safety in mind.

NJ Licenses & IDs Go to Central Issuance

November 23, 2020 - As part of a long-planned security upgrade, NJMVC is rolling out a new license design with modern security features, issued centrally from a secure production facility.

Central Issuance is industry best practice, providing greater fraud protection and security for individuals' personal information and protecting them from identity theft.

At least 27 states already have a practice of Central Issuance.

What this means for the customer:



Licenses will no longer be printed at Licensing Centers while you wait but will be mailed to you. You will be given an interim license at the center.

The current printers, which are outdated, frequently overheat, and break down, will be removed from the Centers. Your transaction will be quicker and more efficient, getting you in and out of the center in less time.

"My Office is honored to work with Chief Sue Fulton and her team at the New Jersey Motor Vehicle Commission to move forward with this long-anticipated update that enhances the security of New Jersey licenses," said Jared M. Maples, Director of the New Jersey Office of Homeland Security and Preparedness. "In addition to complying with national REAL ID standards, having secure identity credentials better protects New Jersey residents from fraud and identity theft."

"Our commitment to producing secure, reliable documents requires constant updates to our security, and we're grateful for the support and counsel of Director Maples and the Office of Homeland Security and Preparedness," said Sue Fulton, Chief Administrator of the Motor Vehicle Commission. "We already mail hundreds of thousands of licenses via our online and mail renewal systems, but this initiative will round out that process – and have the side effect of speeding your trip if you have to visit the agency in person."

This initiative, originally planned as part of REAL ID Readiness, was delayed due to the COVID-19 crisis. It is now expected to go live on November 24th.

Quantifying Drowsy Driving [Traffic Safety Facts Research Note]

According to NHTSA's National Center for Statistics and Analysis, drowsy driving was a contributing factor in 775 deaths in 2018, or 2.1% of total fatalities involving motor vehicle crashes on U.S. roadways. However, statistics likely underestimate the extent of the drowsy driving problem. The American Automobile Association Foundation for Traffic Safety estimated the percentage of fatal crashes that involved a drowsy driver at 21%. This Research Note explores the feasibility of using machine learning algorithms to identify drowsy driving episodes in large-scale naturalistic driving datasets. The Strategic Highway Research Program 2 (SHRP2) Naturalistic Driving Study (NDS) collected data from more than 3,400 participating drivers in six States, yielding time series data for more than 5 million trips. The SHRP2 NDS database contains vehicle variables and video data, including a view of the driver's face.



Evaluation of Correct Child Restraint System Installation

This research project used an experimental design, called an "incomplete factorial" type, with a convenience sample of 75 novices and 75 experienced child restraint system (CRS) users to test whether user experience, child's age/weight/height, vehicle characteristics, and CRS characteristics are associated with installation errors. This study identified conditions related to correct and incorrect CRS use to inform programming and education to increase correct use. The results help frame the target population for programming and education as not only novice users but also experienced users, as the study did not find a significant difference in errors by experience.

Crash Avoidance Technology Evaluation Using Real-World Crash Data

This study used data on primarily optional safety content from 1.2 million General Motors (GM) vehicles linked to State police-reported crash data by Vehicle Identification Number to estimate field performance of various new safety technologies. After linkage, there were 35,401 vehicles in our analysis dataset. This data included both an indication (presence/absence) of certain types of safety equipment on each vehicle, as well as a variety of crash descriptors at the crash, vehicle, and driver levels. Available covariates were also used to attempt to control for variables that might influence system-relevant crash involvement for the systems examined, including driver age and gender, speed limit, alcohol/drug presence, fatigue, weather, road surface condition, vehicle type, and vehicle model.

FBI Releases 2019 NIBRS Crime Data

On December 9th, the FBI released detailed data on nearly 7.7 million criminal offenses reported to the National Incident-Based Reporting System (NIBRS) in 2019.

The Uniform Crime Reporting (UCR) Program's latest report, *NIBRS, 2019*, presents data about victims, known offenders, and relationships for offenses reported in 23 categories with 52 offenses. It also presents arrest data for those crimes and ten additional categories for which only arrest data is collected.

Highlights of *NIBRS, 2019*

In 2019, 8,497 law enforcement agencies, whose jurisdictions covered more than 146.5 million U.S. inhabitants, submitted NIBRS data to the UCR Program. These agencies accounted for 51.3% of the 16,551 law enforcement agencies that submitted data to the UCR Program in 2019. The remaining agencies submitted their data to the program via the Summary Reporting System (SRS). NIBRS agencies reported 6,572,870 incidents involving 7,688,645 offenses, 8,116,849 victims, and 6,543,257 known offenders. Also, these agencies reported 3,931,924 arrestees.


FBI Releases 2019 Hate Crime Statistics

The FBI released its latest Hate Crime Statistics report, an annual compilation of bias-motivated incidents throughout the nation that provides information about the offenses, victims, offenders, and locations of hate crimes. The 2019 data, submitted by 15,588 law enforcement agencies, provide information about the offenses, victims, offenders, and locations of hate crimes.

Law enforcement agencies submitted incident reports involving 7,314 criminal incidents and 8,559 related offenses as being motivated by bias toward race, ethnicity, ancestry, religion, sexual orientation, disability, gender, and gender identity. Please note the UCR Program does not estimate offenses for the jurisdictions of agencies that do not submit reports.

Attorney General Grewal Issues Additional Guidance to Prosecutors on Handling Low-Level Marijuana Possession-Related Cases

On November 25th, Attorney General Grewal issued additional guidance to prosecutors concerning the prosecution of low-level marijuana cases, supplementing his August 29, 2018, and November 4, 2020 guidance.

On November 4th, the Attorney General issued guidance to law enforcement emphasizing that they have broad discretion in handling low-level marijuana offenses and encouraging them to exercise that discretion in light of anticipated legislative action that may decriminalize marijuana.

Attorney General Grewal reiterated that more comprehensive guidance, including direction on handling previously adjudicated matters, will follow when the Legislature provides details of the framework for marijuana decriminalization and the legalization of adult-use cannabis.

Pedestrian and Bicycle Safety Program Offers Free Online Technical Assistance and Training

FHWA's Pedestrian and Bicycle Safety Program released two resources in the past couple of years, including free online technical assistance and training.

As mentioned in the fall 2018 edition of the [Pedestrian and Bike Forum Newsletter](#), FHWA published the [Guide for Scalable Risk Assessment Methods for Pedestrians and Bicyclists](#) (and accompanying [Areawide Exposure Tool](#) [Microsoft® Excel download]) that outlines eight sequential steps to develop risk values and describes the scope and nature of each step, including guiding principles.

Practitioners can use these scalable risk assessment methods to evaluate pedestrian and bicyclist risk at different geographic scales. These evaluations can then inform program and project funding decisions. Free technical assistance is still available through the fall, and virtual sessions are provided. The team recently completed a well-received 3-hour training with the State of Arizona with more than 90 attendees.

FHWA released its [Bikeway Selection Guide](#) a year ago. This resource helps transportation practitioners consider trade-offs and make decisions to accelerate the delivery of high-quality bicycle networks. FHWA will continue to offer free technical assistance and workshops on the guide through spring 2021.

Throughout 2020, FHWA will offer this workshop virtually.

Participants will review online training materials before joining an interactive, 3-hour online event to learn more about how to apply the Bikeway Selection Guide to plans and projects.

The first virtual training took place on July 9. In addition to supporting the resources mentioned above, the Office of Safety offers quarterly webinars on topics of interest.

FHWA hosted a two-part webinar series with 2,109 attendees on Enhancing Mobility, Access, and Safety for Pedestrians on April 28 and April 30.

Part 1 provided information on how pedestrians with visual impairments travel and how changes in engineering have influenced their safety and mobility.

Part 2 explored wayfinding for pedestrians who are blind or have low vision and showcased various strategies for aiding navigation along streets and crossing locations. The recorded webinars are available online.

FHWA and the Pedestrian and Bicycle Information Center (PBIC) have developed and recorded a number of webinars over the years. The PBIC archives of the webinars are [available online](#).

FHWA Calls for Comment on 11th Edition of the MUTCD

The Federal Highway Administration (FHWA) on December 11th proposed wide-ranging revisions to the “Manual on Uniform Traffic Control Devices for Streets and Highways” (MUTCD) – the first comprehensive update in more than 10 years to advance traffic operations and safety in states and cities nationwide.

The proposed 11th Edition of the MUTCD will be previewing in the [Federal Register](#) on Monday, December 14th.

The MUTCD is the national standard for traffic signs, signals, and pavement markings that guide us on our nation’s streets and highways. The proposed revisions offer many proven advancements while remaining flexible to accommodate newer technologies and operational strategies.

Among other improvements, the proposed updates reflect state-of-the-art traffic research to help transportation agencies prepare for automated vehicles and other cutting-edge technologies.

Features for vulnerable road users include the rectangular rapid-flashing beacon, expanded traffic signal warrants, and an array of roadway treatments for cyclists – many of which have been proven through the experimentation process defined in the MUTCD.

The update is incorporating the results of over 150 Official Experiments of novel traffic control devices and applications, Official Interpretations, Interim Approvals, and other research conducted both independently and by the Traffic Control Device Consortium Pooled Fund.

In brief, there are more than 600 proposed changes, comprehensively described in the Notice.

A mark-up document of the proposed MUTCD text and separate documents containing the proposed Figures and Tables will be available when the public docket officially opens for comment on Monday, December 14th.

As part of the process of updating the MUTCD, FHWA will gather feedback from state and local traffic engineers and other traffic control device stakeholders, and the public in general, from the docket that is now open for public comment.

The Office of Inspector General works within the Department of Transportation to promote effectiveness and head off, or stop, waste, fraud and abuse in departmental programs. We do this through audits and investigations. OIG also consults with the Congress about programs in progress and proposed new laws and regulations.

Virginia Woman Charged for Aiming Laser Pointer at Aircraft

On November 2, 2020, the USAO for the Eastern District of Virginia filed an information charging Amanda Robinson with aiming the beam of a laser pointer at an aircraft and the flight path of the same aircraft.

On June 4, 2020, Robinson attended a demonstration in Richmond, Virginia, and used a laser pointer to illuminate a law enforcement aircraft flying overhead. Robinson struck the aircraft with the laser multiple times, causing the pilots to experience temporary blindness.

DOT-OIG conducts this investigation with the Federal Bureau of Investigation, the Richmond Police Department, and the Henrico County Sheriff's Office.

New Jersey Moving Company Owner and Employee Plead Guilty in Connection with Defrauding Customers

On November 19, 2020, in the U.S. District Court for the District of New Jersey, Lola Larios pleaded guilty to one count of conspiracy to commit wire fraud. On November 20, Lior Atiyas pleaded guilty to one count of conspiracy to commit wire fraud and one count of conspiracy to commit health care fraud.

According to court documents and statements made in Court, Atiyas devised a scheme to enrich himself and his moving company. He used several names to conceal his company's true identity, including Premier Relocations LLC, Metro Van Lines, Inc., and others. Between January 2016 and January 2019, Atiyas and Larios, Atiyas' employee, extorted customers by quoting them "low ball" price estimates for moving household goods. Once the goods were loaded on trucks, Atiyas and Larios directed employees to raise moving prices to totals that were often two or three times more than initial quotes. Customers were refused their goods until they paid higher prices.

Atiyas also admitted to participating in a scheme to defraud Medicaid by generating false paystubs and employment documents to obtain Medicaid benefits for an uncharged conspirator.

Automakers and suppliers worldwide have agreed to a system that makes it possible to charge electric vehicles and plug-in hybrids without ever actually plugging them into a wall outlet.

Miscellaneous Traffic Safety Points of Interest



What are those big orange balls on power lines?

This might not be “ground traffic safety” related, but.... Have you ever seen those big yellow, orange, white or red balls hanging from power lines and wondered what they’re used for?

They’re called visibility marker balls or marker balls. You’ll often find them near major freeway crossings, around airports, by mountain passes, and in the deep valley areas. They weigh about 17 pounds each.

The marker balls are placed on power lines to make the conductor crossings visible to aircraft. Helicopters and small aircraft often fly low near freeways and usually fly low while approaching an airport. Adding to that air medical helicopters will land on the highways or close by to medivac crash victims to a trauma center.

When flying, the conductors and skyline become almost invisible against the terrain — especially the skyline wires.

Many of the marker balls are required by the Federal Aviation Administration, like the ones near airports.

Over the years, other locations have also been identified that are particularly hard to see.

Next time you’re driving past a marker ball, remember that they’re used for the flying aircraft’s safety and to protect the electrical infrastructure.

Governor Murphy Signs Legislation to Bring Changes to the Use of Body Worn Cameras by New Jersey Law Enforcement

S1163 Requires Every Patrol Officer to Wear a Body Camera and A4312 Regulates the Use of Body Worn Cameras by Law Enforcement Officers

Executive Order Establishes Working Group to Further Facilitate Implementation of Body Worn Cameras

Acting on a commitment to promote further transparency in policing and build trust between police officers and the communities they serve, on November 24th, Governor Murphy signed two pieces of legislation ([S1163](#) and [A4312](#)), which concern the use of body-worn cameras by members of law enforcement. The Governor also signed [Executive Order No. 201](#), which establishes a 14-member Interagency Working Group to provide recommendations to the Governor's Office and Attorney General regarding technology solutions to facilitate the statewide implementation of body-worn cameras in law enforcement agencies. The Working Group will identify barriers to adopting body-worn cameras and recommend technology solutions to facilitate their implementation.

Governor Murphy Signs “Daniel’s Law”

On November 20th Governor Murphy signed legislation ([A1649](#)), which protects the home addresses and telephone numbers of judges, prosecutors, and law enforcement officers from public disclosure. The bill, known as “Daniel’s Law,” is named in honor of Daniel Anderl, the late son of U.S. District Court Judge Esther Salas. Daniel fell victim to a senseless act of gun violence committed by an individual who had compiled a dossier of personal information about Judge Salas, including the judge’s home address.

New Law – AG to Establish Records on Certain Data

[A-1076](#) was signed into law on November 8th it requires the AG to collect, record, analyze, and report specific prosecutorial and criminal justice data.

New Law - Junior Firefighters' Auxiliary Members

[S-238/A-1106](#) was signed into law by the Governor on November 20th; it revises law governing training and duties of Junior Firefighters' Auxiliary members.

NJ Legislative Bills Introduced or with Recent Action Related to Police and Traffic

[Senate Bill S1602](#) Requires driver's license examination to include questions on distracted driving; creates violation for motorists to talk or text on hand-held wireless devices while vehicle is temporarily stopped.

12/10/2020 Reported from Senate Committee with Amendments, 2nd Reading

12/10/2020 Referred to Senate Budget and Appropriations Committee

[Senate Bill S3241](#) Requires the chief law enforcement officer of municipal Police departments to hold two community roundtables on Police relations each year.

12/10/2020 Introduced in the Senate, Referred to Senate Law and Public Safety Committee

[Assembly Bill A4960](#) Prohibits law enforcement officers from administering anesthetic or sedative during arrest or traffic stop.

11/12/2020 Introduced, Referred to Assembly Law and Public Safety Committee

[Assembly Bill A4656](#) Authorizes the creation of local civilian review boards to review police operations and conduct; appropriates \$600,000. Identical Bill Number S2963.

[Assembly Bill 4392](#) Requires law enforcement officers and recruits to undergo self-defense training; appropriates \$250,000 to Police Training Commission.

Supreme Court of The United States DeRay Mckesson v John Doe No.19–1108. Decided November 2, 2020

Petitioner DeRay Mckesson organized a demonstration in Baton Rouge, Louisiana, to protest a shooting by a local police officer. The protesters, allegedly at Mckesson's direction, occupied the highway in front of the police headquarters. As officers began making arrests to clear the highway, an unknown individual threw a "piece of concrete or a similar rock-like object," striking respondent Officer Doe in the face. Officer Doe suffered devastating injuries in the line of duty, including loss of teeth and brain trauma.

Though the culprit remains unidentified, Officer Doe sought to recover damages from Mckesson on the theory that he negligently staged the protest in a manner that caused the assault.

The District Court dismissed the negligence claim as barred by the First Amendment.

A divided panel of the Court of Appeals for the Fifth Circuit reversed.

US Supreme Court vacate the judgment of the United States Court of Appeals for the Fifth Circuit, and remand the case to the state court for further proceedings.

FBI Legal Digest

U.S. Supreme Court Cases, 2019–2020 Term

Of the 63 cases heard by the U.S. Supreme Court during the 2019–2020 term, there were several criminal and civil law cases that could affect the investigative and employment interests of the law enforcement community. The cases dealt with investigative detention, the insanity defense, cross-border shootings, international child abduction, and employment discrimination. For the 2020-2021 term, the Court will hear cases on the issues of “chokeholds” and a debate on the definition of “seizure” under the Fourth Amendment.

This article offers brief synopses of the cases and their holdings. Law enforcement personnel from state, municipal, and county agencies should be aware that their local laws, regulations, and policies may provide greater protections for citizens in their jurisdictions or place additional limitations on law enforcement actions than described in the following cases, which were decided on the U.S. and not state constitutions.

Your car's emergency flashers could get a major upgrade soon - and here's why

Detroit Free Press

One of the oldest and possibly least effective auto safety features may be getting a 21st-century upgrade.

A new system to improve the visibility of vehicles stranded by the side of the road could help reduce thousands of collisions and hundreds of deaths a year. The system could be available nearly immediately if supplier Emergency Safety Solutions (ESS) gets regulatory approval.

Every year from 2016 through 2018, nearly 72,000 people in the U.S. were involved in a crash that included a disabled vehicle, according to research ESS commissioned.

The new system is designed to change the flash rate of the four-way hazard lights on cars. Current emergency flashers blink at a rate of about 1.5 flashes per second. About five flashes a second is best, according to research ESS used to develop its system, which it calls the Hazard Enhanced Lighting Package (HELP).

The HELP system can easily be installed in cars being manufactured and to newer cars already on the road with a simple software upgrade. The flashers are also automatically activated if the vehicle's airbags deploy.

NHTSA is evaluating the system. There's no announced schedule for a decision,


The U.S. federal government declared a national public health emergency in October 2017, to address the national opioid crisis.
