Awards will be handed out at the conclusion of the trial. Ribbons will be awarded for qualifying score, Best of Breed, and High in Class. Rosettes will be awarded for new titles.

### Venue:

Exhibitors will be crating in their vehicles. **4 Points NASDA Club** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog. There is shade at the site, but you might want to bring fans and shade cloths.

- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$25 fee for any returned check or payment.

- Exhibitors are responsible for complete, accurate, and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must always be on leash, except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Bitches in season will run at the end of the class entered and must wear protective gear.
- Please be courteous and pick up after your dog.
