

Reach Out Lodi's Automatic Deduction Plan Using Electronic Funds Transfer (EFT)

This authorization allows Reach Out Lodi to debit your account and, if necessary, credit entries or adjustments for any debits made in error to your account. This authority remains in full force and effect until Reach Out Lodi has received written notification from you, the donor, of its termination and the bank has had reasonable time to act on it. All information provided will remain confidential.

A record of each exchange will be included in your bank statement. This record will serve as your receipt. Your ROL gift will also be recorded on your year-end contribution statement.

It is understood and agreed that the bank shall have no responsibility for the correctness of any charge herein contemplated and that any dispute involving the amount hereof shall be handled by you directly with Reach Out Lodi.

Introducing the Reach Out Lodi, Inc. (ROL) Electronic Funds Transfer (EFT) Giving Plan

The ROL/EFT makes it easy for you to support Reach Out Lodi. Your monthly gifts are automatically deducted from your designated bank account and sent directly to Reach Out Lodi.

By using the ROL/EFT Giving Plan:

- You provide ROL with steady giving that supports your community center and community store.
- There is no more check writing since your gift will be automatically transferred.
- Your gifts are tax deductible. A record of each deduction will be reported on your monthly bank statement.
- You may choose to change your gift at any time.

It's Simple! Just Follow these EFT Giving Plan Steps

1. Complete the ROL/EFT Giving Plan form.
2. Indicate the amount you want deducted each month from your checking or savings account.
3. Return the ROL/EFT Giving Plan form along with a voided check or a deposit slip from your savings account.

Note: The bank routing number must be on the deposit slip. This will give us the necessary information to begin automatic deductions.

5. You will receive a letter confirming that you are a member of the ROL/EFT Giving Plan.
6. Your first automatic deduction will occur on the effective month you provided.
7. To discontinue the ROL/EFT Giving Plan, send an email at least one month prior to requested date to reachoutlodi@charter.net and indicate your final giving month.
