AN ORDINANCE OF THE CITY OF CISCO, TEXAS, AMENDING CHAPTER 13 "MOTOR VEHICLES AND TRAFFIC" OF THE CITY'S CODE OF ORDINANCES, SPECIFICALLY ADDING SECTION 13-58 "DESIGNATION OF PARKING SPACES FOR EXCLUSIVE USE OF DISABLED PERSONS UPON PUBLIC PROPERTY" TO INCLUDE "ATTACHMENT A" ILLUSTRATING PARKING DESIGNATIONS FOR USE BY DISABLED PERSONS ON PUBLIC PROPERTY IN THE DOWNTOWN BUSINESS DISTRICT; AND ESTABLISHING AN EFFECTIVE DATE OF ENFORCEMENT. Mr. Diers informed the Council that the Cisco Economic Development has gotten approval from the other Eastland County taxing entities to agree to convey the deed to the old Westfall property for future development. The EDC will apply for a grant through the EPA to abate the nuisance property which has stood vacant for approximately 40 years.
