New USTA Rules

Competitive Age

The date for determining an athlete's age for competition in USTA events has changed from December 31 of each calendar year to August 31 of each competition season. Athletes will compete at the age they are on August 31 of each competition season. The competition season runs from September 1 to August 31.

Therefore, the 2019-2020 competition season runs from September 1 2019 to August 31, 2020. During the 2019-2020 season, athletes will compete in USTA events as they age they will be on August 31, 2020.

Twirl Team

Primary level is only offered in the Novice and A Level

Juvenile level is only offered in the Novice, A and AA Level

Junior and Senior levels are offered in Novice-Elite Level

Entertainment & Parade Corps

Effective immediately, only one level will be offered for Parade Corps, Entertainment Corps (formerly Show Corps) and Show Teams. We will no longer offer A Class and Open levels in those events. There are no longer age divisions for Parade and Entertainment Corps. Show Teams still have the following age divisions: Primary, Juvenile, Junior and Senior.

Entering More Than One Level

Effective September 1, 2019: Athletes may only enter 'one level up' from their current level in a particular event. For example, a beginner athlete may enter Intermediate but not Advanced, since that would be 'two levels up.'

Entry forms will automatically be corrected if the athlete is entered in the following events incorrectly: All Foundation Events, Solo, Duet, Two Baton, Three Baton, Artistic Twirl, Artistic Twirl Pair and/or Strut.
