Drinking Water Sample – Paul received notification from the CCHD that the latest water sample did not meet all of the sampling requirements. Correspondence from CCHD states that the nitrate sample did not meet thermal preservation standards. A monitoring violation must be posted and the sample must be recollected. The water is safe to drink and no other actions must be taken at this time.

Recreational Marijuana – Hillary shared legal guidance drafted by MTA in regards to municipalities prohibiting medical or recreational marijuana facilities. At this time there are no legal advantages or disadvantages to adopting such ordinance and all ordinances are subject to referendum due to the passing vote for recreational marijuana use at the state level. LARA has until December 6, 2019 to establish guidelines and no recreational marijuana establishment will be lawfully licensed until that time.

Budget Review – Expenses YTD were reviewed and compared to budget cost centers. No budget adjustments needed at this time.
