--Streetlight Request for Edinburg Highlands - cost estimate

Tom presented copies of the email conversation between himself and Ray Martinez, Area Manager at First Energy. Ray turned it over to engineering and it came back that they have to add poles because the current ones are not suitable. The pole & light (100 watt high pressure sodium) on St. Andrews way would be: \$2,557.05. The pole cost would not be charged at Carlisle so it's \$1,940.30. The cost is approximately \$4.70/month to operate each one of them.

Brent Redeker: What would be the next step if there's interest in getting those added?

**Thomas Repcik:** Do you fellas want to help pay for it?

**Diane Austin:** Well, here's where I'm standing: we don't have lights at every road and there are intersections that are more traveled than yours. If your association wants to pay to have the poles put in, then I would be in agreement that the Township would pay the monthly fee. But we don't have the money; we're in a very tight budget; we do not have almost \$4,500 to put these poles in. So if the association wants to pay to put them in, my feeling is, I would agree to pay the electric.

**Brent Redeker:** It's a dangerous enough intersection that ODOT put a turn lane in there and widened it. **Diane Austin:** Correct but we've never had any accidents there; you would have to pay to have a study and I have other intersections where there have actually been accidents; we do not have lights at every intersection right now; we don't. I drove the Township; I had Chris drive the Township; I cannot justify paying this for those two when there's how many homes up there when some of these other roads that don't have lights that have more homes on them and are more highly traveled so then we would have to put them-to be fair, because it's tax payers' money, we would have to put them everywhere. The last poles we put in we split with Palmyra Township and then with this, if the Association wants to pay for them, we'll maintain the electric; that's what we do for the other areas. That's my feeling; I don't know, it would have to come to

**Thomas Repcik:** And the other development up on [State Route] 18 does not have a light to the entranceway coming in.

**Brent Redeker:** There's about a half dozen homes in there. This is the only intersection on a state highway that doesn't.

**Thomas Repcik:** Well, think about it. **Brent Redeker:** Thank you; I appreciate it.

**Diane Austin:** You've got that. You can call them too if you want but if they want to do that and pay the poles then, my feeling is, we would pay the operation of it.

Chris Diehl: What did you say? That's the only intersection that doesn't have a—

Brent Redeker: On the state highway it's a major intersection.

**Chris Diehl:** I don't think there's one at Knapp Road I mean Cableline, where Cableline comes out—I don't think there's one there either.

Brent Redeker: Cableline onto [State Route] 14?

Chris Diehl: Yes.

Brent Redeker: Ok, I'll double-check it.
