Making Apprenticeships More Attractive: What is being done to alleviate the chronic shortage of licensed Truck & Coach mechanics? At the request of our president Dan Cushing, Al Thompson reviewed this critical matter. Something-or things-has to be done-by the truck industry, by government, by colleges, by the media, by all of us- to make apprenticeships more attractive. We have to find some ways and means of enhancing the allure of the trade-which could include improving remuneration-so that the trade moves nearer the top in post secondary career path aspirations. The trades should be promoted from early grade school; employers could introduce summer jobs for students.
