

## **Animal Control Bylaw**

Animal Control Bylaw No.143 will be strictly enforced. In accordance with this bylaw, dogs must be on a leash at all times, must be picked up after and must not be allowed to excessively howl and bark. A reminder that all dogs within the boundaries of the Summer Village must be controlled and on a leash at all times, including in the park and reserve areas. There is currently no off-leash area for dogs within the Summer Village.

A reminder to please take responsibility for your animal's waste as we have many residents who enjoy walking throughout the Summer Village.

## Fires can happen - ARE YOU COVERED??



<u>Did you know</u>: the average cost of fire suppression by the fire department can be **approximately ten to twenty thousand dollars for a structure fire** and is payable by the property owner to the fire suppression provider?

<u>Did you know</u>: if a fire department responds to any other sort of fire (grass, lawnmower, burn barrel, home alarm etc.), that there will also be a cost?

## Will your insurance cover these costs? What does your policy say?

Be sure you take a look at your home insurance policy or talk to your insurance agent. Some insurance companies do not insure for fire equipment in the case of a fire, and some include up to two thousand dollars with an option for you to increase that coverage for a very reasonable additional cost. Ask your provider if your policy covers grassland, fire suppression and call-out costs.

#### FIRE PITS

#### Within the corporate limits of the Summer Village of South View, fire pits must:

- a) Be at least 3.0 m. (10.0 ft.) from buildings, property lines and anything else that could catch fire.
- b) Be less than 1.0 m. (3.0 ft.) wide.
- c) Be less than 0.6 m. (2.0 ft.) high.
- d) Have enclosed sides made from bricks, concrete or heavy-gauge metal.
- e) Have a mesh screen on top to stop sparks (spark-arrestor) with openings smaller than 1.25 cm. (0.5 in.).

## Encroachments onto Road Right of Ways & Use of Municipal Reserves

It is the responsibility of every property owner to understand and know where their property lines are. If you are unsure of your property boundaries, it is your responsibility to have your lot surveyed. If there happens to be items encroaching on Summer Village property they will need to be moved to within your property.

To facilitate park maintenance in the summer months and to ensure safety of all users during the winter months, boat hoists and piers etc. are required to be removed from all park reserve areas to private property. Failure to do so may result in the Summer Village having the items removed at the owner's expense.

#### DO YOU THINK YOU'VE SPOTTED A QUAGGA OR ZEBRA MUSSEL?

Report it to Alberta's invasive species hotline at 1 855 336 BOAT (2628).

Quagga and zebra mussels move from lake to lake by attaching themselves to boats and other recreational equipment. Quagga mussels are found in various parts of North America, such as in the Colorado River system in the US, a popular destination for Alberta snowbirds. Zebra mussels were discovered in Lake Winnipeg, Manitoba in October 2013.

Here's how to keep Alberta waters free of aquatic invasive species, and keep your boat and recreational equipment in ship-shape.

#### **Boaters**

## Clean, Drain, Dry Your Boat!

#### Clean

- Clean and inspect watercraft, trailer and gear
- Remove all plants, animals, and mud at the access area or dock
- At home, soak your gear in a bleach solution for at least one minute
- Rinse, scrub or pressure wash your boat away from storm drains, ditches or waterways

#### Drain

- On land, before leaving the waterbody, drain all water from:
- Bait buckets
- Ballasts
- Bilges
- Coolers
- Internal compartments
- Livewells, etc

#### Dry

- Dry the watercraft and gear completely between trips and allow the wet areas of your boat to air dry
- Leave compartments open and sponge out standing water.

## Off-Highway vehicle users

Remove any vegetation or clumps of mud or debris from the vehicle and thoroughly clean the underside of vehicles, tires and parts before moving to another area.

#### What's the government of Alberta doing about aquatic invasive species?

Environment and Parks is working closely with a variety of stakeholders. Together, we have developed a program that includes these components:

- Monitoring
- Rapid response planning
- Education and outreach
- Watercraft inspections
- Policy



### Property Taxes - Due June 30, 2017

The overall average property tax bill increased from last year approximately 3.0%. The Summer Village collects taxes annually to meet the projected costs of providing services to the community. These revenues are received through grants, a municipal services tax, and the municipal portion of property taxes. Other amounts collected on your annual tax bill are collected on behalf of the Lac Ste. Anne Seniors Foundation and the Alberta School Foundation Fund.

#### Assessment

Property assessment services are contracted to Dan Kanuka and he can be contacted at 780-939-3310 with any questions you may have regarding the assessed value of your property.

### What is a Property Assessment?

Each year, the Assessors will inspect certain properties within the Municipality. The property assessment is the estimated market value of your property which is used to calculate property taxes. Assessors do not create your property value, nor does Council. The market determines the value of your property, and that value is the basis for the assessment and is then used to calculate your property taxes.

## What If I Disagree with My Assessment?

Remember, you can only make a complaint against your assessment value, not your tax dollars or rates and you must have grounds for your complaint . New legislation allows you 60 days from the date of your assessment notice to make an assessment complaint.

## The assessment complaint deadline for the Summer Village of South View is July 11th, 2017.

There is a fee of \$50.00 that must accompany a completed assessment complaint form which is available on the website <a href="www.summervillageofsouthview.com">www.summervillageofsouthview.com</a> or by contacting the office at 587-873-5765. Prior to completing the assessment complaint form, please contact the assessor to first discuss the matter of your assessment (not your tax dollars) – Dan Kanuka – 780-939-3310.
