

However their years of service, contributions to the organization, dedication to the community, warrant their inclusion as the impact that their loss will have on the Club will be felt for a long time to come. Therefore it is not only fit and proper but right and necessary to include these stories within this review.



TOLLESBORO LIONS CLUB LOSES LONG-TERM MEMBER

The Tollesboro Lions Club lost a long-time member Sunday, Nov. 27th, 2022 with the passing of Larry Tucker.

Larry joined the Tollesboro Lions Club Oct. 1, 1967, an active member of the organization for 55 years. At the time of his passing, Larry was the Club's longest serving active member (since the Tollesboro Lions Club's chartering in 1954, only 4 members have served for 50+ years, with Larry's tenure in the organization only surpassed by two members: Charter member Mack Wright, who at the time of his passing in 2015, had been a member for 61 years; and Don McCann, who at the time of his passing in 2019, had been a member for 60 years. Charter member Elmo Gillespie served the Tollesboro Lions Club for 50 years).

While a member of the Tollesboro Lions Club, Larry served at least two terms (there are a number of years where the record as to whom served as President is incomplete and it is entirely possible that he served an additional term/terms during this period) as President of the Tollesboro Lions Club (1969-1970 and 1976-1977). Larry was also named the Tollesboro Lions Club Outstanding Citizen of the Year in 1990.

Larry was a retired educator with the Lewis County School system, teaching English and serving as a guidance counselor and basketball coach. He also was well-known locally as a minister serving the Concord Christian Church for 44 years; served as the last Mayor of the City of Tollesboro; was a 50+ year member of the Tollesboro Volunteer Fire Department; and a long-time member/leader of the Woodmen Life Chapter 890.

Larry was a respected and vital member of the Tollesboro Lions Club, present at almost every meeting, a fixture at the gate collecting gate money throughout the fair each year, and a trusted advisor to the Club. He will be missed...



McGinnis officiating. Burial will follow in the Ebenezer Cemetery in Lewis County.



TOLLESBORO LIONS CLUB FIRST MEETING OF 2023

The Tollesboro Lions Club met Monday, January 9th, for their first meeting of 2023 with 16 members and 2 guests present. President Craig Stanfield opened the meeting with a moment of silence in deference to the recent loss of members Larry Tucker (passed away Nov. 27th) and Darrell Dixon (passed away Dec. 9th) and the father of member Shane Wallingford, Johnny Wallingford (passed away Dec. 23rd) who was a long-time supporter and who showed horses at the Tollesboro Lions Club many, many years. Following the moment of silence, Craig welcomed back members Ritchie Cunningham, Clinton Applegate and Denny Hornback, all of whom had experienced health issues recently. Craig then led the group in Prayer, followed by the Pledge of Allegiance led by member Charles Kendall, after which the group broke for dinner.

Following dinner, Lion Craig read Thank You cards that had been mailed to the Club from the families of Larry Tucker and Darrell Dixon. The minutes from the November meeting and the December Christmas Party were then read by Secretary Phil Cropper; the minutes were approved as read. Treasurer Steve Pedersen mentioned some recent financial activity and made a report about continued statewide contributions to Eastern Kentucky flood victims. President Craig Stanfield mentioned that the Club had provided memorial throws for funeral services in memory of Larry Tucker, Darrell Dixon, and Johnny Wallingford. He then announced donations to the Club from the Eyecare Group in memory of Larry Tucker, from Tony and Angela Sweeney in memory of Darrel Dixon, and \$790 in donations for continued Eastern Kentucky flood victims that he was able to raise from the Mason County Men's Club and the Ringgold Lodge Independent Order of Odd Fellows (individuals who contributed to this included Barbara Boone and Larry Poe, Bill and Dorinda Leet, David and Carolyn Collins, Mike and Vieda Stitt, Tony and Angela Sweeney, Gary and Jo Ann Bowers, and Craig and Beverly Stanfield). Craig also reported that he had submitted the events/projects of the Club from July 1, 2022 through the end of 2022 (first half fiscal year) to Lions Club International for consideration for the newly established Lions International Marketing Award. He also informed Fair Chairman Lee Thomas that the Bluegrass Mule and Pony Pullers Association had reached out for inclusion in this year's fair.


Next, under New Business, Phillip Bussell of Family Tradition Motorsports was introduced to the Club as he is considered for hosting this year's Demolition Derby event during the Fair. He is already conducting the event for Ewing, Germantown, and Carlisle. After discussions, questions and answers, the Club dismissed Mr. Bussell for private consultations. Based upon a recommendation by Fair Chairman Lee Thomas and member T. J. Palmer, and after consideration by the membership, a motion was made by Lion Clinton Applegate, seconded by Lion Charlie Kendall to approve Mr. Bussell's proposal for this year's fair Demolition Derby Event. The motion passed unanimously.

Lion Steve Pedersen then suggested that a posthumous Melvin Jones Fellowship Award be ordered for recently departed member Darrell Dixon (the award had been ordered for Lion Larry Tucker back in September, but has yet to arrive for presentation), with the plan to present to Darrell's wife and family at a future meeting, to coincide with the presentation

of the award to Larry Tucker's family. Seconded by Lion Charlie Kendall. These two members together have been members for a combined 100+ years. The motion passed unanimously.

Next, it was suggested that the Tollesboro Lions Club offer the use of their grounds for an event for 13 year old Mackenzie Forman, suffering from leukemia. A mud-sling event was hosted on her behalf last year, and due to some complications, another fund-raiser would be necessary. The Club approved the event under the same conditions as last year, said event to be held in March or April, with a firm date to be set soon.

Being no further business, the meeting adjourned.



TOLLESBORO LIONS CLUB HOSTS FEBRUARY MEETING

The Tollesboro Lions Club met Monday, February 13, 2023 for their regularly scheduled meeting. With 17 members in attendance, President Craig Stanfield welcomed the group and asked Lion Steve Pedersen to lead the group in prayer, followed by Lion Charles Kendall leading the group in the Pledge of Allegiance, after which the group broke to enjoy dinner.

After dinner, the business meeting began with Secretary Phil Cropper reading the minutes from the last meeting, followed by Treasurer Steve Pedersen providing the financial report. President Craig Stanfield then read to the group Thank You cards from the Neon Lions Club for providing food, clothing, and other products to those communities in Eastern Kentucky that had been devastated by flooding, as well as a Thank You card from the Family of Johnny Wallingford. While going over communications, the Club was asked to offer support to the Kentucky Lions Eye Foundation. Lion Steve Pedersen suggested that we donate \$1,000 to the KLEF to purchase Finis Davis Fellowships to posthumously present to Brenda Tucker and Loretta Hord in memory of Larry Tucker and Darrel Dixon, two recently departed Lions Club members, who together had served the Club for 100 years (the Club had approved purchase of Melvin Jones Fellowships for each of these members the last meeting). This was seconded and approved unanimously.

Lion Jim Meadows reported that the 3-D Archery Tournament at the Tollesboro Lions Club Fair would be Monday, July 17th, with a request to conduct an additional 3-D Archery Tournament at the Fairgrounds August 26th. This event was approved.

Lion Denny Hornback made a motion to paint the brick portions of the exterior of the Horse Show Ring (rather than covering it up each year, a savings of time and energy). This motion was seconded and passed unanimously.

Lion Craig Stanfield mentioned that Little League had asked to use the ballfield again this year, a motion made and seconded and passed unanimously. Lion Shane Wallingford mentioned that the ballfield needed a brick dust treatment and offered to pay half the cost if the Club would pay half. This was approved by the Club.

Next, Craig reported that he had been approached about the possibility of conducting a Community Easter Egg Hunt on the fairgrounds, with a proposed date of April 1st. Tabby Tully and Carol Cunningham, wives of members of the Club, had offered to conduct the event, with Kyra Bane, Vanessa May and Becky Walker also offering assistance. This event was approved unanimously.

Carol Cunningham asked the the Club approve the use of the grounds for the David Iery Foundation Log Jam Bluegrass Festival. This will be the fourth annual event which in the past had been conducted on a hill off Quicks Run Road. They have been having crowds of 250 to 500 persons attend, but thought that by locating the event at the Fairgrounds, that a larger crowd could be accommodated. They have their own event insurance, and the Club would not have to do anything. A motion was made and approved for this use of the fairgrounds.

Lion Clinton Applegate brought up the need for the purchase and installation of a large fan for the Showring of the Livestock Barn. After discussion, it was decided that, although in favor of the purchase, it would be necessary to look into the cost of the installation; so this consideration was tabled for the next meeting with members offering to look into cost estimates.

Next, Lion Steve Pedersen informed the group that he had just returned from Chicago where he had attended District Governor Training.

Next, he informed the group that it was time to replace the coolers and a deep freeze in the Concession Stand, and that these units would have to be replaced before the fair. He indicated that he had located a used two-door cooler and a motion was made to purchase the used cooler and a new large deep freezer for the Concession stand; motion seconded and approved.

Next, Lion Steve Pedersen reported that he (as District Vice President) and Chuck Carlson had delivered food to Eastern Kentucky to support flood victims. They would be making an additional trip this week to provide non-perishable food items to Whitesburg and Jenkins. He also indicated that the state Lions Clubs, both districts 43-K and 43-Y were making donations of non-perishable food items for provision to Eastern Kentucky to offer further assistance to flood victims there. It was brought up that the public at large would probably contribute to such a food-drive if we could advertise and promote such, and provide for a place for canned and non-perishable items to be dropped off, to which Lion Jim Meadows offered the use of Rip's Farm Supply as a drop-off point. Lion Craig offered to write up an article to post in the newspaper, Carol Cunningham offered to prepare a handbill for Lion Lee Thomas to post on the Lion's Club website.

Next, Lion Lee Thomas brought it to the Club's attention that a Giving Box had been installed at the Tollesboro Volunteer Fire Department by a local church organization. He indicated that he had seen many persons taking advantage of this service in the community, and that there existed a need within the community to support this use for our local persons in need. He further expanded as to what a blessing the Food Pantry has been to local needy families (the food pantry is operated at the Tollesboro High School, owned by Lion Craig Stanfield, with the use of the building donated to the Lend-A-Helping-Hand Food Pantry).

Lion Lee (who organizes the Club's Facebook page) then mentioned that the Tollesboro Elementary School would be offering lunch from the Fairgrounds tomorrow, and that they would be doing this once a month through May as a fund-raiser for the Tollesboro PTO. He then mentioned that he (as Fair Chairman) had traveled to Louisville to investigate additional events to add to the fair. This brought up considerable discussions on how to best utilize the fairgrounds to maximize the events that the group could host.

Following these discussions, President Stanfield invited new members Shane Wallingford and Zach Tully to approach the podium and he presented each with their new member packets and member certificates. Zach was sponsored by Craig Stanfield who received a sponsor pin; Shane was hosted by Steve Pedersen who also received a sponsor pin.

As no other business was brought before the board, the meeting adjourned.


TOLLESBORO LIONS CLUB COLLECTING FOOD DONATIONS FOR EASTERN KENTUCKY FLOOD-VICTIMS

TOLLESBORO LIONS CLUB LOSES ANOTHER LONG-TERM MEMBER

With great sadness, the Tollesboro Lions Club must now deal with the loss of another long-time member. CLINTON APPLEGATE passed away March 2, 2023, after having been diagnosed last year with ALS (Lou Gehrig's Disease). Clinton's passing is just months behind the recent passing of two other long-term members of the Tollesboro Lions Club, Larry Tucker and Darrell Dixon, who passed in late November and early December, 2022, respectively.

Clinton was a Tollesboro native, a Tollesboro High School graduate, and a Tollesboro resident. Clinton joined the Tollesboro Lions Club in 1990 and was an active member, even after his diagnosis and being present (and bringing up an item of business!) at the most recent meeting of the Tollesboro Lions Club, conducted on Valentine's Day, February 14th. He was also the Club's First Vice President and Membership Chairperson at the time of his passing.

During his nearly 33 years of service to the Tollesboro Lions Club, he has been the face of the Tollesboro Lions Club Tug Tractor Pulls (both during the Annual Fair and those individual events conducted at various times throughout the past 32 plus years), as well as the most visible member at the Livestock Shows each year at the Fair. As the Tollesboro Lions Club Fair does not offer a sale in addition to their livestock show, he was also active in supporting youth as a part of the Lewis County Livestock Boosters, present each year at the Germantown Fair at the Annual Show & Sale, spending monies from local groups and businesses so as to insure that Lewis County youth showing livestock received premium sales prices for their livestock.

As a Club Member, he has served 5 consecutive terms as Club President, has served several terms as the Fair Chairman and Co-Chairman, was the 2022 TOLLESBORO LIONS CLUB FAIR PARADE GRAND MARSHALL. On a higher level, Clinton is the current Zone Chairman, serving his 3rd term in that capacity.

On Sunday, July 17th, 2022, following the Tollesboro Lions Club Parade, the Tollesboro Lions Club hosted a Community Rally for Clinton Applegate at the Tollesboro Lions Club. Put together under short notice after determining his diagnosis, but to take place as part of the Annual Fair, the Rally consisted of dinner and ice cream followed by a live auction. Without actively seeking donations from businesses, over 150 items were donated to the cause from individuals and businesses, showing Clinton how much he is loved and respected by the community, which resulted in the highest grossing benefit auction ever conducted on the grounds of the Tollesboro Lions Club (far exceeding by more than double that of any other benefit so conducted)!

Clinton was honored for his service to the Tollesboro Lions Club by the Club presenting him with the Melvin Jones Fellowship (an award named after the Founder of Lions Club International and the highest recognition offered by Lions Club International) and with the Finis Davis Fellowship (an award named after and to honor Kentucky's only International Lions Club President who served in 1960-1961, said honor the highest recognition offered by the Kentucky Lions Foundation). Clinton was also recently honored by the Buffalo Trace Area Development District (BTADD) as the most recent recipient of the BTADD/Lewis County Community Leadership Award.

Clinton's dedication to the Tollesboro Lions Club has been significant. He will always remain in our Hearts, our Thoughts, and our Prayers, and his passing leaves a heavy burden on the organization that will be felt. He will be missed.

He grew up in the Pine Valley community of Lewis County and graduated from Tollesboro High School. Clinton was a dairy, beef, and tobacco farmer, and fence builder. Visitation will after 10:00 a.m. Monday at Tollesboro Christian Church, 3684 West KY 10 at Tollesboro.





TOLLESBORO LIONS CLUB HAS MARCH MEETING

The Tollesboro Lions Club met Monday, March 13, 2023 at the Tollesboro Lions Club Clubhouse at the Tollesboro Lions Club Fairgrounds for their regular monthly meeting. Seventeen members were present. President Craig Stanfield called the meeting to order, with Lion Steve Pedersen leading the group in prayer and Lion Charles Kendall leading the Pledge of Allegiance. The group then broke for a wonderful meal prepared by Skeeter and Sonia Shaw.



TOLLESBORO LIONS CLUB TO GIVE AWAY TREES FOR ARBOR DAY

The Tollesboro Lions Club will give away trees to the public in recognition of Arbor Day. Arbor Day in Kentucky is officially April 7th, while nationally it is April 28th (this is to coincide with best dates to transplant trees by season/zone, which for Kentucky is April and May. However, this does not take into consideration "moon sign" variables to determine best tree planting dates by the phase of the moon: The New and First Quarter Moon Phases are generally considered the best moon phases in which to transplant; thus the latter part of the month of April is considered ideal if you want to rely on the Moon Phase Calendar for planting).

To obtain the trees, the Tollesboro Lions Club President Craig Stanfield reached out to Michael Carter, Forest Ranger, and Suzy Knott, Forester, both of the KY Division of Forestry. We received a much better selection of tree varieties this year, filling requests made by members of the public last year and since, with the Division of Forestry providing us with Burr Oak, Black Walnut, Chinese Chestnut trees, and potentially Persimmon trees for the Club to give to the public in recognition of Arbor Day. In addition, as the Division of Forestry could not provide Paw Paw trees (another requested variety), Craig reached out to Sheri Crabtree, MSc, Horticulture Research and Extension Associate Academic Affairs, of the Kentucky State University. KSU is well known nationally for their Paw-Paw tree program (have you ever tried Paw-Paw ice cream? Or Paw-Paw wine?), and we may have a few Paw-Paw trees to give away as well. Altogether, between 150 and 220 trees will be available free to the public to plant locally, improving the environment (and depending upon the demand April 1st, more trees - potentially additional varieties - may be obtained for the April 15th event, particularly with regards to Black Walnuts)!

This marks the third time that the Tollesboro Lions Club has offered free trees in recognition of Arbor Day, having previously offered free trees in 2019 and last year (2022).

The trees will be available at two upcoming events at the Tollesboro Lions Club, one before Kentucky's Arbor Day, and one after. Trees may be picked up at the Tollesboro Lions Club Fairgrounds on April 1st at our Community Easter Egg Hunt/Mud Sling Benefit for Makenzie Forman. Additional trees will be available for pickup at the Tollesboro Lions Club Fairgrounds on April 15th when we host a Benefit for Dwight Malone.

Tree planting is a project recommended by Lions Club International's "Initiative to Improve The Environment". While trees provide natural beauty to the areas in which they are planted, it is not just their inherent beauty that improves the environment. Oaks, walnuts and the Chinese Chestnut all produce nuts (acorns from oaks are one of the most beneficial nuts for providing energy to deer, squirrels, and other wildlife, especially during the winter months; walnuts and chestnuts may provide a food source to some animals, but ate suited to human consumption). Most tree varieties will grow to become large trees, generally in excess of 40 feet in height, often exceeding 100 feet, and leaves scattered throughout the height provide for shady canopies in which many birds nest and as necessary to the survival of many other plants and animals. This shade also acts to cool the earth, providing an important defense against global warming. Also, once trees mature, they sometimes become

homes for different wildlife; And oaks, walnuts, and chestnut are hardwood trees producing timber which we use for a variety of purposes (fuel, building materials, furniture, manufacture of paper, etc.). Persimmons and Paw-Paw trees provide fruits suited to human consumption as well as for wildlife. However, the most important benefit to the environment of all trees is their ability to clean air, taking in carbon dioxide from the air that we exhale and converting it through the process of photosynthesis to oxygen which we inhale.

FUN TREE FACTS: The Mighty OAK (not any particular variety) is the Official National Tree. Kentucky's Official State Tree is the Tulip Poplar (however there was a time, from 1976 to 1994, that the Kentucky Coffee Tree was the Official Kentucky State Tree. A possible reason for it's replacement is that parts of the tree are toxic with instances known and proven where leaves, seeds, and seed pods falling from a Kentucky Coffee Tree into ponds have poisoned and killed cattle).

Juglans nigra (Black walnut) Walnut Family (Juglandaceae)

Introduction:

Black walnut is a common tree throughout Kentucky. At one time it was abundant, especially in mixed forests on fertile soils. Large trees over 100 feet tall were once common, but most of these have been cut to clear farm land or harvested for its valuable lumber.

Culture:

Black walnut grows best in fertile, moist soils. However, it will tolerate drier sites. It produces a tap root that makes it difficult to transplant.

Black walnut is often avoided in landscape situations because the tree's leaves and roots contain a compound called juglone. Many plants exhibit reduced growth or even death when exposed to small amounts of juglone. The competitive advantage of black walnut due to juglone is an example of allelopathy.

Additional information:

Black walnut is a valuable timber tree. The wood is prized for cabinet and furniture. Demand for the lumber is high and does not meet demand. Solid walnut furniture is uncommon today, with most pieces being made of walnut veneer.

Nuts are flavorful, but not as commonly available as English walnuts. In the wild, nuts are an important wildlife food.

Black walnut is a favorite host for mistletoe. Mistletoe is a plant parasite that lives in the tops of trees and takes water and nourishment from its host tree.

The National champion trees is Oregon and is over 130 feet tall. The Kentucky champion tree is in Nelson County and is 80 feet tall.



Botanical Characteristics:

Native habitat: Native along the entire east coast from Florida to New England. It grows as far west as Minnesota.

Growth habit: The tree produces an open, rounded crown.

Tree size: Common to see trees 60 feet tall, however, it can reach 150 feet tall.

Flower and fruit: Male flowers are catkins; female flowers lack petals and are formed in spikes. The fruit is a nut with a lemon-scented outer covering.

Leaf: Leaves are compound having approximately 16 leaflets with fine teeth along the margin.

Hardiness: Winter hardy to USDA Zone 4.

Quercus macrocarpa (Bur Oak) Beech Family (Fagaceae)

Introduction:

Bur oak is a member of the white oak group with lobed leaves. Considered the classic North American savanna tree, bur oak lacks some of the grace and beauty of white oak, but it is a much more adaptable tree. Bur oak offers large, beautiful leaves and acorns. During winter, it fully reveals its rough, gray bark.

Culture:

Although the bur oak is too large for most home landscapes, it is an excellent park tree. Native to rich bottom land, this oak is tough and adaptable. It is cold hardy, tolerates drought and grows best in full sun. It is more tolerant of urban conditions than most oaks.

Its well-developed tap root makes bur oak difficult to transplant. Because of its large leaf size, leaf litter may be a landscape problem.


Although bur oak has no serious disease or insect problems, potential problems include obscure scale, two-lined chestnut borer, bacterial leaf scorch, oak horn gall and gypsy moth. In addition, as little as 1 inch of fill soil can kill an oak.

Additional information:

The species name, *macrocarpa*, is derived from the Greek words *macros* (large) and *carpos* (fruit), referring to the bur oak's large acorn. The bur oak acquired its common name because of the resemblance of the fringed acorn cap to the bur of the chestnut fruit.

The massive root system of the bur oak is said to be a mirror reflection of the trunk and branch system above ground. With this extensive root system it is not surprising that the bur oak is the dominant tree of midwestern prairies, often considered the advancing pioneer species. Remaining trees are considered the most fire-resistant, having withstood the ravages of periodic prairie fires.

The root system of bur oak successfully competes with prairie grass roots as well as neighboring bur oaks. Intense root competition keeps bur oaks scattered apart from each other throughout the savanna. Bur oak seedlings cannot survive in the shade of a dense forest.



Botanical Characteristics:

Native habitat: Nova Scotia to Pennsylvania, west to Manitoba and Texas.

Growth habit: This tree has an irregular, open crown with coarse, broad-spreading limbs and a massive trunk.

Tree size: A slow-growing tree, it can reach 70 to 80 feet in height and width. This tree may live hundreds of years. It can exceed 100 feet in height.

Flower and fruit: Female flowers are inconspicuous. Pendulous male catkins are yellow-green. The 3/4 to 1½-inch-long acorn is half covered by a fringed cap.

Leaf: Leaves are 4 to 12 inches long, lobed and shaped like a base fiddle. The beautiful leaf is glossy and smooth above while pale and hairy below. Fall color is a dull yellow to yellow-brown.

Hardiness: Winter hardy to USDA Zone 3.

300 bearing acres, with larger acreages per farm than Michigan. The number of states reporting 100 or more acres of chestnut trees for nuts increased from eight in 2012 to 13 in 2017, according to the 2017 Census of Agriculture. Iowa, Missouri, Ohio and Virginia tallied substantial new plantings since 2012.

Marketing channels for U.S.-grown chestnuts have mainly focused on niche, upscale foodservice and specialty food markets. Production for local sales, such as at farm festivals, is a possible way to add value to small-scale production. The agricultural cooperative Chestnut Growers, Inc., developed as a processing and marketing outlet in Michigan, as has the Route 9 Cooperative in Ohio, where its members could access a commercial-scale chestnut peeler for processing.

Production Considerations

Planting material and cultivar selection

Chestnut trees may be established from seeds, seedlings, or grafted trees. Planting grafted trees is preferred for consistency in yield, ripening, size, and quality of the nuts produced. While seedling trees are generally more readily available and less expensive to purchase, grafted trees come into bearing sooner than seedlings. Grafted trees should have a genetically similar rootstock to avoid delayed graft incompatibility several years after planting. Grafted tree survival is more likely when the rootstock is a seedling of the scion cultivar.

There are a number of Chinese chestnut cultivars and hybrids that are well adapted to Kentucky conditions. Nut characteristics, such as size, flavor, cracking quality, and storage life can vary among varieties. It is particularly important to choose selections resistant to chestnut blight, and cultivars that produce the largest nuts such as Qing. Most markets require large chestnuts. Chinese chestnuts are self-sterile, so two or more different cultivars are required for good pollination. Refer to Nut Tree Growing in Kentucky (ID-77) for recommended varieties. Custom grafted trees may have to be ordered a year in advance.

Site selection and planting

Chestnuts can be grown on land that is considered unsuitable for other crops, such as sandy or gravelly soils. Heavy, poorly drained sites should be avoided, as chestnuts are very susceptible to Phytophthora root rot. Chestnuts prefer soils that are somewhat acidic (pH 5.5 to 6.5) and will not tolerate high pH soils. While trees are cold hardy when dormant, swelling buds are susceptible to frost damage in the spring. Do not plant in frost pockets or locations with poor air drainage.

Mature chestnuts require a final 40 feet by 50 feet spacing; however, it may take 20 or more years before trees actually fill this space. Some growers interplant chestnut seedlings at a closer spacing among grafted chestnuts. As the permanent grafted trees mature and come into full production, these filler trees are removed.

Trees are trained to a modified central leader shape, with only limited pruning needed on bearing trees. Young trees require protection against sunscald injury to their smooth bark with white spiral trunk guards. Supplemental watering helps promote tree growth and to reduce stress, especially in the first year. Once established, trees are relatively drought tolerant; however, irrigation will help bearing trees to produce larger nuts and improve nut fill.

Pest management

Eliminating undesirable vegetation prior to planting is essential for tree establishment. Weeds should be controlled within 3 feet of young trees. Weed control strategies include the use of herbicides and mowing between tree rows. Chestnut blight is still present in the U.S., but using blight-resistant varieties may reduce disease incidence. Potential insect problems include aphids, Japanese beetles, potato leafhoppers and chestnut weevil. Insecticide applications will be required annually for weevil control and as needed to control Japanese beetles. The Asian chestnut gall wasp (ACGW) is also present in Kentucky. Biological control through parasitoids is showing some control. There are no insecticides cleared for ACGW, but adult wasps are easily killed with sprays applied for Japanese beetle.

Young trees are very prone to damage by animal pests, such as rabbits, mice, squirrels and deer. These pests will need to be controlled to reduce nut losses. Placing plastic guards around each tree soon after planting will help deter feeding damage from voles or rabbits when population pressure is low. Deer fencing and tree shelters should be used until trees are large.

Harvest and storage

The first harvest for seedling chestnuts can be expected in five to six years. Grafted trees will begin to bear within three to five years, with larger yields beginning six to nine years after planting. Soil moisture is important prior to harvest because half the kernel growth takes place during the last two weeks before ripening.

Chestnuts are hand-picked off the ground once they have fallen from the tree. Daily harvesting is necessary to prevent the fallen nuts from drying out and to ensure that area wildlife does not steal or damage the crop. Alternatively, where deer or squirrel losses are severe, nuts in burs may be shaken from the tree once the burs begin to split. Chestnuts harvested too early will be smaller, softer in texture and hard to remove from burrs.

Harvested nuts are separated from any debris gathered at harvest and cleaned so they are free of dirt. Promptly refrigerate (32° F or slightly above) in ventilated plastic bags. Nuts should not be allowed to dry out. Curing and storing chestnuts is a fairly involved process, and interested individuals should consult the harvesting and storage article from Michigan State University listed in the Selected Resources at the end of this document.

Labor requirements

Based on 1,000 to 2,000 pounds produced per acre, labor needs are approximately 80 hours for establishment in the first two years, 25 hours for production, 70 hours per ton for hand harvest, and 16 hours per ton for packaging and grading.

Economic Considerations

Chestnuts require three to six years for establishment before any nuts may be harvested, and 10 years before yields are significant. This delay will mean a period without any cash income, presenting a significant financial and production risk. For this reason, many chestnut growers start with the crop as a hobby or source of generating farm income from underutilized land.

Initial investments for chestnuts include land preparation, the purchase of trees, deer fence installation and the installation of an irrigation system. Other costs may include a sprayer, a nut shaker, cleaning equipment, a grader, and cold storage. Significant costs may



be incurred protecting seedlings from animal pests. Substantial losses due to graft incompatibility may also occur if grafted trees are not selected carefully.

Establishment costs will vary depending on production systems and tree costs. Total establishment costs for 1 acre of chestnuts in Kentucky would likely range from \$4,500 to \$8,000 per acre for the first five years of grafted tree production. Estimates from Michigan calculate a five-year establishment cost at \$7,797, including a \$1,187 deer fence cost. Estimates for Kentucky production (2019), based on a price of \$2.50 per pound, show establishment costs recouped after seven to nine years. Annual returns to labor, land and management of \$1,000 to \$1,450 per acre of chestnuts could be realized after year 7.

Financial returns may increase as trees mature and produce substantially greater yields of nuts per acre. Higher prices will also generate greater profitability from chestnuts. Product quality (particularly, weevilfree) and market development are essential for profitable chestnut production. Potential chestnut producers can utilize a detailed financial projection tool, developed by the University of Missouri Center for Agroforestry, to estimate long term profitability.

Introduction:

Common persimmon has distinctive thick, dark gray to black bark that is broken into scaly, square blocks. Because of its messy fruit, it is not among the better choices for the home landscape, but is an interesting native tree that is suited for use in parks, golf courses and naturalized areas.

Culture:

Common persimmon grows best in moist, well-drained, sandy soils but will perform well in dry soils with low fertility. It prefers full sun and adapts to a variety of pH situations. It is hardy in Zones 4 to 9.

This tree can develop a blackish leaf spot, although trees seem to vary considerably in susceptibility. In the South, it is susceptible to a vascular wilt. Tent caterpillars can also be a problem.



Additional information:

Common persimmon was introduced into the landscape in 1629. It is often found along fence rows and in abandoned fields. The tree suckers profusely and often forms naturalized stands.

Before ripening, persimmon's fruit is not edible. The fruit is not ripe until the skin is wrinkled. Fruit presents a litter problem, and attracts flies and opossums as well as raccoons, skunks, foxes, deer and songbirds. The plant is dioecious, so a male (fruitless) tree would be a much more acceptable landscape plant than the female.

Immature fruits contain a large amount of tannin and are astringent. They have been used to make tea for use in gargling for sore throats. The tea was also used to treat warts, cancers, heartburn, diarrhea and stomach aches.

Ripe persimmons are said to taste a great deal like dates. They are used to make cakes, puddings and beverages. Native Americans used the fruits to make bread, and also dried them. Cooking oil, with a flavor like that of peanut oil, can be extracted from the seeds.

Confederate soldiers boiled persimmon seeds as a coffee substitute during the Civil War. Persimmon wood is very hard and nearly black. It is used to make golf club heads, billiard cues and parquet flooring.

Diospyros means "fruit or wheat of the gods;" virginiana means "from Virginia." One common name, possum wood, was given to the tree because opossums love its fruit.

Botanical Characteristics:

Native habitat: Connecticut to Florida, and west to Texas and Kansas.

Growth habit: Slender, oval-rounded form; usually has a symmetrical outline.

<u>Tree size:</u> 35 to 60 feet tall, 20 to 35 feet wide.

Flower and fruit: Flowers are white to greenish white and are shaped like blueberry flowers. The tree blooms in late April. Fruit is a yellowish to pale orange berry that is 1 to 1½ inches across. Fruit, which is edible, ripens in September or October. It is delicious when ripe, but highly unpleasant before ripening.

Leaf: Alternate, simple leaves are 2 1/4 to 5½ inches long, and 3/4 to 2 inches wide. Leaves are dark green in summer but have little or no fall color other than occasional purple blotches. Hardiness: Winter hardy to USDA Zone 4.

Asimina triloba (Pawpaw) Custard Apple Family (Annonaceae)

Introduction:

Pawpaw, found from New York to Florida and west to Texas, has a semi-tropical appearance and is known for its fruit, the largest berry (up to 5 inches long) produced by any tree native to the United States. The fruit is nutritious and has been used in cancer therapy. Its twigs and bark contain a natural insecticide.

Culture:

Pawpaw prefers fertile, moist soil that is slightly acidic, and will sometimes tolerate wet soil. It can be grown in sun or shade, exhibiting dense growth in sun and open growth in shade. Pawpaw grows quickly if mulched and watered during droughts; it is drought-sensitive when grown in sun. Seedlings should be planted in shade for the first year as they are sensitive to ultraviolet light.

Pawpaw is pest-free and hardy in zones 5 through 8. It can be trained to grow with multiple trunks and its limbs are break-resistant. Some pruning is needed to create clearance because of drooping branches. Mowing or pruning the suckers that emerge from the root system encourages sprouting, so they should be hand-pulled while still small.

Cultivars:

There are at least 45 cultivars of pawpaw selected for their fruit characteristics. The national germplasm repository for pawpaw is at Kentucky State University in Frankfort, KY. Selected cultivars include:

'Convis' - Large (up to 1 pound) fruits with yellow flesh.
'Davis' - An older, popular plant from Michigan introduced in 1961. The fruit are less than ½-pound with yellow flesh.
'Overleese' - Heavy producing plant with clusters of

1-pound fruits. Selected in Indiana.

'Sunflower' - Produces 8-ounce fruit with a butter-yellow flesh. Said to be self-fertile. Selected in Kansas.

'Wells' - This cultivar has fruit with green skin and orange flesh. Fruit are a little less than a pound. Collected in Indiana.



Botanical Characteristics:

Native habitat: Northern Florida to Western New York, northern shores of Lake Ontario, Southern Michigan to Southwestern Iowa, and west to Southeastern Nebraska, and eastern parts of Kansas, Oklahoma and Texas.

Growth habit: Round, upright pyramid, with moderate density and coarse texture.

Tree size: 15 to 20 feet tall, 15 to 20 feet wide; can grow to 30 to 40 feet tall in ideal locations. Growth rate is moderate.

Flower and fruit: Flowers are nearly 2 inches across, pale green before turning brown, then maroon or purple. Pawpaw blooms in spring before leafout. Fruit is a 3- to 5-inch-long berry that is green when young then becomes dark and wrinkled when ripe in October or November. Ripe fruit has a flesh like custard and tastes a lot like bananas.

Leaf: Alternate, simple, 4 to 10 in+ches long and 4 to 6 inches wide. Light green, turning yellow in fall.

Hardiness: Winter hardy to USDA Zone 5.

Asimina triloba (Pawpaw) Custard Apple Family (Annonaceae) Page 2

Additional information:

There has been great demand for pawpaw recently, not only because of its appealing ornamental characteristics and tasty fruit, but also because of its potential as a source of organic insecticide and for use in cancer therapy. An insecticide can be made from the tree's ground-up bark and twigs. Extract from pawpaw can overcome the ability of some cancer cells to reject chemotherapy.

On dormant stems, pointed buds are vegetative while flower buds are round and fuzzy.

Cross-pollination is needed to get good fruit set in pawpaw. Pawpaw fruit develops in clusters. Fruit with orange flesh is considered the tastiest.

The fruit attracts wildlife (especially raccoons, opossums, gray squirrels and birds). It also attracts the beautiful zebra swallowtail butterfly, giving added incentive for wildlife lovers to obtain the tree. It is an excellent source of vitamins A and C, and is high in unsaturated fats, proteins and carbohydrates. Pawpaws contain more potassium, phosphorus, magnesium and sulfur than apples, grapes or peaches.

The first reference to pawpaw came in writings of Hernando DeSoto's expedition to the Mississippi Valley in 1541. The fruit, a favorite food of American Indians, was used to feed DeSoto's conquistadors. Early North American settlers used the fruit to make jelly, and the tree's inner bark to string fish. Indians in Louisiana used the inner bark to weave a fiber cloth.

Although pawpaw is in great demand, it does have a disadvantage. Its fruit and foliage produce a great deal of litter. Planting only one tree can help alleviate the problem, as lack of cross-pollination leads to production of less fruit. Because they are broader at the tip than at the base the leaves droop, giving pawpaw a "sleepy" or tropical appearance. The genus Asimina includes the only temperate members of this family.

The tree, which is hard to transplant because of its wide root system, should be balled-and-burlapped and moved when it is less than 6 feet tall.

Come on out and put your skills to to the test. Then challenge whomever you want to see who really has "top cowboy" potential!!







The truck will be setup from noon until 6 pm. A wonderful way to add something to your lunch or dinner plans! Or just grab a mid-afternoon snack.


TOLLESBORO LIONS CLUB SITE OF FUND-RAISER FOR DWIGHT MALONE

IMPROVEMENTS MADE TO PAVILLION AT TOLLESBORO LIONS CLUB FAIRGROUNDS

The Pavillion at the Tollesboro Lions Club was recently improved. The 12 bay structure had rollup garage doors installed (12 total) on the south side of the building. This will permit the south side to be shut off from rain, snow and wind (most of the weather that enters the building comes from the south). This is a much needed improvement. At an event last April, on a very cold day, sharp winds drove thru the south side of the building during an event, making for a very uncomfortable situation for those gathered inside. The event was a "Meet the Candidates" event, and included a dinner, announcer, and guest speakers, who were standing on the cold concrete and taking the brunt of the winds that whipped through the building. While tarps were put in place at that time along a small portion of the southern exterior, not enough tarps were obtained and those that were put in place were not large enough to cover the entire opening, thus the tarps only cut down some of the wind, but nowhere near all of the wind that whistled through the structure. Lions Club President Craig Stanfield was the Master of Ceremonies and it was due to the inhospitable conditions that he suggested that the improvement be made, even going so far as to obtain a bid for the renovation. However, Jim Meadows obtained a second bid, saving significantly on the original estimated installation costs, with the total cost of the materials and labor \$18,400, a cost and improvement that the Club approved and which will make the building more functional for many events and for many years. The garage doors will show their usefulness very soon, as will almost certainly be used during the the rapidly approaching Community Easter Egg Hunt to be conducted on the Fairgrounds April 1st.

APRIL 1ST EVENTS AT TOLLESBORO LIONS CLUB VERY SUCCESSFUL!

On Saturday, April 1, 2023, the Tollesboro Lions Club Fairgrounds was the site of multiple events. While the weather was sunny and warm, heavy rains had fallen overnight, leaving some mud puddles and dampness on the grounds. But the heavy winds the day of the event made for less than an ideal conditions for success. However, the "show must go on" and it did just that, and to great success regardless!!! The events included an Easter Egg Hunt, a Mud Sling, and a Tree Giveaway.

The Easter Egg Hunt was a SPECTACULAR SUCCESS with more than 110 kids participating and close to 300 in attendance including parents, grandparents, Lions Club members, organizers and friends. This was the first Community Easter Egg Hunt ever conducted at the Fairgrounds, so no one knew what to expect. Weather conditions were not ideal for outdoor events. So all we could do was set up the event and hope for the best. But as time neared for the event to start, families started arriving with children in tow, and they were not disappointed. The organizers had worked hard and had somewhere between 3,000 and 4,000 plastic eggs hidden on the fairgrounds (each with a small prize inside, a piece of candy or a prize ticket!). The children were organized into 5 age groups with eggs set up in zones for each age group. An abundance of prizes was available, including a bicycle! A big round of applause to Tabby Liles, Carol Cunningham, Kyra Bane, Vanessa May and Becky Walker who did the hard work behind the scenes planning and organizing the event.

The tree giveaway was also a very successful venture. 94 trees were offered free to the public to celebrate Arbor Day (Arbor Day in Kentucky is April 7th, although celebrated nationally on April 28th. The Tollesboro Lions Club will be giving away trees on two dates, coinciding with events at the Fairgrounds, April 1st and April 15th). The trees included 50 Black Walnuts, 10 Chinese Chestnuts, and 10 Burr Oak provided by the Kentucky Division of Forestry, plus there were 24 Paw-Paw trees provided by Kentucky State University. This event landed solely upon the shoulders of Tollesboro Lions Club President Craig Stanfield who organized the event, and made the necessary contacts with the Kentucky Division of Forestry and Kentucky State University, arranging to acquire tree varieties that had been requested since last year's giveaway, coordinating the donation and delivery of the trees from the Kentucky Department of Forestry and picking up the trees donated by Kentucky State University, then promoting the event and giving the trees away. All the trees had found new homes **BEFORE NOON**, with a few late arrivals who were informed that the trees had already been given away but that MORE TREES WOULD BE AVAILABLE AT THE APRIL 15TH EVENT coming up in two weeks at the Tollesboro Lions Club Fairgrounds (the April 15th event being a Tractor Poker Run, dinner, and a live auction, with the proceeds raised earmarked for Dwight Malone, a local farmer and electrician - as well as a former member of the Tollesboro Lions Club - who was recently diagnosed with Testicular Cancer).

The Mud Sling event was a fund-raiser for Makenzie Forman, a 13 year old young lade who has leukemia. Lewis County's own music artist Nate Stone performed for the crowd prior to the event, picking chords on the guitar and vocals, singing a number of country hits.

Unfortunately, the high winds did not permit him to perform in front of the crowd, as he had to take cover and perform from the announcer's booth and make use of a microphone and speaker system for the entertainment of the crowd.

Several fancy trucks (high octane/high horsepower/high performance engines, with big tires and nice paint jobs) were on site to show the crowd (and the competition) what their trucks would do. Eight classes showed up, 4/6 Cylinder, Hot Stock, Pro-Street, Pure Stock, Pro-Stock, Super-Stock, Diesel, and ATV. There were 27 entries total. The first class, the 4/6 cylinder had 4 entries. The winner was Cody Fryman, with Austin Gordman taking second, and with third going to J. J. Grayson. The second class was the Hot Stock, with 4 entries. Taking the win was Shawn Palmer, with David Senters finishing second, and Justin Howe taking third. The third class was the Pro-Street the largest class, with 6 entries. With the fastest time going to the first place winner, with David Sent Alex Bruce, with Kyle Walcott taking second and third going to Nick Wilson. Class 4, the Pure Stock class, had only 2 entries with Zac Bloomfield taking over Austin Nolder taking second. Class 5, the Pro-Stock class had 4 participants, with Jeremy Preston taking first, second going to Jerry Hoskins, and finishing third was Justin Tanner. Class 6, the Super-Stock Class had 3 entries, with Jason Hoskins taking first, Justin Tanner settling for second, and Troy Nolder ending up in third. Class 7 was the diesel class, with 2 entries with Hayden Smith the faster of the two taking first, edging out Aaron Denton settling for second. Class 8 was the ATV Class, with 3 entries in this class with Brandon Overbee taking first, with Josh Hazelbaker taking second, with Trenton Applegate in third.

Overall, the Mud Sling event was a great success, earning just under \$6,400 for Makenzie and her family. Our Prayers go to her for a speedy recovery!





SECOND ROUND OF ARBOR DAY TREE GIVEAWAY APRIL 15TH!

The Tollesboro Lions Club has once again partnered with the Kentucky Division of Forestry and with Kentucky State University to provide trees to give-away to the public at large for Arbor Day. Tollesboro Lions Club President Craig Stanfield contacted Michael Carter, Forest Ranger, and Suzy Knott, Forester (both of the KY Division of Forestry) and Sheri Crabtree (MSc, Horticulture Research and Extension Associate Academic Affairs) of Kentucky State University, both of whom were happy to provide trees for the Club to give away to the public. This year, we received a much better selection of tree varieties, filling requests made by members of the public last year and since, with the Division of Forestry providing us with Burr Oak, Black Walnut, Chinese Chestnut trees, and potentially Persimmon trees (as well as possibly White Pine) and with Kentucky State University providing Paw Paw trees (double the number of trees donated last year, with this year's trees being much larger than those provided last year!), for the Club to give to the public in recognition of Arbor Day. Trees were available April 1st at events conducted at the Tollesboro Lions Club and will be available on April 15th as well when the Tollesboro Lions Club will host a fund-raiser for Dwight Malone. This marks the third year that the Tollesboro Lions Club has offered free trees in recognition of Arbor Day, having previously offered free trees in 2019 and 2022.

The Tollesboro Lions Club participates in Arbor Day Tree Giveaways as tree planting is a project recommended by Lions Club International's "Initiative to Improve The Environment". While trees provide natural beauty to the areas in which they are planted, it is not just their inherent beauty that improves the environment. Oaks, walnuts and the Chinese Chestnut produce nuts; Paw Paws and Persimmons produce fruits. The nuts and fruits from these trees provide important food sources for wildlife, most of which are also suited to human consumption. Most tree varieties will grow to become large trees, generally in excess of 40 feet in height, often exceeding 100 feet, and leaves scattered throughout the height provide for shady canopies in which many birds nest and as necessary to the survival of many other plants and animals. This shade also acts to cool the earth, providing an important defense against global warming. Also, once trees mature, they sometimes become homes for different wildlife. Oaks, walnuts, and chestnuts are hardwood trees producing timber which we use for a variety of purposes (fuel, building materials, furniture, manufacture of paper, etc.). However, the most important benefit trees add to the environment is their ability to clean air, taking in carbon dioxide from the air that we exhale and converting it through the process of photosynthesis to oxygen which we inhale.

Arbor Day this year in Kentucky is celebrated April 7th, although nationally it is celebrated April 28th. The two events at the Tollesboro Lions Club (April 1st and April 15th) coincide with events being conducted at the Tollesboro Lions Club Fairgrounds, thus permitting the Club to give away trees on the weekend preceding Arbor Day as well as the weekend following Arbor Day. The tree selection this year (assuming that Persimmon and White Pine will be available) will "check off all the boxes" of tree varieties requested for planting locally, as Burr Oak, Black Walnut, Chinese Chestnut, Persimmon, and Paw Paw

requests had been made since last year, with the White Pine request made after this year's order had been placed. NOTE: If unable to attend the April 1st or April 15th events, or in order to reserve some trees prior to the event, or to see if there were any trees left over after the event, feel free to contact Craig Stanfield at 606-301-3350.

TOLLESBORO LIONS CLUB APRIL 10TH MEETING

The Tollesboro Lions Club met at 7 pm., April 10th, 2023 at the Tollesboro Lions Clubhouse for their regular first April meeting. The meeting was well attended with 18 persons and 8 guests. President Craig Stanfield opened the meeting, welcoming guests, introducing new member Eric Bloomfield, then asking Lion Steve Pedersen to give the blessing, followed by Lion Charles Kendall leading the group in reciting the Pledge of Allegiance. The group then broke for dinner.

Following the meal, President Stanfield invited Loretta Dixon (the surviving spouse of Darrell Dixon) and Missy Dixon (Darrell's daughter), to the front of the room and presented them with the Finis Davis Fellowship and the Melvin Jones Fellowship posthumously in honor of Darrell Dixon, a 50 year member of the Club who passed away in Dec., 2022. Next, Craig invited Brenda Tucker (the surviving spouse of Larry Tucker), daughter Ann Marie Scott, her husband Shaun and their daughter Makenna, as well as Carolyn Hughes (the sister of Larry Tucker) and presented them the Finis Davis Fellowship and the Melvin Jones Fellowship, honoring Larry Tucker's 55 years of service to the Tollesboro Lions Club, Larry having passed away in Nov., 2022. Craig informed the families of the namesakes of the awards: Melvin Jones was the founder of Lions Clubs; Finis Davis Kentucky's only International Director, having served 1960-1961. The Tollesboro Lions Club contributed funds for disaster relief to Lions Club International Foundation for the Melvin Jones Fellowships, and for sight preservation to the Kentucky Lions Eye Foundation for the Finis Davis Fellowships.

Following the posthumous presentations of the awards, the business meeting began. The minutes from the March 13th meeting were read and approved. No Treasurer's report was presented. Under old business, brief discussions were made about the potential acquisition of a large fan for the agricultural livestock show barn and an AED unit purchase/training. Under New Business, the Club was informed about several recent events (Community Easter Egg Hunt; Arbor Day Tree Giveaway; Makenzie Forman benefit Mud Sling; Hot Rod Ruark benefit; Eastern Kentucky donations and deliveries; Tollesboro PTO benefits (Auntie Anne's Pretzels and a luncheon; the placement of garage doors on the south side of the Pavillion; and the recent visit to the Fairgrounds by Ryan Quarles, current Kentucky Commissioner of Agriculture and Candidate for Kentucky Governor. Upcoming events were also mentioned: The Tractor Poker Run, Dinner, and Benefit Auction for Dwight Malone (as well as second round of Arbor Day Tree Giveaway) set for this weekend (April 15th); and the Spring Trade Days for the first weekend in May (May 4th through May 6th). The rapidly approaching 2023 Tollesboro Lions Club Fair (July 14-22, 2023) was briefly mentioned. It was also mentioned that Tollesboro Lions Club Scholarship applications needed to be turned in by next meeting; applications could be downloaded from the Tollesboro Lions Club website, www.tollesborolions.com. Lion John Redmond was named to the Scholarship Committee to fill the vacancy created by Larry Tucker's passing (he will serve alongside Secretary Lion Phil Cropper and fellow Lion Denny Hornback).

Treasurer/First Vice District Governor Steve Pedersen announced that over \$9,000 had been donated by various Lions Clubs and other organizations throughout Kentucky to purchase food to deliver to Eastern Kentucky Flood Victims. Enough food was purchased to arrange for boxes of food to serve 500 families, with a trailer load located on the grounds in an enclosed trailer that needed to be unloaded. A work-night was immediately arranged to follow the meeting to unload the trailer. An additional trailer load would be picked up for delivery and unloading in a few days, with plans to box and then deliver the food to Eastern Kentuckians to be scheduled in the near future.

Under New Business: President Stanfield indicated that he was contacted by County Judge George Sparks asking the Club to consider paying \$75 / month for mowing (this is consistent with what the Club paid towards mowing last year). A motion was made and seconded, which passed unanimously.

Next, President Stanfield informed the members that he had been contacted by new Peoples Bank of Ohio Branch Manager Natalie Stitt about what needs the Club had, and informed her that the Club was in need of an Amish-type building for placement on the grounds as a "lost and found", "first-aid", and multi-purpose structure. He was asked to inquire as to the cost of such a building and if the Bank would arrange for payment of such a structure, could a sign be placed on the structure to promote the Bank. Craig obtained a quote for a 14' x 20' structure, single door, no windows, no porch, at a delivered cost of around \$7,000. He informed the Club that the Bank would provide for said building in exchange of a sign placement for a period of 7 fairs. A motion was made to accept said building and permit sign placement on said structure (sign to be provided by the Bank) for a 7 year period. The motion was seconded, and approved unanimously.

The Mud Sling Pit was being enlarged and it was determined that there would be a need to obtain 100 or more 6' concrete barriers to place alongside the wall. Cost of the concrete barriers was estimated to be between \$35 and \$40 each. A motion was made to approve the purchase of up to 125 concrete barriers, as needed, with a per barrier cost not to exceed \$40. Motion was seconded and approved unanimously.

President Stanfield then presented new member Eric Bloomfield with a new member packet and Lions Club lapel pin. Being no further business, the meeting adjourned. However, before departing, members went to the Floral Hall for the purpose of unloading the trailer load of various cans of food items purchased from donations for the purpose of donating said food to Eastern Kentucky Flood Victims.

APRIL 15TH MARKS 10TH ANNIVERSARY OF LIONS CLUB MEMBER'S CONTINUING DONATION TO LOCAL FOOD PANTRY

April 15th was a busy day for Tollesboro Lions Club President Craig Stanfield, giving away trees to the public for Arbor Day and conducting the auction for the Tollesboro Lions Club sponsored benefit for Dwight Malone. But April 15th also marked the 10th anniversary of Mr. & Mrs. Stanfield's purchase of the Tollesboro High School and thus the 10th anniversary of the donation of the use of the old Tollesboro High School for use by the Lend-A-Helping Hand Food Pantry and Clothing Bank.

The Lend-A-Helping Hand Food Pantry gives food away each month to those in need, serving approximately 350 families each month on the third Friday of each month, serving nearly 500 families in November and approximately 450 families each December. In addition, during summer months, additional days are sometimes provided for food giveaways when excess food is available (the Lend-A-Helping Hand Food Pantry has also contributed food items to other Food Pantries when they have had excess items available). The Food Pantry also operates a clothing bank to provide clothing for victims of fire or other disaster, as well as providing the occasional bit of furniture for fire victims or other needy persons.

The Food Pantry has been in operation at the Tollesboro High School for many years, dating back to a date when the Tollesboro Lions Club previously owned the property, and throughout the ownership of the property by the Tollesboro Christian School, with both organizations donating the use of the facility for the Food Pantry during their respective terms of ownership. The Food Pantry is further supported by Tollesboro Lions Club member Jim Meadows as owner of Rip's Farm Supply, who donates the use of his truck & trailer when returning empty from making deliveries of feed and other products to various locations, to further permit and provide for pickup of food items from God's Pantry, Kroger, and other suppliers, and delivering such items to the Pantry.

The food pantry is supported by local churches and numerous other persons and organizations which provide additional aid to the Food Pantry, including significant hours each month of free labor used to unload and organize the donations, then boxing the food items, load them onto the recipient's vehicles in drive-thru fashion, and otherwise providing for inventory, ordering, monitoring, and other organizational needs of the Pantry.

ARBOR DAY TREE GIVEAWAY WELL RECEIVED

The Tollesboro Lions Club gave away a total of 214 trees to the public for planting in honor of Arbor Day. The Club gave away 94 trees (50 Black Walnut, 10 Chinese Chestnut, 10 Bur Oak, and 24 Paw-Paw) on April 1st, and gave away 120 more trees (50 Black Walnut, 10 Chinese Chestnut, 10 Burr Oak, and 50 White Pine) on April 15th. The tree giveaway events were made to coincide with events conducted at the Tollesboro Lions Club Fairgrounds on April 1st and April 15th, book-ending the weekend preceding and immediately following April 7th, the official Arbor Day Celebration for Kentucky (nationally, Arbor Day is celebrated April 28th this year). These trees were distributed free to the Public! Of the 214 trees given away, 190 (bareroot) trees were provided by the Kentucky Division of Forestry and 24 trees (the Paw-Paw trees, container trees in soil) were provided by Kentucky State University.

The Tollesboro Lions Club participates in Arbor Day Tree Giveaways as tree planting is a project recommended by Lions Club International's "Initiative to Improve The Environment". 2023 marks the third year that the Tollesboro Lions Club has offered free trees to the public in honor of Arbor Day, having previously given away trees in 2019 and 2022. This year's event's success was enhanced as the Tollesboro Lions Club just happened to have busy events at the fairgrounds the weekend immediately preceding and immediately following Kentucky's Arbor Day Celebrations, thus making the trees available to a larger group of persons who may not have been offered the opportunity to obtain free trees during past events.

The Tollesboro Lions Club Fairgrounds has seen an abundance of youth on the grounds taking advantage of the recent sunny and warm weather to use the Playground and the Baseball Field. TOLLESBORO LIONS CLUB SECOND APRIL MEETING; OFFICERS ELECTED

The Tollesboro Lions Club met Monday, April 24th at their Clubhouse at the Fairgrounds at 7 pm for their regularly scheduled April meeting, their second meeting of the month, and a business-filled meeting! 14 members were present. Just prior to the beginning of the meeting, Shirley Williams of Woodmen Life made an appearance to present the Club with a 5' x 8' US Flag after which she left for another meeting. At 7 pm, President Craig Stanfield opened the meeting, asking Lion Jim Meadows to offer Prayer, followed by Lion Denny Hornback leading the group in the Pledge of Allegiance, after which the group broke for dinner.

Following the meal, President Stanfield read the press release of the last meeting in lieu of the minutes in the absence of Secretary Phil Cropper. The press release was accepted, as read, as a true and accurate account of the last meeting.

Treasurer Steve Pedersen then presented the group with the financial report, which was approved as read (NOTE: Treasurer reported that the garage doors installed on the Pavillion had been paid for, total cost \$18,400).

Under Old Business: Lion Shane Wallingford presented the group with a cost estimate to purchase a 12' fan for use in the Livestock Show Barn Arena (cost \$4200 plus tax and shipping, plus installation). He also presented cost estimates for smaller fan units that could be placed in various locations as needed as an option, and as a non-permanent installation. While mulling over the options, and at one point considering tabling the issue for the next meeting, it was brought up that the 12' fan was an idea of now deceased member Clinton Applegate and that monies had been collected to pay part of the costs of said fan, and that Clinton's support and dedication to the event was significant. Lion Jim Meadows made a motion, which was quickly seconded by Zach Tully, to purchase and install the 12' fan, basically in homage to Clinton's desire and dedication to the event, and the motion was approved unanimously.

The Club is in the process of improving the Mud Sling Track. Construction was discussed as the improvement will require considerable costs, as will require relocating an existing waterline and hydrant, upgrading electrical and lighting (including replacement of poles and purchase/installation of new light fixtures, as well as installation of a new electrical breaker box), erecting a new fence, backhoe/grader/excavator work to widen the pit, and purchase/transport/installation of concrete barriers.

An upcoming event at the grounds will be a dinner and auction to support former Lion member Kenny Cooley who is suffering from various health issues. It was discussed that at the last auction event, a woman had fallen over the lip of the stage. It was discussed about painting the stage; however a better option was determined to be placement of a railing. Under discussion, President Stanfield stressed that the stage "lift" improved his sight visibility as auctioneer by slightly lifting him somewhat above the crowd. Someone suggested limiting the public from accessing the stage; however President Stanfield stated that the stage would need to be accessible by the public to permit the public to view items that were to be sold at the benefit auctions conducted in the Pavilion. It was suggested that removable

"gates" or barriers (rather than hinged gates) could be placed centrally and on each end to permit opening to allow podium, public address systems, tables and chairs, musical/audio equipment, or other items to be placed on the stage. Lion Wallingford indicated that there was a sale on 3" pipe that could be used to fabricate a rail extending across the entire stage area similar to a handrail, and that removable gates could be placed within the handrail for accessibility. A motion was made by Lion Denny Hornback, seconded by Lion Charles Kendall to approve the installation, with the hope that the installation could be performed prior to the May 13th Kenny Cooley Benefit Event.

Next, Lion Wallingford indicated that he had been in contact with the Athletic Director about utilizing student athletes on the grounds during the fair for parking in order to free up some of the members for events. It was also discussed that several members of the Amish Community had been assisting with parking and had experience in parking vehicles. It was also mentioned that the Fleming County Archery Club was interested in assisting in cleanup of the grounds and trash collection again this year. No motion was made, however it was suggested that these groups be kept in the loop and in consideration to assist in parking services.

It was announced that Scholarship Applications were due next meeting and that the Scholarship Committee would be meeting to select Scholarship recipients at the next meeting (May 8th; Scholarship applications may be downloaded from the Lions Club website, www.tollesborolions.com). The Scholarship Committee is made up of Lions Phil Cropper, Denny Hornback, and John Redmond .

Lion Lee Thomas mentioned that the Tollesboro Elementary School PTO would be conducting two fund-raisers in May: A lunch would be available some day in May (date to be announced), and Auntie Annie's Pretzels would make another appearance on the Fairgrounds May 26th.

The Spring Trade Days Event would be conducted on the Fairgrounds May 4th through 6th.

Lion Pedersen mentioned that it would soon be time to nominate officers. President Stanfield asked for volunteers for a nominating committee; however Lion Denny Hornback made a motion, seconded by Lion David Hampton, to re-elect the officers to another term. It was then brought up that due to the passing of Lions Clinton Applegate and Darrell Dixon, as Clinton was First Vice President and Membership Chairperson, and as Darrell was Club Administrator. Nominations were made to move Second Vice President Lee Thomas to First Vice President and Third Vice President Jim Meadows to Second Vice President. Clinton's sons, Trevor and Travis Applegate were nominated to fill the unfilled positions opened by Clinton's passing, with Trevor nominated as Third Vice President, and Travis nominated as Membership Chairperson, with John Redmond nominated as Club Administrator. Lion Hornback accepted the changes to his motion, and Lion Hampton accepted the second of the nominations. With no further discussion, the motion was approved. 2023-2024 officers are as follows: President: Craig A. KSP Releases Name Of Fatality On AA Hwy

One man was killed Wednesday morning following a crash involving two pickup trucks and a tractor trailer.

Kentucky State Police said Philip Richard Konopka, 42, of Grayson was killed just after 8 a.m. on Wednesday.

Troopers say a pickup truck was traveling southbound on the AA Highway when it crossed the center lane headed toward a tractor trailer traveling southbound.

Konopka was traveling behind the semi, according to KSP.

The driver of the semi-truck attempted to avoid collision, but the northbound pickup crashed into the side of the tractor trailer, causing the pickup to spin out of control—eventually crashing into Konopka's truck.

The AA was closed for several hours on Wednesday but has since reopened as of 4 p.m.

The driver of the southbound pickup was flown to Cabell-Huntington Hospital and details of their condition are unknown.

The driver of the tractor trailer sustained no injuries.



The meeting was called to order by President Craig Stanfield. Lion Steve Pedersen offered the benediction, who somberly offered blessings for the family of Philip Konopka, recently a fatality in a car accident, who - while not a member - contributed greatly to the Club not only during the annual fair but also helped the Club acquire the Playground Equipment on the fairgrounds. Following the prayer, Lion Charles Kendall led the group in the Pledge of Allegiance. The group then broke for a great meal provided by Skeeter and Sonia Shaw.

After the meal, the business meeting opened. As Secretary Phil Cropper was absent last meeting, Craig read the press release about the last meeting in lieu of the minutes; the press release was accepted as a true and accurate record of the evening events.

No Treasurer's report was provided.

President Stanfield mentioned once again the recent passing of Philip Konopka and his contributions to the Tollesboro Lions Club. He also stated that - for the benefit of those who had not seen first-hand the large gathering of persons present at the Trade Days Event - the great success that was visible by the large number of vendors and the equally impressive number of customers present to purchase items from vendors, this the largest and most successful Trade Days Event that the Club has hosted to date. He also announced (or alternatively reminded the group) of two upcoming events conducted on the Fairgrounds this week:

- 1). A fund-raiser consisting of a lunch available to the public at large offered by the Tollesboro Elementary School Parent-Teacher Organization (PTO), consisting of a meal including either a cheeseburger or pork tenderloin sandwich, cheesy potatoes, baked beans, a drink and dessert for just \$10 available Wednesday, May 10th from 10:30 AM to 1:30 PM. pm.
- 2). A fund-raising lunch and live auction event to be conducted at the Fairgrounds on Saturday May 13th for Kenny Cooley, a former Tollesboro Lions Club member suffering from Stage IV stomach cancer. The lunch will begin at noon; the auction will begin at 1:00 PM.

Treasurer Steve Pedersen made a motion to make a donation to the Kentucky Lions Eye Foundation for a Melvin Jones Fellowship to present posthumously to the family of Philip Konopka in appreciation for all his contributions to the Tollesboro Lions Club. Besides the obvious contributions to the Fair's Livestock Shows, he also assisted in the Floral Hall, and he was instrumental in the Lions Club obtaining the grant for the Playground Equipment

installed on the Fairgrounds in 2018. This motion was quickly seconded and approved unanimously.

Lion Jim Meadows mentioned that it was planned to install the railing approved at the last meeting in front of the stage inside the Pavillion this Friday, this installation prior to the fund-raiser for Kenny Cooley on Saturday.

Lion Jim Meadows also mentioned that the Club needed to sell tickets for the Cow Bingo Event at the Tollesboro Lions Club Fair and needed to start contacting Elite Sponsors for this year's fair.

The Scholarship Committee (Phil Cropper, Denny Hornback, and John Redmond) announced that they had received 6 scholarship applications from students graduating this year from Mason and Lewis County High Schools. The Committee suggested making four scholarship awards of \$400 each rather than three awards for \$500 each; however a member of the Club who wished to remain anonymous offered to donate \$1500 to match the \$1500 offered and budgeted by the Club for a total of \$3,000; thus the Club opted to award all 6 applicants with \$500 scholarship awards. NOTE: There were additional scholarship applications which came in late, with President Stanfield notified that these scholarships were at the Lewis County High School and were intended to be submitted May 9th based upon last year's date of submission and a day AFTER the meeting of the Tollesboro Lions Club in which the scholarship recipients were selected. On this date, May 9th, an additional \$500 was donated by Brenda Tucker specifically for an additional scholarship to be awarded in Memory of Larry Tucker, a 55 year member of the Tollesboro Lions Club, an Educator, Guidance Counselor and Coach as well as member of the Tollesboro Volunteer Fire Department, a Pastor, who also served on the Tollesboro Lions Club Scholarship Committee for decades up until his recent passing November 27, 2022. This will result in an additional Scholarship being awarded. Brenda specifically requested that the Tollesboro Lions Club Scholarship Committee select the student to be the recipient of this additional Scholarship. This is only due to the additional support and donations of an anonymous donor and that of Brenda Tucker in Larry's memory. The Scholarship Committee will meet Wednesday, May 10th for purposes of choosing the 7th recipient.

Being no further business to go before the Club, Tollesboro Lions Club Treasurer and Vice District Governor of District 43-Y Steve Pedersen made a short slide show presentation of Lions Club 43-Y's contributions to Eastern Kentucky following the devastating flooding events of July of last year affecting Breathitt, Floyd, Perry, Knott, Leslie, Pike and Magoffin Counties, and the communities of Hazard, Hindman, Jackson, Neon, Chavies, Pikeville, Whitesburg, Jeremiah and Booneville (including Lions Clubs in the communities of Hazard, Neon, Jackson, Whitesburg and Hindman). Tens of thousands of dollars poured in around the country and through Lions Club District 43-Y including from the Tollesboro Lions Club and Clubs, Schools, Churches, Corporations and Individuals in Lewis County and surrounding counties in the form of cash, gift cards, canned goods and non-perishable foods, coats, hats, gloves, portable heating stoves, tents, socks, Lp gas cylinders, generators,

and more were donated and distributed to those Eastern Kentucky residents made homeless from the devastating floods which destroyed homes, businesses, infrastructure, roadways, railroads, bridges, schools, recreational areas, public buildings, Lions Club structures, courthouses, churches, and so much more. The Tollesboro Lions Club and other entities (Tollesboro Christian Church, Farm Bureau Insurance, Rip's Farm Center, individuals and more) made numerous trips to deliver goods and products to Eastern Kentucky including feeding over 3,700 persons warm dinners over 3 events, including feeding 1,500 persons a Thanksgiving meal. They also assisted in providing 500 boxes each filled with 32 food items to 500 families in Eastern Kentucky and over 1400 coats and 2,000 pairs of socks to Eastern Kentucky residents.

Being no further business to go before the Club, the meeting adjourned.



The following statement will reflect the process that the Tollesboro Lions Club utilized to select 7 local students to receive Scholarship funds from the Club for 2023:

The Tollesboro Lions Club submitted a newspaper article/press release informing the public that the Tollesboro Lions Club was offering graduates intending to further their education the opportunity to apply for our Scholarships. The newspaper article correctly stated that applications were due to be turned in by 5 pm., May 8th, 2023, this date being Monday and coinciding with the night of our Club's first meeting in May. It also indicated that the Scholarship Applications were available for download from the Tollesboro Lions Club website, www.tollesborolions.com (Note: Scholarship Applications downloaded from the website included the statement that applications were due to be turned in by 5 pm., May 8th, 2023. NOTE: This date/time was utilized so that applications would be turned in so that the Scholarship Committee could make the selections that evening, so that schools could be notified of the Tollesboro Lions Club Scholarship Recipients during Graduation and/or Awards Day events).

Six students turned in Scholarship Applications that were available at Monday's meeting (it should be noted that of the 6 applications that were reviewed Monday evening, all had been received at least several days prior to Monday's deadline/meeting, with at least one received 2 or 3 weeks prior and one - from a grandchild of a member of the Tollesboro Lions Club - submitted possibly as early as November of 2022). The Scholarship Committee had selected 3


of the applicants to receive Scholarships, each in the amount of \$500, fulfilling the \$1,500 budgeted sum set aside by the Tollesboro Lions Club for said Scholarships. However when the Scholarship Committee announced to the Club the selections and the number of applications received, a generous ANONYMOUS member of the Club offered to match the budgeted funds in order that all six applicants would receive the full \$500, thus doubling not only the number of students selected to receive Scholarships (6 rather than 3), but also the amount of dollars awarded (\$3,000 rather than \$1,500); this was *significantly* more (number of students as well as total dollars awarded) than the Tollesboro Lions Club had ever given away in the past for Scholarships (over the past 4 years: 2019, five \$300 scholarships were provided; in 2020, three students received \$300 each; in 2021, \$300 each was provided to 3 students, with a 4th student receiving \$150; and in 2022, 4 students were awarded \$400 each). This was approved at the meeting of the Tollesboro Lions Club, thus members of the Tollesboro Lions Club knowing some of the recipients were able to notify some students Monday evening, and some were notified on Tuesday.

On Tuesday afternoon, I (as Club President) was contacted and informed that there were 9 additional scholarship applications that had not been turned in, as they relied upon an application from last year that erroneously stated that the date of last year's application - May 9th - was the date that applications were due (although in all fairness, this application stated that they were due May 9th, <u>2022</u> rather than 2023), a terrible and unfortunate oversight.

We could not go back and take away from those that had already been awarded (whether or not those students had been contacted officially or not), as the generous anonymous donor had donated under the impression that ALL the students who had submitted applications at that time had been approved to receive funds (basically we could not make changes as we had already committed far more than our budgeted funds). However, Brenda Tucker (the widow of a recently deceased member of the Tollesboro Lions Club), opted to provide \$500 to the Tollesboro Lions Club to offer an additional Scholarship, this Scholarship to be awarded in Memory of Larry Tucker. Larry Tucker was a long-time resident of Tollesboro, a former teacher/educator, coach, guidance counselor, pastor, member of the Tollesboro Volunteer Fire Department, a Tollesboro Lions Club Citizen of the Year recipient, a former President of the Tollesboro Lions Club, and a member who served the Tollesboro Lions Club for 55 years (including being a part of the Scholarship Committee for decades). This generous donation permitted the Tollesboro Lions Club to offer one more \$500 Scholarship, thus permitting the Tollesboro Lions Club to offer a total of \$3,500 scholarship funds to 7 area graduates intending to further their education. This last Scholarship would be awarded to ONE of the 9 applicants whose application was received late and, as Brenda Tucker did not want to be involved in the selection process, she suggested that the Scholarship Committee (of which her deceased husband Larry Tucker had been a member for decades) make the selection. THEREFORE, as President, I called the members of the Scholarship Committee together and tasked them with selecting ONE MORE Scholarship recipient. They met at 4 pm. this evening at the Tollesboro Lions Club with the 9 additional applications to review from which to make the selection (I was not present at the Committee meeting and had no part of the decision process).

Ultimately, the Scholarship Committee reported to me that they selected Mary Miller as the recipient of the Larry Tucker Memorial Scholarship from the Tollesboro Lions Club. She

will join the 6 other students chosen to receive Tollesboro Lions Club Scholarships, two of whom were from Mason County High School, the other four from Lewis County High School (these six being chosen Monday evening prior to the receipt of the nine scholarship applications provided today and of whom we were only made aware of Tuesday afternoon. Unfortunately, we cannot change the original recipients as some of them had been informed Monday evening or Tuesday morning AND as the only reason that the Club was provided the additional \$1,500 in Scholarship funds was that a generous donor offered to match the budgeted Scholarship funds permitting us to give to all 6 of the original applicants, thinking that this fulfilled ALL of those students applying for our Scholarship funds). Please note the following: There were 15 Scholarship Applications submitted, from which 7 were chosen to receive Tollesboro Lions Club Scholarships; each scholarship award is in the amount of \$500; the total committed by the Tollesboro Lions Club for Scholarships for 2023 is \$3,500 (of which \$2,000 came from private donations with the Club committing \$1,500 of the total). The full list of Tollesboro Lions Club Scholarship Recipients for 2023 is as follows: From Lewis Co. High School: Jason Parker Evans, Jaden Lewis, Sarah Paige Weddington, Mikayla Kielman and Mary Miller. From Mason County High School: Jaclyn Cropper and Philip Bierly (total recipients: 7; each recipient to receive \$500; total funds awarded \$3,500).

TOLLESBORO LIONS CLUB SECOND MAY MEETING VERY PRODUCTIVE!

The Tollesboro Lions Club met Monday, May 22nd, 2023 at the Tollesboro Lions Club Clubhouse on the grounds of the Tollesboro Lions Club Community Park for their regularly scheduled meeting. Fifteen members were present plus one guest. President Craig Stanfield opened the meeting requesting that Treasurer Steve Pedersen offer the blessing, followed by the Pledge of Allegiance led by Lion Charles Kendall. President Stanfield then introduced guest Natalie Stitt representing the Peoples Bank of Ohio, asking her to lead the group to the wonderful meal provided by Skeeter and Sonia Shaw.

After the meal, Craig invited Natalie Stitt to introduce herself to the group and she made a check presentation for the Club to use to purchase a building to set on the grounds as a First Aid/Lost & Found/General Purpose structure. The building is to be a 14' x 20' structure to be placed rather centrally on the grounds. The Club had agreed to accept the building, to connect it to water, electric, and sewage, and to finish it out (insulate, wallboard, etc.) at one of the April meetings, and to permit placement of a sign on the structure for the Peoples Bank (of Ohio) acknowledging the donation. Natalie joined President Stanfield for a photograph and then she retired from the meeting before the business portion of the meeting began.

President Stanfield then explained to the members present the process involved in the Club's granting of 7 Scholarships for graduating students of Mason and Lewis County High Schools for furthering their education. The Tollesboro Lions Club funded three \$500 Scholarships; one Lions Club member who preferred to remain anonymous provided the funds for three additional \$500 Scholarships; Brenda Tucker also provided \$500 for an additional Scholarship in Memory of Larry Tucker, who served over 50 years in both the Tollesboro Lions Club and the Tollesboro Volunteer Fire Department and who was a teacher, guidance counselor and coach; this made for 7 scholarships for 2023. There was some confusion in the turn-in date of the Scholarships; the newspaper article and the minutes from the last meeting indicated that scholarship applications were due by 5 pm., May 8th (this so that the Scholarship Committee could meet at the regular meeting of the Tollesboro Lions Club to make their selections); this date/time was also on the applications available for download from the Tollesboro Lions Club website, www.tollesborolions.com. At the May 8th meeting, there were only 6 Scholarship applications turned in. Three students were chosen to receive the scholarships funded by the Club. However at that time, a member of the Club who wished to remain anonymous stated that he would like to see all six applicants receive the scholarship and generously agreed to donate \$1500 to do just that; this ensured that all 6 recipients would receive \$500 to further their education. However, the very next day (Tuesday, May 9th) President Stanfield was contacted by the Lewis County High School (after they were notified of the students who had been selected to receive Scholarships the night before) and he was informed that there were 9 additional scholarship applications that were intended to be turned in that evening, these relying on last year's due date and outdated copies of the Scholarship application that indicated that they were due May 9, 2022. The 6 recipients having already been selected and announced, left the Club in a quandary. However Brenda Tucker reached out and contacted President Stanfield to see if it was too late for her to offer funds for an additional scholarship in Larry's memory. Craig accepted her generous offer and it was then decided to accept the 9 applications and to arrange for the Scholarship Committee to meet and choose one more recipient, this recipient to be chosen from the 9 applications that were not received by Monday, May 8th. The Scholarship Committee then met Wednesday late afternoon and chose the 7th recipient, this being from the 9 applications that had not been turned in by May 8th. It was announced that each of the Scholarship recipients, as well as their parents, would be invited to attend the next Lions Club meeting and that the Club would provide dinner for the Scholarship recipients and their families. The 2023 Tollesboro Lions Club Scholarship recipients are Philip Bierly, Jaclyn Cropper (both of these students graduated from Mason County High School), Mikayla Kielman, Sarah Paige Weddington, Jaden Lewis, Jason Parker Evans and Mary Miller (these students graduating from Lewis County High School). President Stanfield and Secretary Cropper offered to contact the recipients and invite them and their parents to attend the next meeting (June 12th, 7 pm). Secretary Cropper then stated that of the Scholarship applicants, several had 4.0 or greater grade point averages. It was also announced that those students having received Tollesboro Lions Club Scholarships were announced at Award Day ceremonies and mentioned in Graduation Programs in both Mason and Lewis County High Schools.

Secretary Phil Cropper, in advance of the rapid approach of Memorial Day, read to the Club "Lincoln's Letter To Mrs. Bixby", a mother who had supposedly lost 5 sons in the Civil War. While the circumstances surrounding this letter (as well as the author) are somewhat controversial/subject to debate, the poignant message was on target and well received.

Next, Treasurer Steve Pedersen presented the Treasurer's Report.

Under Old Business, President Stanfield announced that the Tollesboro PTO Lunch Fund-Raiser May 10th was a success, as was the Kenny Cooley Benefit Auction & Lunch Event of May 13th. The upcoming Trade Days dates (June 15th thru 17th and Sept. 7 thru 9th) were announced. Treasurer Pedersen announced that the concrete berms being purchased for the expansion of the Mud Sling Pit were being picked up and delivered to Brown County Construction for eventual delivery to the Fairgrounds.





Lion Stanfield also informed the group that he had completed the application to submit to Lions International for the Club to be considered for the Club Excellence Award.

Treasurer Steve Pedersen then presented the Club with the Club's Financial Report, noting several commitments that the Club had made to improve the grounds. The Club is in the process of making several improvements to the Fairgrounds. The most visible improvement will be widening the Mud Sling Track. This will require purchase/delivery/ setup of concrete barriers for placement along the side of the Mud Sling Track which will require replacing of electrical requirements (poles, lights, breaker box), movement and replacement of waterlines and replacement of a fire hydrant, and repairs to bleachers that had been damaged by recent heavy winds (two sets of aluminum bleachers had been picked up and turned over by heavy winds several months ago resulting in siignificant damage to the bleachers. This damage included portions of the seating, and near total destruction of top protective rail and handrails. The estimate to repair the damage to the bleachers is \$4,000 and this has been turned in to our insurer).

Other improvements that the Club has committed to: 1). A safety railing to be placed in

the Pavilion to alleviate a trip hazard posed by the raised concrete stage area. 2). Purchase, delivery, and installation of a large fan for the livestock show ring. 3). The building that the Club is committed to purchase with funds provided by the Peoples Bank (of Ohio) — while the funds for this purchase have been provided by the Peoples Bank, these funds are within the monies reported within the Lions Club accounts but which are committed to be spent. In addition to this expenditure, the Club is also committed to funds to finish out the interior of the building being purchased, as well as placement of water and electrical improvements within the building.

Under Old Business, the rapidly approaching fair was discussed, as well as the Fairbook, and Elite Sponsorships (with regards to Elite Sponsorships, tickets were passed out to the members in charge of contacting sponsoring businesses, so that the members selling sponsorships could provide fair passes to these businesses when meeting with the business owners). It was also mentioned that this weekend, the Summer Trade Days Event would be taking place. Still under Old Business, the fan for the Livestock Barn was further discussed (having been brought up initially in the Treasurer's Report as an expense that Club has already committed to complete), with the Treasurer informing those present of a cost estimate AND with recommended size restrictions proposed by the manufacturer, based upon the ceiling height. This fan would need to be ordered as soon as possible in order for it to be installed by Fair time.

First Vice President, Lion Lee Thomas then asked about if anyone had been in touch with anyone to fill-in for Philip Konopka, the Lewis County Extension Agent who had recently been killed in an automobile accident. President Stanfield indicated that he had been contacted by Extension Office agents who plan to jointly assist the Club this year in the Livestock Events and Floral Hall displays to cover until someone has been hired to take Philip's place (this year hits especially hard as the Club has lost Clinton Applegate and Philip Konopka since last year's fair, and these two – along with Mary Shoemaker – were the most visible persons in the Livestock Shows. Craig provided Lee with the phone number of the person who had contacted him and Lee would touch base in the next few days.

The Club had mentioned that the State Highway Department placed warning signs on the "AA" Hwy last year at the approach to the Germantown Fair and they suggested that we contact Highway District 9 to see if they could do something similar during the Tollesboro Lions Club Fair. It was also suggested that the Fiscal Court be contacted to limit traffic (or alternatively permit one-way traffic ONLY) on Lions Club Lane during the Fair, from 6 pm until 10 pm. President Stanfield indicated that he would make the necessary calls to see if these two accommodations could be met.

Lion Zach Tully indicated that a compacting roller would be necessary for the Mud Sling Track to compact dirt placed in the track from the widening.


Lion Stanfield brought up an item suggested by Lion Terrell McCall who could not be present at the meeting, with regards to the ditch line extending through the Fairgrounds. Recent rains coupled with a curving nature to the ditch line had resulted in the exposure of water and gas lines and this needed to be addressed. Lion Zach Tully indicated that he would look it over and make a suggestion at the next meeting as to how to best go about improving this condition.

Lion Lee Thomas also asked about trophies. In the past few years, a number of providers had been providing trophies, and suggested that if one provider was utilized,

significant savings would likely result, by purchasing in bulk. Lion Pedersen also indicated that the cost of trophies and the sizes of some of the trophies had gotten out of line. Lion Stanfield then mentioned that — while not trophies but ribbons — Brenda Tucker had donated a large number of ribbons to the Club that Larry Tucker had purchased in the past, apparently purchasing larger numbers than required in order to save money so that the Club could purchase additional ribbons as needed at a cost savings. Therefore the Club will likely not need any ribbons for several years; it was decided that Lee, Lion Eric Bloomfield, and Lion Pedersen would work to cut down the expenses of trophies and utilize a single provider if that would result in significant savings.

Under New Business, Lion Steve Hampton suggested that the Club invest in an improved sign that could be utilized to inform the public of events conducted each night during the fair. Lion Stanfield indicated that the costs of such a sign was <u>SIGNIFICANT</u>. Treasurer Pedersen stated that such an improvement would offer a huge advantage, but suggested that we wait until after the fair to commit to such an improvement. Lion Stanfield also added that such a sign could not likely be purchased, delivered, and installed prior to Fair time, although he too could see the advantage of such an improvement for promoting events at the fairgrounds year-round, primarily during the fair, but not exclusively to the week of the annual fair.

Being no further business, the meeting adjourned.




TOLLESBORO LIONS CLUB IMPROVES MUD SLING/DEMOLITION DERBY PIT/TRACK

The Tollesboro Lions Club is making significant improvements to the Demolition Derby Track/Mud Sling Pit at the Tollesboro Lions Club Fairgrounds in advance of this year's fair. The improvements are significant and are meant to improve the area for both events, the Mud Sling and the Demolition Derby. Utility lines for electric and water were relocated, then the pit/track was widened, concrete berms/barriers were installed for safety (the Tollesboro Lions Club purchased 140 concrete berm/barriers for placement, which required transport to the Fairgrounds, unloading several tractor-trailer loads, and then placement along the sides of the track/pit), and then a new fence constructed. In addition, two sets of bleachers that had been flipped by recent high winds which resulted in damage to the railings, will be repaired and placed alongside the Demolition Derby Pit/Mud Sling Track for seating for the crowds. Last year, a new elevated announcer's booth was placed on the grounds to serve this area and events, as well as placement of a flagpole, electrified to provide for public address system. These improvements will permit a better event during the fair for the benefit of the crowds. The Tollesboro Lions Clu,b would like to thank David Tully, Zach Tully and Zach Truesdell – as well as Jim Meadows/Rip's Farm Supply, Steve Pedersen/Brown County Construction, all of whom helped ensure that these improvements were put in place.








TOLLESBORO LIONS CLUB FAIRGROUNDS <u>IMPROVEMENTS</u>

The Tollesboro Lions Club recently made improvements to the Fairgrounds that will increase the usable space on the grounds. Forever, a ditch has extended through the Fairgrounds south of the Horse Show Ring and north of the Tug Tractor Pull Track. This ditch had been widened by weather conditions over the years, and recently both gas lines and water lines had been exposed by weather condition erosion. Therefore, the Tollesboro Lions Club decided that the time was right to improve this area, placing a concrete drainage box in the ditch, then installing drainage tile in the ditch, then covering the pipe and backfilling to level the former ditch.





TOLLESBORO LIONS CLUB JUNE 26TH MEETING

The Tollesboro Lions Club met Monday, June 26th at the Tollesboro Lions Club Clubhouse at the Tollesboro Lions Club Fairgrounds at 7 pm. for their regularly scheduled meeting. Lions Club President Craig Stanfield opened the meeting, inviting Lion Steve Pedersen to ask the blessing, followed by Lion Charles Kendall in leading the Pledge of Allegiance, after which the group broke for dinner. Twenty-one members were present. Prior to dinner, a member asked President Stanfield as to when the other Scholarship recipients were to attend to receive their certificates and monies. Craig reported that they were supposed to be present at this meeting, but that 2 had called him regretting not being present due to scheduling conflicts, and that one had contacted Secretary Phil Cropper with the same statement. Craig and Phil had informed the recipients that an informal presentation would be made at their convenience, where photographs would be taken and checks/certificates would be presented.

Following dinner, Secretary Phil Cropper presented the minutes from the June 12th meeting, which were accepted as read. No Treasurer's report was presented. Under Old Business, President Stanfield announced that Zach Tully, David Tully, and Zach Truesdell, with assistance Jim Meadows/Rip's Farm Center and Steve Pedersen/Brown County Construction, had made significant improvements to the Mud Sling/Demolition Derby Track. They had also placed drainage tile in the ditch between the Horse Show Ring and the Tug Tractor Pull Track that covered up exposed electric and gas lines, and made for a level area that will be functional for parking and/or other uses.

President Stanfield reported that the building for which Peoples Bank of Ohio had provided payment for, had been ordered and may be delivered prior to Fair time (however not in time for the Club to improve with electric and water, or to insulate and wallboard prior to Fair time). This building is planned for utilization as a Lost & Found, First Aid, and Auxilliary Use building. It was also discussed as to where to place the building on the Fairgrounds. It was decided that the most ideal place would be north of the restroom facility.

Members were reminded to sell Cow Bingo tickets, Elite Sponsorships, and to check over the Fair Catalog before leaving the meeting, so that any changes could be made. It was also announced that Elite Sponsors needed to be contacted prior to July 7th for confirmation as to their participation this year, in order to be placed on the banners to be installed on the grounds during the Fair.

Under Old Business, President Stanfield announced that he had been in touch with: 1). District 9 Division of Highways for placement of lighted safety signage during the fair and that they would accommodate the request. 2). Lewis County District Court for permission to close Lions Club Lane to one-way traffic from 6 pm. until 10 pm during the Fair. This request will be considered at a Special Meeting of the Fiscal Court Friday, June 30th.

Lion Lee Thomas reported that two large 10' fans had been purchased for placement in the Livestock Show Barn.

Lion Steve Pedersen commented on the success of the Summer Trade Days Event June 15th through 17th. The event had a large number of vendors and customers due to very good weather conditions, with some vendors even staying an extra day (Sunday, June 18th).

Lion Pedersen reported that two sets of bleachers - which had been picked up and turned over by heavy winds recently resulting in \$4000 in damage to the railings - had been turned in to the insurance agency and that they had provided a \$3,000 payment for repairs (the Club had to pay a \$1000 deductible). The bleachers should be repaired prior to Fair time in order to be utilized next to the Mud Sling/Demolition Derby Track.

Lion Pedersen suggested that each member work the gate at least one night during the Fair. Lion Phil Cropper and Lion Daymond Thomas volunteered to create a spreadsheet with the number of gates open each night, the location of each gate opened, and a sign-in sheet for members to sign up to work the gate during the Fair. This sign-in sheet would be presented at the next meeting of the Tollesboro Lions Club (July 10th).

Lion Eric Bloomfield brought up trophies for events during the Fair. Last year, trophy expenditures had gotten out of hand, so an effort is being made to have one person provide trophies, thus ensuring consistency and efficiency of cost. Members in charge of events were encouraged to provide Eric a list of trophies needed.

Under New Business, the Tollesboro Lions Club plans to once again install US flags throughout town as they had last year. It had been considered for placement that evening after the meeting, however as it rained during the meeting, it was decided to wait a day or so.

Also under New Business, Lion Pedersen announced that Lion Tyler Liles had purchased a snow cone machine and would like to set up during the Fair. This would not conflict with any other food vendor. A motion was made by Lion Pedersen, seconded by Lion Charles Kendall, to permit Tyler to set up during the Fair, and at no cost, as a member benefit. Motion carried.

Being no further business, the meeting adjourned.


