REGULAR MONTHLY MEETING  
MINUTES OF DECEMBER 11, 2018

Reimink moved, Gooding supported acceptance of the Agenda of December 11, 2018 as presented with addition of 12. D PA 116 Application. Motion carried.

Hutchins moved and Reimink supported approval of the regular meeting minutes of November 13, 2018 with corrections. Motion carried.

Reimink moved, Hutchins supported to approve payment of the bills, as amended, dated December 11, 2018 as presented from the following funds: General Fund- \$22533.28; Fire Fund- \$8858.71; First Responder Fund- \$1882.30; Ambulance Fund- \$1240.39. Motion carried.

Hebert moved and Hutchins supported to send 2 First Responders for training. Motion carried.

Hebert moved and Gooding supported spending Approx. \$1400 on shirts for the Fire Dept. Motion carried.

Matt Zawila, Asst. Fire Chief, reported.

Hutchins moved, Hebert supported Approx. \$4500 for tire upgrade on fire trucks. Motion carried.

Reimink moved and Gooding supported application from Mat Korman for Ganges Fire Dept. Motion carried.

A.J. Broe, Cemetery Sexton, reported 1 burial for the month. Also, looking into getting new signs for each of the cemeteries.

Hebert moved and Gooding supported to accept price increase of grave openings and to establish new rates as: Weekdays- \$370.00 and Saturday- \$517.50. Motion carried.

Barry Gooding reported Planning Commission will not have a December meeting.

#### Unfinished Business

Hebert made a motion to re-appoint Jim Leow to the Board of Review. Seconded by Hutchins. Term ending 12/20/2020. Motion carried.

#### New Business

Hebert moved to adopt Prohibition of Marihuana Establishment Ordinance. Seconded by Hutchins. After a roll call vote: Hutchins, Reimink, Hebert, Phelps, Gooding- Yes. Motion carried.

Hebert moved to go along with 2019 Gravel Program. Seconded by Reimink. Motion carried.

Reimink moved that we approve application for PA 116. Hutchins supported. Motion carried.
