

**SWIMMING POOL RULES FOR
FOX MEADOWS HOMEOWNERS ASSOCIATION, INC.

1. Every time you enter the pool you must show your current year pool pass. The swimming pool is for the exclusive use of the FOX MEADOWS HOA members in good standing and their guests. Only persons with valid pool passes will be permitted to use the pool and the adjoining facilities. Guest pool passes have 10 punches per pass, additional passes cost \$20.00. The host member must accompany guests at all times guests are at the pool. The conduct of the guests is the responsibility of the member.
2. Take your pool passes with you when you leave the pool area, as the HOA is not responsible for lost or stolen pool passes. New passes cost \$5.00 each.
3. The swimming pool hours are posted at the clubhouse. Persons found inside the pool enclosure when the pool is closed may lose their pool privileges at the discretion of the Board and prosecuted for trespassing.
4. Fox Meadows HOA members in good standing and 21 years of age or older may apply to the Board or authorized committee for before or after-hour use of the pool on a first-come basis. A pool rental application needs to be submitted at least two (2) weeks in advance of the event.
5. During regular hours of pool operation, certified lifeguards under the employ of the HOA's contracted pool management company, Millennium Pools, represent the Association. The lifeguard on duty is in charge of the pool with full authority to enforce these rules and take whatever action is needed to maintain a safe and healthy environment and to eject those non-compliant with these rules.
6. Pool safety is a paramount concern for the Association and its members. All persons using the pool do so at their own risk and agree to abide by these rules for the use of the facility. The Association assumes no responsibility for an accident or injury in connection with the use of or for any loss or damage to personal property.
7. Responsible person 16 years or older must accompany children under the age of 12 years at all times.
8. All swimmers should take a brief shower before entering the pool and wear proper swim attire as not to endanger swimmer or cause damage to pool equipment. Swimmers may briefly use the shower upon exiting the pool. Other uses of the shower are prohibited.
9. Persons with impaired health (colds, lesions, rashes, open sores or cuts, etc.) will not be allowed in the pool.
10. Food and non-alcoholic beverages may be consumed on the deck area surrounding the pool.
11. Intoxicants, alcoholic beverages, or drugs are not allowed in the pool at any time. Those under the influence of intoxicants are not allowed to be in the pool at any time.
12. Breakable objects, especially glass containers are not permitted in the pool area at any time, as well as small toys or objects that may get sucked into pool equipment and cause operation problems.
13. Swimmers must wear proper pool bathing attire to be allowed to swim in the pool.
14. Diaper-aged children must wear a swimsuit and swim diapers to insure that the pool does not become contaminated. Contamination of the pool will result in pool being shut down for health reasons until lifeguard deems it safe to use and may result in pool privileges being suspended by those who do not take proper precautions with their children.
15. Persons must stay clear of lifeguard stations at all times.
16. No play equipment, wheeled vehicles (except wheelchairs & strollers) are permitted in the pool area.
17. No pets (except for Service dogs with owner) are allowed in the pool area.
18. Persons unable to demonstrate an ability to swim, at the lifeguard's discretion, will not be permitted in the deep end.
19. Tubing, rafts, balls and other flotation devices are allowed in the pool at the discretion of the lifeguard and this may change depending on the crowd or condition that exists at any particular time.

20. Dangerous or improper conduct is prohibited. Running, pushing, wrestling, spitting, dunking, standing/sitting on shoulder, and foul/abusive language will not be tolerated. This conduct will lead to loss of or suspended pool privileges.
21. There will be a 15-minute rest period for children every hour. During this period, children must be completely out of the water to allow adults 18 years of age or older to swim.
22. Adults or responsible party must accompany Children under the age of 10 in the wading area of the pool. Accompany can be either physically inside the wading pool area or on the pool deck directly surround the wading pool area.
23. No radios are permitted in the pool area except those with ear phones played at a volume that does not disturb others.
24. Violation of the Swimming Pool rules will result in suspension or revocation of pool privileges.
25. These pool rules change according to the final pool rules adopted by the Board from time to time.
