Award Criteria:

<u>Public Official of the Year</u> - Presented to a non-elected professional administrator who has consistently demonstrated excellence in public management over a sustained period of time.

<u>Community Service</u> - Presented to an individual or organization for sustained leadership in addressing public policy issues or improving life in the Sacramento region.

<u>Government Innovation</u> - Presented to an individual or organization that has implemented a new program, policy, or solution that has made a significant improvement in public service delivery or performance.

<u>Intergovernmental Cooperation</u> - Presented to an individual or organization that has developed and delivered a program or policy between different levels of government resulting in greater effectiveness.

<u>Academic Excellence</u> - Presented to a local college student, teacher, administrator, or organization that has demonstrated scholarship and leadership in public administration or a

closely related field of study, or that has made a noteworthy contribution to the education of public administrators.

<u>Rising Star</u> - Presented to a public professional, teacher, or researcher thirty-five years of age or younger who has made significant contributions to good government in the Sacramento region.

<u>Lifetime Distinguished Public Service</u> - Presented to an individual for especially meritorious service to the field of public administration over the course of a lifetime.
