Retired ASI Forester Recognized

When Larry Gnewikow retired as fulltime manager of the Amana Society Forestry last year, the humble West Amana resident would not have anticipated that his fellow foresters in the state of Iowa would seek to honor him as they have.

Last week the longtime Amana Society staff member received the Frudden Award from the Iowa Chapter of the Society of American Foresters. The award, established in 1960 by the Frudden family of western Iowa, is given to honor those individuals who have greatly contributed to positively impact Iowa forests through sound resource management, use of best practices and the education of the public. The award was presented at a recent meeting of the group

Also last fall Gnewikow was presented the Delmar Wetjen Award by the Iowa County Soil and Water District for 35 years of dedicated conservation effort.

In addition to developing and implementing long term forestry management policies and practices here in the Amana Society forests, Gnewikow has been part of major water and soil conservation efforts here, helped to establish and maintain our wetlands, worked with the Iowa DNR trumpeter swan repopulation program and other DNR programs for the reestablishment of native Iowa species including the wild turkey. Gnewikow has been recognized for his willingness to work with and train Iowa State University forestry students and his cooperation and assistance to the federal and state forestry divisions in education and research.

Passionate about conservation, recreation and education, Gnewikow was a longtime Boy Scout leader, a member of the Amana Colonies Trails Board and the ASI Conservation Committee. His service has helped to make both the Tannenbaum Forest and the Homestead Nature Trail possible.

Share the Love: LOVE Network Gift Tree Going Up Nov. 20

In Iowa County over 120 families and individuals have been referred thus far to the Iowa County LOVE Network, a nonprofit group of volunteers here in Iowa County arranging for Christmas gifts to be distributed to people in need.

Carmen Grimm, our local Amana coordinator for the LOVE Network, will be setting up the LOVE Network tree November 20 in the Amana Family Practice Clinic lobby, just as has been done for the past two decades.

Then you can stop by and pick a "gift tag" off of the tree. Each gift tag has information on it to help you buy a gift for the anonymous recipient to help brighten their holiday. Wrap the gift, attach the gift card securely to the gift and return it to the LOVE Network Tree in the clinic by December 14. Then all the gifts will be collected and distributed to families and persons throughout the county.

Again this year trees will be going up in Marengo, Williamsburg, North English and Victor.

Referrals for the gift tree are received from social services, schools and nursing homes.

The LOVE Network of Iowa County has been doing this Christmas service for nearly 40 years. In addition the network works with larger companies to encourage their employees to collect new or lightly used toys, mittens, hats, coats, socks, boots, blankets and food. These are added to the wrapped gifts collected and distributed as needed.

This is a confidential service and all gifts and all recipients are anonymous.
