## Call to Order

As outlined in the July 3, 2014 Amendment to the ByLaws, the presence of 10% of the membership shall constitute quorum. If, however, quorum is not present, the members present and entitled to vote thereat, shall have the power to adjourn the meeting, without notice until a quorum shall be present. With respect to the act of electing a director or directors, the meeting shall be reconvened immediately following its adjournment and the persons in attendance in person, by proxy or by absentee or electronic ballot at the reconvened meeting shall constitute quorum sufficient to elect directors.
