ACTION TAKEN:

## 23 FULL OR HALF SURVEILLANCE MIRRORS WERE OBTAINED AND INSTALLED

THE SIX SHOWERS IN THE CELL BLOCKS WERE FOUND TO BE NON-COMPLIANT WITH PREA STANDARDS.

ACTION TAKEN:

SIX SHOWER STALLS HAVE BEEN COMPLETELY REFABRICATED TO ADDRESS AND COMPLY WITH THE PREA STANDARDS.
