He served as a judicial clerk to Justice Joseph Grodin of the California Supreme Court, and practiced law at two California law firms. Mr. Feuer is currently our twice-elected LA City Attorney and a 30-year award-winning public servant. He is the only mayoral candidate who has been elected to a citywide office. He began his career in public service as the Executive Director of Bet Tzedek, a non-profit law firm providing free legal services to Angelenos. The Los Angeles Daily Journal described him as having transformed Bet Tzedek into a "national success story".

As a prior City Councilmember for Sherman Oaks in then Council District 5, Mr. Feuer chaired the Budget and Finance Committee, delivering balanced multi-billion-dollar budgets while protecting funds for public safety, meals and transportation for seniors, jobs for disadvantaged youth, and other essential services in LA. As a former State Assemblymember and current City Attorney, Mr. Feuer has taken on big banks, big polluters, and the National Rifle Association (NRA) – and won. MONORAIL IS VIABLE AND AFFORDABLE SEPULVEDA PASS ALTERNATIVE

Metro is studying six rapid transit alternatives for the Sepulveda Pass – three monorails and three heavy rail trains. Some organizations won't support or, even worse, have rejected monorail, such as UCLA. SOHA's Bob Anderson wonders why because the monorail alternatives are the only ones that could be built within Metro's available budget on reasonable schedules. But many people have fallen prey to the misinformation campaign against monorail and Metro has done nothing to correct the resulting misconceptions about this viable technology. Monorails are proven and safe with more than 200 miles of urban monorail worldwide and almost that many more miles in construction. The monorail through the Pass has more capacity than the heavy rail trains under the Pass. What's not to like. Monorails deserve a fair chance but are not getting it from Metro, UCLA, and many in the public.

The heavy rail train alternatives all travel under the Pass in huge tunnels with routes that Metro never discussed with the Sherman Oaks and Bel Air communities they travel under. SOHA asked Metro how they chose the tunnel routes and they never responded. One of the heavy rail alternatives even becomes a noisy above-ground train above Sepulveda Boulevard in the Valley. This is called Metro Alternative 4 or, as we call it, the Horrible Halfway – a subway under the Westside but five miles of unfair noisy elevated trains in the Valley. This is a ridiculous alternative that should never have been studied in the first place. Metro must terminate it.

The remaining two heavy rail alternatives might be viable with different routes that don't travel under residential communities. But what will kill all Metro's heavy rail alternatives in the end is their high costs and unpredictably long schedules. Heavy rail subways cost two or three times as much as Metro has available and tunneling under the Pass will take two or three times as long as building a monorail above the 405 freeway. And don't forget that Metro has never built anything without huge cost overruns and schedule delays. We need rapid transit through the Pass now – not in 2040 or beyond.

SOHA has been working closely with our neighbors in Bel Air. Here is an opinion from Fred Rosen, a concerned Board Member of the Bel Air Association who has had interactions with Metro and UCLA. This says it all.

"I always thought that solutions that were the most expedient, fiscally responsible were ones the that should be implemented. UCLA and Metro advocating for a tunnel under a residential community does not come close to reaching that solution. It's fiscally irresponsible – it will cost more than \$20 billion – which Metro does not currently have the funds for – and will not be completed for 25 to 30 years – assuming the litigation that will certainly occur does not prevail. Not to mention – Angelino's do not like riding underground and the project will be obsolete before its completed – if ever. Everyone who advocates for a tunnel as a solution, in my opinion, is severely uninformed and just a fool."

HOW RHNA FAILED TO PRODUCE AFFORDABLE HOUSING

Sacramento says we have a housing crisis and California needs 3.5 million more homes. The Biden Administration recently stated that the entire nation needs 3.8 million more homes. Is California trying to house the entire nation? Many experts feel that 1.5 million housing units are much more accurate for California.

The state's housing numbers are a quota called the Regional Housing Needs Allocation (RHNA, pronounced ree-nah). The state assigns the total quota proportionally to cities and counties to be built over an eight-year cycle including required allocations for very low-income, low-income, moderate-income, and above-moderate-income (market-rate) housing. Cities must identify housing sites (called the Housing Element) to meet their RHNA goals and apply for state approval. Since the state demands more housing, many multi-family housing sites will be in single-family neighborhoods.

Cities must rely on for-profit developers to build this housing – the state no longer gives cities any money to fund housing themselves. Developers build market-rate housing because it's more profitable. They need incentives (density bonuses) to build affordable housing. These incentives allow them more market-rate housing if they include some affordable units.

The RHNA system doesn't work because it sets a false housing goal that cities can't meet. As a result, the state rejected 97 percent of all cities' housing proposals including LA's. An independent audit of RHNA conducted in March found that faulty and inaccurate data was often used to calculate RHNA. Yet, the state still holds cities to its RHNA numbers and decided to penalize cities that don't meet state goals.

In fact, to build the required amount of low- and very-low-income housing required by RHNA, developers would need to build five times the required market-rate housing to be profitable. Even that doesn't guarantee we get all the affordable housing we need. Next month, we'll discuss reasons why we have an affordable housing crisis.

SWEET BUTTER CAFÉ – A LABOR OF LOVE



In 2009, Leslie Danelian wanted to bring life back into Sherman Oaks, where many businesses had shut down during the recession. Inspired by recipes from her own childhood, she opened Sweet Butter Café with an inviting atmosphere and comfort-ing menu.

Although Danelian passed away six years ago, her son Andrew Smith has taken over the family business – "just a one-minute walk from the home I grew up in" he says. "Our family has lived in this community for 35 years and seeing it grow and prosper is a beautiful thing."

In addition to their "Sweet Butter Scramble", Danelian's signature eggs cooked with lime tortilla chips, and other favorites such as "Mia's Breakfast" which includes pancakes, eggs, and applewood smoked bacon, Sweet Butter offers a range of healthy salads and other brunch items. And, although Sweet Butter gets busiest on the weekends between 11:00 am and 2:00 pm, Smith doesn't want you to forget dinner, when customers can order homemade classics such as spaghetti and meatballs, roast chicken, or barbecue pork ribs. He also says, "the outdoor courtyard is magical" and it will reopen soon after being closed due to COVID safety protocols.

In addition to the range of menu items in size, genre, and indulgence, there is a grab-and-go selection as well as a coffee bar and marketplace for books and last-minute gifts.

"We value coziness – that feeling you get when you're at home," says Smith. "We value community and being a place where friends and neighbors can gather, enjoy food with good company, and through that grow closer together."

"My mother loved making people happy through food," he says. "I'm lucky to be able to carry on what she started, and to have a place that feels so much like her."

I loved their fried chicken, and their shrimp appetizer was amazing among so many other tasty dishes. Yet, in its place will be a new restaurant from the owners of Taisho which is right across the street in the old Cafe Bisou location. Sorry to see Pearl District go, but happy about this new restaurant and expect it to be as special as Taisho. On a completely different note ... They also have an amazing smoked whitefish salad with cream cheese, salted cucumber, red onion, and dill or just a crispy fried egg with spicy maple glazed bacon, sharp cheddar, tomato, and aioli. Whatever you choose here you will not be disappointed. A few times we have found that sometimes there is line to wait, but it's worth it.

It did sadden me to learn that Josephine's on Ventura in Sherman Oaks has closed. It was such a beautiful bakery with wonderful baked goods and beautiful specialty items like tea pots and mugs. It was nice to meet a friend down there for an afternoon tea and a small bite. This shop opened about a year ago and now it is now gone.

There's also a wonderful new restaurant in Sherman Oaks at 13355 Ventura Boulevard called Malama Pono – a Hawaiian restaurant. Our friends Marcie and Stu had been raving about it, so last week after my wife and I returned from our trip to the big island we thought it was the perfect time to try this new gastronomic addition to our community. We were not disappointed. The food was delicious, the owners and staff were wonderful, and the atmosphere is beautiful. Many unusual dishes to try and everything was great! We're definitely going back! My wife even tried the crispy rice cakes with fried spam! And loved it! Go figure!
