Running Order and Class Information

Driving Directions:

Heading South from Portland on I-5

Take EXIT 282A (Canby/Hubbard) and go 1.6 miles. Turn Left at stoplight-Arndt Rd. Go 1.9 miles and you will come to a Y in the road, stay left. You will now be on Knights Bridge Rd. Go 2.1 miles and take a Right on Grant St. (Stop sign)

Then take a left on 4th Ave. 4th Ave. takes you directly to the Fairgrounds which will be on your left.

Heading South from Portland on I-205

Take EXIT 9 (Oregon City). Turn Left at the stop light onto Hwy 99E. Follow Hwy 99E for 10 miles South into Canby. Fairgrounds will be on your Right as you enter Canby. Turn Right at the stoplight for Pine Street (You will see the Fairgrounds Sign)

Heading North from Salem on I-5

Take EXIT 278 (Aurora/Donald) and turn right onto Ehlen Rd. Follow Ehlen Rd. into Aurora to Hwy 99E. Take a Left onto Hwy 99E. Go through Canby and take a Left into Fairgrounds at Pine St. (Stoplight) (You will see the Fairgrounds Sign)

Class Schedule:

Check in time will begin at 8:00am with the first class starting promptly at 9:00am each day. This will be a 2 judge trial. There will be a single timed walkthrough for each class, with split walkthroughs for the Excellent/Master classes as shown in the chart on the next page.

Trial Information: Trial statistics and other pertinent information are posted at www.k-9sports.com.

Move-ups: The deadline for move-up is Monday, May 29, 2017 at 6:00 pm. Move-ups must be submitted in writing or email. Day-to-Day move-ups are accepted for Saturday & Sunday and must be received by ½ hour after the trial ends each day.

Measurements: If you do not have a valid height card, you will need to have your dog measured. Two measuring officials are scheduled to be at the show so you can get your permanent card. If you have a dog that is in the 24-26" class and you don't have a temporary or permanent height card, you will need to have your dog measured.

Parking: Parking will be on the paved parking areas around the arena building. No parking of vehicles out on the grass except for RV Parking.

Head West on SW 4th Ave. to Birch St., Turn right onto Birch St. Turn left onto OR99E follow for 3.3 mi. Turn right onto Liberty St. NE. Continue straight onto 1st St. NE. Cont onto Main St NE. Continue onto Ehlen Rd NE. Turn right onto Hubbard Cutoff Rd. NE, continue for 3 mi. Take ramp onto I5 North. Take exit 289 to Tualatin/Sherwood. Turn right onto SW Nyberg St. Continue on SW 65th. Hospital is on the left.

Crating:

This is an outdoor trial on grass. You will be allowed to set up your crating space after 4:00 pm on Thursday, June 1, 2017. Plan on bringing a tent for shade as the shade tree space is limited.

Camping:

Camping is first come first serve. There are spots available along the fence in the grass field area as well as under the trees near the horse arena. If you haven't yet paid, you can pay at the Secretary table when you arrive.

Volunteers: We'll be using the white board system for volunteer sign-ups. Please help out where you can and check with the chief ring steward to sign up. Workers will receive raffle tickets to use for the Worker Raffle items. Drawings will be done daily.

Food:

There will be a food vendor on site.

We're going GREEN! Workers, please bring your own (BYO) sports bottle, drinking glass, coffee cup, travel mug or other drinking container. Purified drinking water will be provided near the score table. The water will be in Igloo containers.

B MATCH

Thirty minutes after the trial ends on Saturday, there will be a B match. A B Match runs exactly like a show, but with no scoring. You may use toys and you can train in the ring. There will be a time limit per run of 90 seconds. The cost is \$5.00 per run. You must fill out an entry form and entries will be taken day of show. The dog does not have to be entered in the show to run in the match.
