

### DIRECTIONS TO SHOW SITE

#### From I-5 North or South: Exit #199 at Marysville

Go East on SR 528 (also 4thSt)

Turn left (North) onto SR 9, follow below:

#### From SR 522 in Woodinville

Exit onto SR 9 (North) Snohomish/Arlington Exit

Continue approx. 20 miles, follow below:

#### From Hwy 9 northbound:

Turn right (East) onto 84th St NE (0.6) [Old Getchell Rd]

Turn left (North) onto 99th Ave NE (0.6)

About ½ mi, turn left into CC Kennels, look for orange reflective triangle high on post & A-board sign. Long driveway to parking.

### **MVDTC Offers the following Trial Awards for Each Trial**

#### **Obedience**

▪ Rosette, toy, & tug leash or treat jar for Highest Scoring dog in each trial.

▪ Rosette & travel bag or travel mat for the highest combined score in Open B & Utility A or B, for each trial.

▪ All class placements: Rosette for all placements & a toy for 1<sup>st</sup> place

▪ All classes: Ribbon to all Qualifiers.

▪ High Scoring Junior Handler: Leash & toy

#### **Rally**

▪ All Rally class Placements: Ribbon for all placements & toy for 1<sup>st</sup> place.

▪ All Rally classes: Ribbon to all Qualifiers

▪ High scoring dog in Rally in each trial: Rosette, toy, and tug leash or a treat jar.

### **Venue Information**

▪ **Building:** Country Classic Kennels, Arlington, WA. Indoors and fully matted.

▪ **Hospitality:** Lunch for exhibitors will be available both days for a monetary donation

▪ **Vendor Booths:** due to the space limitations, MVDTC will not be providing vendor booth space at this trial.

▪ **Indoor crating space** will be limited on Sunday due to the size of the Rally ring.

You may need to crate in your car or outside. There is no shelter provided for outside crating—you may bring your own to set up outside. Dogs must be on leash or crated when not exhibited.

### **Entry Information and Policies**

▪ Pre-entry closing date is Monday January 20, 2018 at **10:00pm**.

▪ Obedience classes are limited to a total of 55 dogs per day.

▪ Rally entries are limited to a total of 125 dogs per day.

▪ Day of trial entries will be accepted only if the trial is not filled. Check with Trial Secretary after the closing date.

### **Entry Fees (checks payable to MVDTC)**

**Pre-Entry** \$20 per class *per trial* for regular classes (OB and Rally)

\$10 per class *per trial* for non-regular classes

\$10 *Discounted Jr. Handler Entry Fee (OB and Rally)*

**Day-of-Trial** \$25 per class *per trial* for regular classes (OB and Rally)

\$10 per class *per trial* for non-regular classes

\$15 *Discounted Jr. Handler Entry Fee (OB and Rally)*

### **Other Entry Information**

▪ **Entry forms:** MVDTC reserves the right to return incomplete or incorrectly filled out entries, or entries with insufficient funds.

▪ **Registration #s:** U.K.C. rules prohibit the acceptance of entries with "pending" or missing registration numbers.

▪ **Jump Height:** please remember to include dog's height on entry form for both Obedience and Rally. Also be sure to note whether your dog is a veteran (eligible for reduced jump height), and Junior Handler status.

▪ **Refunds:** exhibitors who withdraw from the trial, in writing, prior to the closing date will be refunded their entry fee, minus a \$5 processing fee, per entry.

Refunds are not given for entry cancellations after the closing date, except for bitches in season, as allowed below.

▪ **Bitches in season** may not compete. Entry fees for bitches that come into season after the closing date will be refunded, minus a \$5 processing fee.

These cancellations must be made prior to the start of the trial, and a veterinarian certificate must be provided to verify that the dog is in heat.

▪ **Move-ups:** Rally exhibitors may move up to the next class for Trial 2 after finishing a title. Move-ups for Rally Trial 2 must be presented to the Trial Secretary no later than the completion of Trial 1.

▪ **Liability:** Neither MVDTC, Country Classic Kennels, nor the United Kennel Club, Inc. is responsible for theft, loss, accident, or injury to any dog, person, or property at any of its events. Absolutely no alcoholic beverages or drugs are allowed. Aggressive behavior by dogs shall not be tolerated at U.K.C. events. Due to space limitations, MVDTC reserves the right to ask that non-entered dogs be removed from the show site.
