BOARD NOTES

DREAMS DO COME TRUE!

One day during this past State Fair, a gentleman approached a couple of workers and asked if the organization would like a building, after realizing that he was not a nut, or joking, said "sure". Things were put in motion and happened quickly. Pres. Casebolt, along with a few other members went to look the building over, taking an enormous amount of pictures. It was determined that the building would suit our needs. So, Mr. Sam Fudenberg, our Property Search chair was notified. Sam got things rolling as far as meeting with the donor several times and hearing more specifics. The BOD has had several meetings involving this donation, and some of the Board members have visited the site. There are several stipulations that accompany this donation, below are just a couple:

- a. The MTP will lease the property for up to three years or less, for a cost of \$1.00 per year, after the lease is up, we will purchase the building and property (2.04 Acres) for a cost of \$1.00.
- b. The MTP will provide lawn care to the adjoining cemetery during the lease period,
- c. The MTP will abide by Covenants laid **out by St. Joseph's Catholic Church of Lexington.**

Full details of the donation of this property and building will be discussed in length with any interested members.

The donor is William J. Benzick, a local businessman in Roseville. The building is located in LeCenter, MN. It is approximately 5200 square feet, climate controlled with room to set up a display and room to work on our portraits. This building and property have an estimated value of between \$250,000 - \$300,000. ***Hard to pass up!***

This is, as everyone knows, **will be the MTP's first permanent building, initially it will be a** place for us to prepare our portraits for digitizing and eventually displaying once again. They have not been publicly displayed since 1971.

The local community members thus far have shown great enthusiasm towards our being in the area. We have already been invited to attend a couple of community events involving historical themes.

This donation comes at a time in which the organization faces some necessary decisions, one being the fact that we will soon be losing our current portrait storage space, perhaps as soon as 31 Dec 2011. We have sought alternate storage and the costs are very high, Approx. \$14,000 – \$18,000 per year. In addition, our status at the Minnesota State Fair is questionable.

We will be taking possession and start moving in around 01 Nov 2011. With this comes an increased cost of having a building. Any donations are appreciated. At this time, we will be keeping the main headquarters in the office at Associated Bank building in St. Paul. Please contact us if you have questions, we will do our best to answer them. *At some point in time, we will invite anyone interested, to come and visit the building.*

Scott County Trail Blazers

Interesting facts of Pioneers Settlers Sketched Briefly

The town of Helena lies on the southern border of Scott County and embraces congressional township 113, range 23. It was settled by Germans principally from the Rhine province. William Nachbar was the first settler. He built the first house on section 5, in November 1854. After him, Jacob and Joseph Schwingler located on section 8. They were followed the next year by Jacob and Sabastian Bauer, Anthon Clows, John Gelchter, John Smits, Valentine Orth, Adam Pfeifer and Joseph Fromm. Vingenz Slawick settled on section 4 in 1854(?). In 1856, among the settlers was Dr. John Landenberger. He established the first store in town on section 29 in 1855. John C. Smith settled on section 11 in March 1855, where he built a house and store. The next year, he had his claim laid out in town lots and named the village Helena.

In the spring of 1856, a meeting was held at the home of William Nachbar to take measures toward erecting a Catholic church. The first religious services were held the following spring at the home of Nicholas Leonard by Rev. Father Weninger. Near this place, a log church was erected that year but was never completed, and a few years later St. Benedictus Catholic church was built about one mile east of the original church site on section 17. The church there in 1867 was a frame building. It was commodious and had a good bell. Rev. Father Cassimierus Hueppe, O.S.F. was the pastor.

September 16, 1855, Anna K. Daughter of William Nachbar was born. This was the first birth in the town.

She stated that Jerry Hammer and Jim Sinclair had made this decision already. We had no knowledge of any of this. It certainly did not start my Fair out right. We contacted Jerry Hammer after the Fair and as of this newsletter, have not heard back from him. The Log Cabin and our organization have been on the same site since 1897! We built the original log cabin there in 1900-1901 and the current cabin was moved there in 1958. Curator's Corner

Fall is in the air, and that means that the Holiday Party is just around the corner. Time to get ready for the Holiday Season! Since the last newsletter, time has been going by too fast.

Over the last couple of months, I have been promoting the MTP at Rendezvous' throughout the state. In September, I was in Aitkin, MN; it was cold and rainy the entire time. I gave out some of our brochures and applications to those who attended. September 16th – 18th, we were at the Elk River Rendezvous, and talked about Minnesota History and the MTP. October 13th – 16th I was at Winona, MN, and talked with school kids from both Minnesota and Wisconsin. Norma and Doug Mackey, and I talked about the region, the MTP pioneers that settled in the area and what life was like in the early history **of the "Upper Mississippi River" land**. We had a great time at each of these events.

During the Fair, the MTP was told that we might not be at this location for next year. The rumors are that the Fair may be relocating the cabin to Heritage Square. However, we have only heard these plans as rumors. The MTP has been at the same location on the Fairgrounds since 1897. We are trying to fight this relocation. Because we are unsure of the situation, we are planning for the worst therefore the artifacts and antiquities at the cabin are being packed and stored, in case of a move. Quite an undertaking. Mary C and I have packed up many of the items, but still have more to go. We are looking for totes to store these items. – NO, we need uniform totes, versus any someone might send our way.

With the new donated building, it will give us a chance to relocate the Portrait Project and start working on them again. The final agreement details still have to be worked out. In addition, it will give us a place to store and display many of the artifacts and antiquities in the collection. We plan to make this new building a museum.

I have received a number of donation offers and will be contacting them soon. Joseph Byrne of Brooklyn Center, MN has donated eight **books "French – Canadian Families of the North Central States", and "A Genealogical Dictionary"**. Thank you for your donation and these will be an asset to the library.

TIDBITS OF HISTORY *"Repeat Vows after 67 years"*

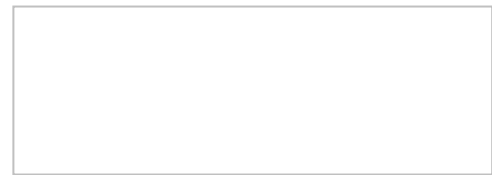
Featuring **Thursday afternoon's program of the Territorial Pioneers at the MN State Fair** was the remarriage of Mr. and Mrs. Thomas Skeffington, formerly of Northfield but now residing at 3926 Blaisdell Ave S. Mpls. They had been married the longest of any of the 102 couples present who had been wedded more than 50 years, and all of whom were honored guests at the Fair. Mr. and Mrs. Skeffington were married 67 years ago at Hazelwood, MN. The remarriage service was read by Dr. David Bryn-Jones, Trinity Baptist Church, Mpls and Leopold G. Bruenner, St. Paul, played the wedding march. After the ceremony, the bride cut the big wedding cake presented by H. P. Keller, St. Paul, President Territorial Pioneers.
