The services to be provided to you by "TA" if you so register are: (a) compete in talent and/or model competition(s) attended and judged by industry professionals (a "competition" is not an "audition"); (b) attend educational classes and workshops as you choose (c) have the opportunity to be seen at "callbacks" if so chosen by a person in the modeling or talent industry; and (d) attend awards and the Gala. The services provided by Talent America, Inc will be performed June 27th through June 30th, 2019. YOU REPRESENT AND WARRANT THAT NO PERSON HAS TOLD YOU OR LED YOU TO BELIEVE THAT TALENT AMERICA, INC OR ITS' AREA DIRECTOR(S) WOULD PROVIDE ANY SERVICES INCLUDING ANY AUDITION OR POTENTIAL EMPLOYMENT FOR YOU IN CONNECTION WITH TALENT AMERICA OTHER THAN SET FORTH ABOVE. YOU ALSO UNDERSTAND THAT THIS TA EVENT IS A COMPETITION AND THAT A "COMPETITION" IS NOT AN "AUDITION".

IF YOU ACKNOWLEDGE AND AGREE WITH THE PRECEDING PARAGRAPH, YOU MUST INITIAL IN THE BLANK SPACE. _____ THE FOLLOWING IS A RELEASE BY YOU. PLEASE READ IT CAREFULLY AS YOUR SIGNATURE BELOW CONSTITUTES THAT YOU FULLY UNDERSTAND AND ACCEPT THIS RELEASE: I agree to abide by all of Talent America's Rules & Regulations including those listed on its' website as well as the following rules and regulations as set forth by Talent America, Inc ("TA") while attending its' National Finals June 27th through June 30th, 2019 in New York as follows:

- I will follow the official schedule and will abide by the competition guidelines for each contest in which I am competing.
- I will not engage in any discussions or agreements with photographers, agencies, etc nor accompany them anywhere without the express permission of a Director of Talent America. I will direct anyone seeking to engage me in such discussion, agreement or meeting to a Director of Talent America.
- I will abide by the rules set forth by the Wyndham New Yorker Hotel and I will be held financially responsible for any damages or loss to the hotel that is caused by me. I am subject to all applicable city, county, state and federal laws, ordinances, and regulations in force in the City of New York.
- In consideration of the potential for publicity at the Talent America National Finals, I hereby grant TA, its subsidiaries, affiliates, area directors, agents, successors and assigns, and those acting with their authority, the unrestricted, absolute, perpetual, worldwide rights to: a) use, re-use, publish and republish, and permit to be used, re-used, published, and re-published, my name and any and all digital images, photographs, video, television and other tapes, recordings, likeness or characterization of me (the "images") made by or on behalf of TA, whether alone or in part or in original or modified form, in any manner as TA may choose, and for any and all purposes, including, but not limited to, the commercial use of my name and images for promotion, advertising or trade purposes ("a release"); b) reproduce, copy, modify, create derivatives of the images, in whole or in part, or in combination with or as a composite of other matter, including, but not limited to, text, data, images, photographs, illustrations, animation and graphics, video or audio segments of any nature, in any media or embodiment, now known or hereafter to become known, including, but not limited to, all formats of computer readable electronic, magnetic, digital, laser or optical-based media; and c) display, perform, exhibit, distribute, transmit or broadcast the images by any means now known or hereafter to become known, including, without limitation, on any TA site on the World Wide Web portion of the internet
- I further agree that I will not enter into any other Release or allow any other person or entity to use any images created of me during the Talent America National Finals without the prior written permission of Talent America.
- I hereby warrant that I have not restricted the use of my name, likeness or images to any person, firm, corporation or other entity.
- I will not hold Talent America or its' Area Director(s) responsible, nor does TA or its Area Director(s) assume any responsibility, for: acts of God, war or terrorism' travel days; labor strikes or work stoppages; or human, technical, mechanical or electronic malfunction that may (a) impact or cause cancellation of the Talent America National Finals or (b) cause bodily injury to me or loss or damage to my property during my travel to or from the TA National Finals or during the TA National Finals. Any disputes arising from my participation shall be resolved by the Director(s) or the President of Talent America.
- I understand that there are risks associated with traveling to and attending the TA National Finals and visiting a city that I may not be familiar with, including risks associated with crime, traffic, weather, congestion, and the negligence of others. I understand that these risks are inherent in traveling to and visiting the city of New York, whether or not I am participating in Talent America sponsored events at the time-and that Talent America is unable to control or minimize these risks. I knowingly assume these risks.
- I understand that TA is under no duty to supervise my conduct, nor the conduct of my children, during the Talent America National Finals. I further understand that Talent America is under no duty to supervise any other contestant, participant, parent, Area Director, judge or guest attending the Talent America National Finals. I understand that because Talent America is under no duty to supervise my conduct, I am free to leave the TA National Finals at any time for any reason and when I do, TA is under no duty to assure the safety of my body or property. I understand that Talent America is under no duty to provide safe and satisfactory accommodations at its' National Finals.
- The undersigned hereby agrees that Tennessee Law shall govern the provisions of the Release Agreement and hereby agrees that they are subject to jurisdiction in any court in the State of Tennessee in connection with enforceability of this Release Agreement.
- I grant permission to the Director(s) of Talent America and or a representative of Talent America to render or seek emergency first aid treatment for me, if it appears necessary to such person.
- I release Talent America, Inc, its directors, officers, area directors, agents, employees, licensees, independent contractors, and or assignees from any and all liability not expressly accepted by Talent America I will not hold Talent America, its parents, contractors, affiliates, directors, share holders, agencies or employees liable for injury, loss or damage of any kind to me resulting from the rights, consent and waiver provided by this agreement. I hereby indemnify save and hold TA harmless from any loss or damage, including reasonable attorneys' fees, arising out of or in connection with any breach or default by me or from any claim by a third party which is inconsistent with any of the warranties, representations and covenants or agreements made by me in this agreement.
