Tuition fees are annual and payable at once by 08/31/19; in 2 installments on 08/31/19 and 12/31/19 or in 9 installments the first of each month 09/19-05/20 by Credit/Debit auto-draft only.

A fee of \$30.00 will be charged for payments not honored by the bank.

A non-refundable \$58.00 fee *per costume* and \$15 Nutcracker costume rental is due 11/05/19; less the \$25 deposit due at registration.

Enrollment for Performance Classes is for the full season, September, 2019 through the ShowCase in May, 2020. Upon registration, **you agree to remain enrolled for the entire season, fulfilling your full tuition obligation.**

A specific uniform available through the SIM online store is required and must be worn in order to attend a performance class.

The early-pay discount may be taken for full season payment, made in cash by the due date.

All fees and payments for tuition, dancewear, costumes, etc. are non-refundable and payable via Visa/MC only. Checks not accepted.

Fees will not be pro-rated or refunded.

This form must be completed by the legal guardian of the enrolling student unless the student is 18 years or older. Please complete all spaces. You will want to obtain and read the SIM Policies and join the eNews list in order to stay aware of current policies, class schedules and events.
