

## Briarwood Homeowners Association

### Architectural Rules & Regulations

- I. Shingle color, texture and style will resemble those on adjoining or neighboring roofs. Reshingling of roof must be windstorm inspected during installation.
- II. Houses and garages, including fascia, soffits, siding, doors and exterior window trim, will all be the same color. Exterior doors may be a different color.
- III. Fences and gates will be maintained with or replaced with similar wooden or brick material as original. Wooden gates on brick fences will be the same color as the house and garage. Wrought iron gates may be black. Metal framed gates with a total surface area that is more than 50% wood or other non-metal material will be painted the same color as the house; both metal and wood or other non-metal material.
- IV. Repainting of house, garage, fence and gates
  - A. Colors will be one from Appendix A. The colors are Sherwin-Williams colors and may be matched by the paint dealer of owner's choice
  - B. Color will be different from neighbors'
- V. House Numbers
  - A. Placement
    1. Above garage door and equidistant from each side of garage
    2. For houses without a side main entry door – On or beside entry gate on opposite side of house from garage
    3. For houses with a side main entry door – On or above the main entry door and equidistant from each side of the door or beside the main entry door
  - B. Color of house number to be black unless gate is black. Numbers placed on black gates will be white or light gray.
- VI. Exterior light fixtures
  - A. 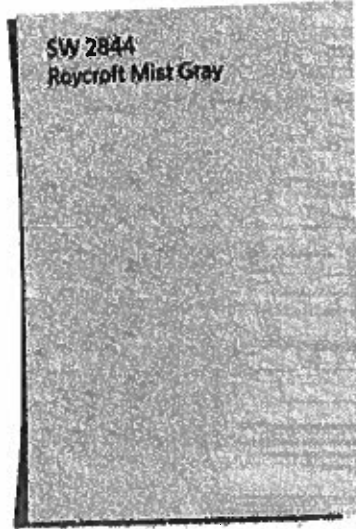
- VII. Exterior Placement of Wiring, Satellite Dishes, Etc**
- A. Utility boxes, wires and cables attached to the garage shall be maintained in good condition and painted the color of the garage and house.
  - B. Satellite dishes require Architectural Control Committee approval prior to installation to assure the following:
    - 1. Mounted as inconspicuously as possible on the house and in no instance on the garage without Architectural Committee approval
    - 2. All unused dishes should be removed
- VIII. Mailboxes shall be maintained in good repair; upright, on sturdy posts, and meet U.S. Postal Service placement guidelines of 41"- 45" above the ground and 6"- 8" from the curb.**
- A. Mailboxes installed after October 1, 2019 shall be similar to Gibraltar Mailboxes Classic 10.2-in W x 49.9-in H Plastic Black Post Mount Mailbox with Post:

- IX. All plants outside the owner's fence belong to Briarwood. The plants will be in keeping with the overall campus foliage and will be maintained by Briarwood. Homeowners who wish to have different plants that are in keeping with overall campus foliage and agree to purchase and install the plants and maintain them at his/her personal expense may request approval of the Architectural Control Committee. Any such approved plants not maintained by the owner will be maintained or removed by Briarwood to Briarwood standards.**

WHEREAS Briarwood Property Owners Association (hereinafter the "Association") a Texas nonprofit corporation, is the governing entity for Briarwood Subdivision, Section II, an addition in Brazoria County, Texas, according to the map or plat thereof, duly recorded in the Real Property Records of Brazoria County, Texas, at Volume 13, Page 71, of the Plat Records of Brazoria County, Texas, along with any replats and annexations thereto (hereinafter the "Subdivision"); and,

WHEREAS the Association and the Subdivision are governed by that certain Declaration of Covenants, Conditions and Restrictions for Briarwood Subdivision, Section II, filed for record in the Real Property Records of Brazoria County, Texas, at Volume 1201, Page 134, along with any amendments and/or supplements thereto (hereinafter the "Declaration"); and,


WHEREAS Article VI, Section 3 of the Declaration authorizes the Association to adopt rules and regulations concerning architectural control; and,

WHEREAS this Dedicatory Instrument represents Restrictive Covenants as those terms are defined by Texas Property Code §202.001, et. seq. and the Association shall have and may exercise discretionary authority with respect to these Restrictive Covenants;

NOW THEREFORE, pursuant to the foregoing and as evidenced by the Certification hereto, the Association, through its Board of Directors, hereby adopts, establishes, and imposes upon the Subdivision, and the residents thereof, the attached Architectural Rules, which shall replace any and all existing Rules and Regulations.
