## The History of Memorial Day

Memorial Day, as we know it today, is truly an American holiday. It is always observed on the last Monday of May and honors the men and women who died while serving in the U.S. military. However, it was originally known as Decoration Day, and has changed over the years to include much more than was initially intended.

It originated in the years following the Civil War, which ended in the spring of 1865, and claimed more lives than any conflict in U.S. history. Due to the number of casualties, it required the establishment of the country's first national cemeteries, which probably helped to prompt the observances that followed.

On May 5, 1868, General John A. Logan, leader of an organization for Northern Civil War veterans, called for a nationwide day of remembrance later that month. "The 30th of May, 1868, is designated for the purpose of strewing with flowers, or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land," he proclaimed. The date of "Decoration Day", as he had called it, was chosen because it wasn't the anniversary of any particular battle.

By the late 1860s, citizens all over America were holding springtime tributes to honor these countless soldiers, decorating their graves with flowers and holding prayer services. It's hard to know how exactly this tradition originated but it is presumed that many different communities may have independently initiated these types of memorial gatherings.

Waterloo, New York, which first celebrated the day on May 5, 1866, hosted an annual, community-wide event, during which businesses closed and residents decorated the graves of soldiers with flowers and flags. One hundred years later, in 1966, the federal government declared Waterloo, <u>New York</u>, the official <u>birthplace of Memorial Day</u>.

On the first Decoration Day, General <u>James Garfield</u> made a speech at <u>Arlington National Cemetery</u>, and 5,000 participants decorated the graves of the 20,000 Union and Confederate soldiers buried there. Many Northern states held commemorative events and continued these traditions annually. By 1890, each one had made Decoration Day an official state holiday. Southern states, on the other hand, continued to honor their dead on separate days until after <u>World War I</u>.

Memorial Day, as Decoration Day gradually came to be known, originally honored only those lost while fighting in the Civil War. During World War I, however, the United States found itself in another major conflict, and the holiday evolved to commemorate American military personnel who died in all wars.

For decades, Memorial Day continued to be observed on May 30, the date General Logan had selected for the first observance. But in 1968, Congress passed the Uniform Monday Holiday Act, which established Memorial Day as the last Monday in May, creating a three-day weekend for federal employees. This change went into effect in 1971and also declared Memorial Day a federal holiday.

Cities across America host Memorial Day parades each year, incorporating military personnel as well as members of veterans' organizations. Some of the largest parades take place in <a href="Chicago">Chicago</a>, New York and <a href="Washington">Washington</a>, D.C. Americans also observe Memorial Day by visiting cemeteries and memorials. Volunteers place American flags on graves in <a href="mailto:national-cemeteries">national-cemeteries</a>.

Memorial Day differs from <u>Veterans Day</u> in that Memorial Day is a day of remembering the men and women who *died* while serving. Veterans Day celebrates the service of all U.S. military veterans. Many Americans observe Memorial Day each year by visiting cemeteries or memorials, holding family gatherings and participating in parades. Unofficially, it marks the beginning of the summer season.

Whether it's a prayer or a parade or a family picnic, take time out to remember and honor our heroes who have made the ultimate sacrifice on Memorial Day or any day of the year. They deserve to be honored and always remembered.



## You Can Do Business With Terrorist Regimes or With Texas, But Not Both



Since I passed the original Iran Divestiture amendment in 2013, over \$9 million in state taxpayer dollars have been divested from Iran. To further solidify Texas' commitment to the American-Israeli partnership as an essential component of our national security strategy, I authored two bills now headed to Governor Greg Abbott for signature. The principle is simple: Companies that choose to profit from business with Sudan, Iran, or a foreign terrorist organization will do so without the support of Texas taxpayers.

Passing both Chambers by a combined vote of 348-3, the Legislature was clear and emphatic: Texas stands with our long-time and faithful ally Israel.



as a Marine in northern Iraq, my unit confronted Iranian-funded agitators, spies and anti-American protesters.



While politicians in Washington failed to stop former President Obama's disastrous Iran deal, Texas — under Gov. Greg Abbott's leadership — again led the way. After meeting with Israeli Prime Minister Benjamin Netanyahu in January, Abbott stated, "As governor, I am a steadfast supporter and friend to the State of Israel — and the state of Texas' policies will reflect that. That is why today I am announcing action to ensure Texas maintains its Iran divestiture policy despite the federal government's deal. Further, I am calling for new legislation that will strengthen Texas existing divestiture laws and ensure Texas taxpayer funds do not enrich Iran."

To further address this issue and solidify Texas' commitment to the American-Israeli partnership as an essential component of our national security strategy, I authored two bills now headed to Abbott for signature. The principle is simple: Companies that choose to profit from business with Sudan, Iran, or a foreign terrorist organization will do so without the support of Texas taxpayers.

Importantly, this was not a partisan issue. Recognizing the commonsense premise that taxpayer dollars should not aid companies profiting off terrorist regimes or organizations seeking to kill Americans or destroy our way of life, these bills earned overwhelming support within the Texas Legislature, passing both chambers by a combined vote of 348-3.

Senate Bill 253, the Terror State Divestiture Act, builds on Texas' current Iranian and Sudanese divestiture standards to encompass all state funds, rather than just retirement funds. This change would apply to funds in the state treasury and public investment pools.

Senate Bill 252, the Terror State Contracting Divestiture Act, prohibits a state agency, city, county, school district, public university, special district and the Legislature from contracting with a business for goods or services, including public works projects, if that business is engaged in business operations with the Sudanese or Iranian governments, or a foreign terrorist organization designated by the U.S. State Department. While state retirement systems cannot invest in companies that do business with the Sudanese or Iranian governments, nothing prevents state agencies and political subdivisions of this state from using taxpayer dollars to contract with these same companies. This change to Texas' contracting law closes the contracting loophole while ensuring that taxpayer dollars do not go to terrorist business partners.

Upon Abbott's signature, these two bills put companies on notice: If you want to do business in Texas with government at any level, you cannot also do business with or invest in a terrorist regime.

This legislation is powerful and unambiguous. If you want to contract with a Texas government entity to build a bridge, develop oilfields, sell gasoline, design plans for a water district, or a host of other projects, Texas taxpayers expect that you are

> not selling those same services to prop up the Iranian or Sudanese governments or a terrorist organization.



If Texas were its own nation, it would represent a top 10 world economy. Given Texas' economic standing, this action could mirror the impact of a similar required implemented by a nation with an economy the size of Italy, Brazil, or Canada. Taking Texas' vast energy resources into account, these divestment measures could have a very significant and possibly worldwide effect.

The Legislature is clear and emphatic: Texas stands with our long-time and faithful ally Israel.

## 85TH TEXAS LEGISLATIVE SESSION ENDS - Senate Press Release

(AUSTIN) — Memorial Day marks the end of the 85th Regular Session, but lawmakers could find themselves in Austin during the summer to deal with some unfinished business. After a bill to extend the Texas Medical Board died due to conflicts between the House and Senate in the waning days, Lt. Governor Dan Patrick wants Governor Greg Abbott to call a special session to deal with two of his top priorities that didn't make it to the governor's desk: property tax reform and the so-called "bathroom bill". Only the governor can call an extra session and only he can set the topics eligible for legislation in it. Abbott said at a bill signing on Monday that he will announce a decision about a special session later in the week.

Over the weekend, the House and Senate passed a final version of the state budget, authorizing \$107.7 billion to pay for state services for the next two years. Despite the tight revenue forecast, its author says the budget will fund the state's critical priorities and put more money into education, mental health care and Child Protective Services. "This budget is fiscally responsible," said Senate Finance Committee Chair and Flower Mound Senator Jane Nelson. "It essentially is flat compared with the current one, but it makes progress in several key areas."

Also over the weekend, the Legislature gave final approval to sweeping reforms to the agency that oversees child welfare in Texas. SB 11, by Georgetown Senator Charles Schwertner, would continue the process of privatizing parts of foster care, moving to a community based model that seeks to keep children in their communities and expedite their medical care. There's also \$500 million set aside in the budget to hire more caseworkers, in addition to the \$160 million spent over the interim to hire more employees and give raises to existing workers.

Here's a look at some of the other key pieces of legislation that passed this session:

- SB 4, by Lubbock Senator Charles Perry, would outlaw so-called "sanctuary city" policies in Texas. These are formal or informal polices set by city officials that preclude cooperation with federal immigration officials. Police departments would also have to comply with federal immigration requests to extend detention for suspected criminal immigrants. This bill has already been signed by the Governor and is set to become law on September 1.
- HB 62, sponsored by Laredo Senator Judith Zaffirini, would ban texting while driving in Texas. This bill still awaits action by the Governor.
- SB 5, by Houston Senator Joan Huffman, would make changes to the state's Voter ID law after a court struck down parts of it. It would allow a person to sign an affidavit stating they have a reasonable impediment to obtaining a photo ID and cast a regular ballot. It still needs to be signed by the Governor.
- SB 8, by Georgetown Senator Charles Schwertner, was amended in the House to become an omnibus abortion regulation bill. It would require that fetal tissue be given a proper burial or cremation after an abortion, would ban a certain type of second-trimester abortion and would reaffirm the ban on partial birth abortions in Texas and give state officials the power to prosecute violators. SB 8 is awaiting action by the Governor
- SB 12, by Dallas Senator Royce West, would create a \$25 million grant program to help local law enforcement entities pay for high-caliber resistant body armor. This was signed by the Governor.

Before gaveling out for the final time, Patrick praised the Senate for its hard work over the last 140 days. "It's an honor to serve with all 31 of you," he said. "You did great work for the people of Texas, particularly in the area of child protective services and child-care." Absent a special session, the Legislature will meet next in January 2019. Until then, the Senate stands adjourned sine die.








## Citing Obama IRS Abuses, Judicial Watch and Allied Educational Foundation File Amici Curiae Opposing Federal Attempt to Force Public Disclosure of Nonprofit Donors

(Washington, DC) – Judicial Watch announced today it joined with the Allied Educational Foundation (AEF) in filing an *amici curiae* brief with the U.S. Supreme Court arguing against a lower court's decision requiring the Independence Institute to report the names and addresses of donors after the organization ran an advertisement the Federal Election Commission (FEC) deemed "electioneering" under the Bipartisan Campaign Reform Act (*Independence Inst. v. Federal Election Commission* (No. 16-743)).

Judicial Watch and AEF argue that the forced disclosure of supporter names will "chill and deter speech":

If allowed to stand this decision will chill and deter speech. As set forth below, *Amici* know firsthand that disclosure, or even the threat of disclosure, may impair the ability of organizations – in particular, of conservative organizations – to conduct issue advocacy....

\*\*\*

The fear of negative consequences arising from public disclosure expressed by those contemplating donations to conservative organizations are founded on recent events. As has been widely reported, monetary support for conservative causes, when disclosed, can subject individuals and organizations to attack and retaliation.

The *amici* brief was filed after a three-judge panel in the U.S. District Court for the District of Columbia ruled in favor of the FEC, which had charged the Independence Institute, a 501(c)(3) nonprofit that sponsors in-depth studies of critical social and economic issues, with running a radio ad supporting federal sentencing reform and encouraging citizens to contact their representative, Senator Mark Udall (D-CO).

At the time, Udall was running for re-election. The FEC deemed the ad an "electioneering communication," which meant that the organization making it had to report the names and addresses of all donors giving more than \$1,000 – simply because it had produced an issue advertisement naming an elected official. The three-judge panel said the ad triggered the disclosure requirements under BRCA, on the grounds that the ad directed the audience to contact their Senators to express support for proposed legislation.

In their *amici* brief, Judicial Watch and AEF strongly countered the FEC's charge and subsequent District Court ruling designating the material an "electioneering communication":

The Court reached this conclusion even though the advertisement made no reference to the Senator's candidacy, did not advocate the election or defeat of the Senator (expressly or otherwise), and referenced the State's other U.S. Senator, who was not then up for reelection. As a result of this decision, organizations that are not engaged in any express advocacy could be subject to the BCRA's disclosure requirements....

*Amici* submit that the district court's decision raises important issues of constitutional law, and that it will have substantial adverse effects on nonprofit, 501(c)(3) organizations only concerned with policy issues, not the outcome of elections.

Citing their own "firsthand knowledge" concerning the harassment of conservative contributors, Judicial Watch and AEF specifically pointed to the recent activities of the IRS in its targeting of conservative organizations applying for tax-exempt status:

[S]taff inside the Internal Revenue Service began targeting applications for tax-exempt status filed by conservative non-profit groups. What followed was one of the most troubling instances in recent memory of public officials using government resources to try to silence political opponents.

After widespread reports and Congressional inquiries regarding selective targeting of conservative organizations, the U.S. . Treasury Inspector General for Tax Administration ("TIGTA") audited the unit responsible for processing applications by

The IISS study shows 157,000 people died in armed conflicts in 2016 down from 167,000 in 2015."

organizations seeking tax-exempt status under I.R.C. §§ 501(c)(3) and 501(c)(4). TIGTA's report on the matter showed that there had been a deliberate, systematic targeting of conservative groups.

"To be clear, Congress can't pass a law that trumps the First Amendment," said Judicial Watch President Tom Fitton. "Politicians who control government want to suppress Americans from even uttering their names around election time. No matter whether it is the FEC or the IRS, the government should stop trying to intimidate Americans. This might be good politics but it strikes at the heart of the First Amendment and government accountability."




