## COVID-19 VACCINE APARTHEID IN AMERICA

The purpose of this report is to provide a transcription of a video by Los Angeles Fire Department LAFD Captain Cristian Granucci. He is a 31-year Veteran. On August 23, 2021, he uploaded a statement and/or declaration to his Telegram App. He voiced his concern, objection and call to action against what he and many others in either Law Enforcement, First Responders, Nurses, Doctors, Teachers are seeing as a creeping Medical Tyranny descending over the entire Planet Earth. As many have agreed, it is a gut-wrenching soliloquy and call to action opposing the State Mandated COVID-19 Vaccine Program that to such is seen as a form of 'Apartheid' now come to USA.

It is a great example of how 1 Individual can make a difference and inspire others to stand. He understands that it is not 'just 1 vaccine' for a Severe Flu. And if he and others alike do not take a stand now, even publicly at the risk of ridicule, threats and Department Discipline, no stance will be made later. And the 'Tyranny' exemplifies itself and proves that the mere action of exercising one's U.S. Constitutional Right to Free Speech, Freedom to be secure and safe in one's Person, that the 'Body' is now subject to 'An Internal Department Investigation'. It is a 'Witch Hunt' but only because Society is being put under a Mass Psychosis of a 'Scare' of COVID-19 that has been weaponized.

And it is true that even if one gets granted either a Medical and/or Religious Exemption, the COVID Camps are ready to be stockpiled by the Unvaccinated. Sooner or later, all those People 'Not Vaccinated', will be forcibly removed to such 'Interment Facilities', for their 'Protection' of course. Medical Apartheid is about to be implemented. The problem is that the consensus of the Nations, the Peoples is that it is divided right down the middle on this issue. With this premise, the old Axium of 'Divide and Conquer' will always favor Tyranny. It has already started. But Captain Granucci is a real Hero.

And of the course, the bought-out Corporate Mass Media, did not waist time in 'Crucifying' this Captain for 'Attacking' the City's Policy, etc. They attacked him for daring to speak-out and oppose the 'Requirement'. How dear he make a 'rare' outburst. Charge him with 'Insubordination'. The Los Angeles Fire Department said in a statement that the matter has been submitted to its Professional Standards Division for investigation, which may result in 'Disciplinary Action'. For the transcription, numbers and certain Names and Words will be bold, numerated for emphasis.

My name is Christian Granucci. I am a Captain with the Los Angeles City Fire Department. I m a 31-year Veteran with this Agency. And I am more than likely going to catch total grief from my Administration from this. But I am done being silent on this matter. And so are many of our Members. And this is regarding the Vaccine Mandate by the City of Los Angeles, for all City Employees. We saw this Tyranny coming. We saw it coming across the Pacific.

And a week and a half ago, it landed in Honolulu with the Honolulu Fire Department. And we watched a passionate plea from Captain Pelekai, literally in tears being forced to resign because he chose not to take the vaccine. Forced to leave the Department after faithfully serving it for years. Then it landed on our coast. It hit San Francisco Fire and we heard the stories up there.

Our Union Representation stood by idly and played a 'Wait and See' and sat on their hands. Well, now it is here in Los Angeles and the Mandate has come down from the Mayor and the City Council that we, all City Employees including First Responders 'Shall Take The Vaccine'. If we do not take the vaccine, we have to be subjected to testing twice a week. If we refuse that? Termination

Again, I am a 31-year Veteran of this Department. I have literally bled for this Department. I used to love coming to work. I respected the Administration of this Department. At one point, I even respected our Union Leadership. And now they are 'Lock Step' with Total Tyranny. I want you to be clear on this. I want everyone to be clear on this. This is not about Politics. This is not about Left or Right. This is not about Red versus Blue.

This is not about Republican versus Democrat. This is not even about Vaccinated versus Unvaccinated. This is Tyranny. This is about Freedom of Choice. The Department has said that we can seek Medical Exemptions if we so choose if we can. That is a 'Pie in the Sky'. We can even try and seek some kind of Religious Exemption. But they know that they have end-runs-around those.

The vaccine the vaccinations will come. And then after that, it will be a Booster and another Booster and another Booster. And when will this end? When will this Tyranny stop? I will tell you where it is going to stop. It is going to stop right here, right now. And I am putting my Administration and my Union on blast. You had the opportunity to get in front of this and you did not.

We want to give you the opportunity to do the 'Right Thing' and represent the Membership. You would think that the Union, that is there fighting for the 'Little Guy' would jump in front of this. And this would have all kinds of handles on it for you to grab. And run this in for a 'Touchdown'. But no. You decided to play Politics with this. And you have... You have half this Department. You have a split right down the middle and this is what Tyrants want. They want to split down the middle.

They want to 'Divide and Conquer'. I am so hopping mad right now! You have no idea. My head could pop! Again, we want to give our Union the opportunity to step in front of this and do the right thing. But know this there is a Large Group of us in the 100s. And we have an Attorney on Retainer. And he is a 'Shark'. We will give you the opportunity to stand-up and take the Fiery Arrows from the 'Adversary of Tyranny'. And step in front of this and fight for us. But if you do not, our Plan B. A Large Group.

And it is growing by the day. We have him on retainer and we will seek Legal Counsel. And we will take the fight to you, the City of Los Angeles. Again, I am going to catch so much grief for this. But I do not care. I would not be able to look at my Wife. She is going 'to kill me'. I would not be able to look at my Wife though and my Sons in the eye as they grew up under Total Tyrannical Law and Rule. When I had a chance to stop this. I had a chance to fight, but I did nothing. This is bigger than me.

This is bigger than the Los Angeles City Fire Department. This is bigger than my Union. I do not recognize this place anymore. I do not recognize this Country. I do not recognize this State. I do not recognize this Department anymore. Again, I want you to be very clear. I want everyone to be very clear on this. This is not a Political Issue. This is not Left-Right. This is not Democrat-Republican. This is not Vaxxed-Unvaxxed. This is a Fight for Freedom of Choice, Free Will.

This is a Fight against Tyranny. Make no bones about, ...we have an uphill battle, a sizable financial commitment from several 100 of our Members. I do not want to be doing this at the end of my career. I would love to do a few more years on this Department and just 'fade-off into the sunset'. But you know what? Damn, it just landed in our lap. And we got to do something. We cannot sit back and let this happen... let this happen to our Country.

I will leave you with this. And I saw this online a couple days ago. It was a Gym Owner in Oceanside, California. And like so many Businesses here in California, they have just been knuckled-under. And he was speaking in front of his City Council and he pointed at them and he said, 'You told us like the Country's Administration told us and you our City Government told us... just give us 2 Weeks to 'Flatten the Curve'. And this has gone from 2 Weeks to Flatten the Curve to 'Show Me Your Papers'.

We all see what is happening here. I cannot sit idly by anymore. If things have moved that fast in the last 18 months, where the hell will we be in the next 18 months? God Bless all the First Responders out there. You need to turn around and put your Union on check and have them fight for you. And if they do not, you take the battle to them any way you can. And you assemble all the Numbers that you can. As many People as you can and you take the fight to them. We outnumber them. I am out.

#### The Neo-Serfs Shall Obey

And what did his Department say? 'While we respect the individual's right to his opinion, he is not authorized to speak on behalf of the Department'. He was not. The Statement from the Department further said. 'The Individual is in his Uniform and appears to be on duty, thereby giving the impression that he is speaking in an official capacity.' Not Really. It is a message of 'You must OBEY!' Realize that LA's roughly 3,350 Firefighters are on the Front Lines. They work alongside Paramedics and Emergency Medical Technicians EMTs, etc. The issue? The Firefighters have been slow to take the COVID-19 Injections. Only about 50% of the Departments were vaccinated earlier in the Summer of 2021. This is the real issue.

And like the Nazi Propaganda Ministers, it was Alex Comisar, a Spokesman for Mayor Eric Garcetti, that toted the 'Official Party Line'. He said the vaccine requirement is in place, 'To protect the Health and Safety of our Workforce and the Broader Public.' He further elaborated by saying next. 'The Mayor hopes that the full FDA approval of the Pfizer-BioNTech vaccine will help reassure People that these vaccines are Safe and Effective' This new Info War and 'FDA Approval' has given new ammunition to those who seek to Cull Humanity and subjugate it under a COVID World Order Tyranny.

One is now living under an unfolding Medical Tyranny. Comisar had referenced the U.S. Food and Drug Administration's 'Full Approval' of the Pfizer so-called 'vaccine'. And Comisar, as in a Soviet Comisar perhaps? How befitting a name and no less shocking of the same that was one of the Signatories to the FDA Licensing Letter to Pfizer, a Mary A. Malarkey. 'In an effort to provide full and complete transparency, however, it must be clearly stated that Labor Attorneys all over the country have examined this issue and there is a Near Unanimous Consensus that States, Cities, and Counties have the Legal Right to proceed with Mandatory Vaccination Policies.'

Several California State Employee groups, including Cal Fire Local 2881, representing over 6,000 State Firefighters, have filed Official Objections to the new State Vaccination Rules. One would say though, that this War Front against the COVID Medical Tyranny has already been lost, legally. As the Union Newsletter went out, it stated what is the course now or will be. But this is the key and failure of the counter-argument. These new mRNA type of technology Injections are not 'Vaccines'.

#### **Ad hominem Responses**

Although they have redefined what a vaccine is/was to accommodate for the COVID-19 Shots, they are not traditional 'vaccines'.
