D. Intake of Rescue Dogs

- Ineligible Dogs reworded first bullet to dogs proven to have previously bitten people in a malicious manner
- Ineligible Dogs third bullet deleted amount under lack of sufficient funds
- Questionable Dogs deleted pregnant females, puppies not weaned and dogs in excess of 12 years old
- Stray Dogs reworded number 3 If no one has claimed the dog within seven days, the dog may be considered for intake as a owner relinquishment dog
- After Dog is Approved to Come Into Rescue reworded number 2 replaced "shall not " to " should not"
- Owner Relinquishments opening paragraph –added military deployment in parenthesis to death, terminal disease of owner etc.

E. Foster Procedures

- Veterinary Treatment reworded number 5 while the dog is being altered please ask the vet to trim the toenails free of charge and implant the microchip. Also ask them to check the dogs teeth.
- Foster Dogs at Events First paragraph delete heartworm negative

F. Adoption Procedures

- Adoption policies number three adjust adoption donation fees to \$250 for puppies up to a year, \$200 for dogs 1-8 yrs. old, \$100 for dogs aged 9-10 yrs. & \$50 for dogs older than 10 yrs. or special needs dogs. Bonded pairs will have a \$200 donation fee or it will depend upon a case by case basis
- Out of State Adoptions added someone qualified
