Asphalt was not stated in the Goldfinch Agreement but it was in the Milona Lakeview Estates agreement. Neither one of the agreements require the township to take over the road. A meeting with Clay Hager would be appropriate to find out intentions with road. The signs on Chicago Club Road and Lane are ordered. Tom sent the two letters out and received phone calls from the parties. Richard Ohland thought he ok with what he did, he would attend the December meeting if necessary and fit schedule to discuss the ditch.
