#### 5. Old Business

A. Property CC&R Violation Complaint Updates

Jon Puryear

1) 4333 Ascot

Jon reported that at the last court hearing, the Judge ordered that the Allen's had 30 days to clean up the property. If they don't, he will issue a fine of \$6000 and refer us to a higher court. Jon stated they haven't performed any additional clean-up activities and reported this to the court for another hearing requesting the Judge to order his last judgement and that court date is Oct 19<sup>th</sup>.

## 2) 4900 St Leger

Jon stated Ray Bejar has a contract on his property and the contract states he must clean up his entire property prior to closing. Hopefully the sale will be successful. Ray did call Jon after he received the letter of violation and stated the two vehicles just needed a new battery and he would move them into the shop or behind the tree line. To date, Timothy stated that hasn't been done.

#### 3) 4337 Ascot

Jon reminded everyone of what was voted on in the last meeting. The Santos family was in attendance and presented a check to reimburse the CNRE of the attorney fees and a letter requesting a variance to be approved by the CNRE Members regarding their 15' setback. Mary Stotler made a motion to approve, Stephanie Simmons Seconded and it was approved unanimously. Jon will email Mr. Santos the approval letter.

#### 6. New Business

A. Property Violation Complaint Update

Amy Lingo

1) 4221 St Leger

Jon stated from the last meeting, the Membership voted to send a certified letter of Violation of the Deed Restrictions of the many unknown individuals causing fear in the neighborhood which was causing a nuisance. Also, individuals were living in a RV on the rear patio. Amy Lingo stated that the property owner called her after receiving the letter and stated that he was helping some homeless people by letting them stay on his property, however they created problems and he made all of them leave. He stated that he learned a hard lesson and wouldn't do that again. He stated that there is a person living on his property who provides security in the owner's absence. Jon stated that it is

the EBOD's opinion that all the issues violating the Deed Restrictions have been corrected and recommends that no further action be taken. The Membership agreed.

- B. Fall Festival Octoberfest Annie Guereca Stephanie Simmons stated there were currently only 10 individuals who have RSVP'd to attend. Jon stated that he would email the NRE about the event and copy/paste the RSVP links in hopes of getting more people to attend. Stephanie has already posted it again on the NRE Facebook page. If we don't get more people to attend by this Friday 10/20, she recommends canceling the event. We will do everything possible to notify the NRE and raise more awareness. At present, here are the needs for the Fall Festival: 8-10 homes to sign up for hayride stops/candy distribution, 3 trucks and trailers with hay for riders, 5-10 chili cook-off participants, 2-3 folks to help with set-up at the Simmons residence Oct. 28.
- C. Discussion of issues/items not on the Agenda Jon Puryear Timothy Biggs stated that there was a NRE Facebook post that wasn't very "neighborly" but instead was hateful. He wanted people to be nice to each other and more neighborly when posting on Facebook. Also, to call the neighbors that you have an issue with directly instead of posting it on Facebook. Timothy also suggested that it be communicated to all residents to wear reflective clothing when walking down the roads at night. Jon stated that he would email the NRE, post it on Facebook, and write a column in the December newsletter.
