Party Bus Rules and Regulations:

1. A \$100 non -refundable deposit is required for reservations and will be charged to client's credit card upon reservation. All balances are due before or upon pick-up. Vehicle will not leave until balance is paid in full.
2. Billing starts at scheduled start time. Driver will arrive approximately 15 minutes early.
3. No alcohol consumed by anyone less than 21 years of age. Violation will result in early termination, no refund, no exceptions. Alcohol is permitted on our party buses as long as everyone is 21 or older with a valid photo ID. You will be carded by the driver.
4. NO SMOKING inside the vehicles. This will result in a \$100 fine (immediately charged to credit card on file) No exceptions.
5. A \$200.00 clean-up fee will be charged for vomit and/or other bodily fluids. (immediately charged to credit card on file)
6. A \$50.00 clean-up fee will be charged for excessive matter left in the limousine. (immediately charged to credit card on file)
7. All vertical and horizontal metallic handrails and/or poles are in place solely to provide stability and support. Blue Moon Party Bus will not be responsible for any injuries or damages stemming from improper usage.
8. All unruly persons will be dropped off at the sole discretion of the driver with no refunds. We strive for everyone to have a great time not fight.
9. We are not responsible for any lost, damaged, or stolen property.

10. No illegal drug use of any kind is permitted.
11. Cancellations must be made within 14 days of your scheduled rental to avoid being billed the full contract amount, the only exception is if we can fill your reserved time spot then you will only lose the \$100 deposit.
12. There is a 15 minute grace period after the drop off time. Any time afterwards is considered overtime. Customer agrees that overtime will be billed at the contracted hourly rate and agrees to pay any overtime charges. Overtime payments will be made via credit card on file OR cash before reaching the final drop off destination.
13. The person(s) signing this contract takes full responsibility of informing their guest of these rules and regulations, even if guest are not informed all of our rules still apply.
14. Blue Moon Party Bus is not liable for lost/stolen items but if we find a left item it will be returned exactly as it was found.
15. Chauffeur will follow the trip itinerary on the contract. There will be one pickup and one drop off location unless otherwise discussed and agreed upon.
16. ALL passengers under 18 MUST have a chaperone over the age of 21 years old with state identification. NO EXCEPTIONS! Failure to comply will result in forfeiture of total contract fee and tour.
17. Feel free to eat food on the buses (and/or decorate it without damage), though you may be subject to a \$50 fee for clean up if the bus is not cleaned prior to end of tour.
18. Neither BLUE MOON PARTY BUS nor any of its employees are responsible for you or your guest being injured due to negligence for example: fighting on or off the bus, being intoxicated and falling, etc.

Cancellations

All cancellations with less than 14 days will be billed the total contract amount (charged to credit card on file). Remember, we are locking in your time slot and turning down other clients so this is important to us.

If you cancel more than 14 days beforehand and would like to reschedule, we will work with you on rescheduling for a later date, otherwise all cancellations will result in you automatically forfeiting your total contract amount.

Agreement to the conditions as outlined below and the contracted rate as quoted and included in this agreement authorizes Blue Moon Party Bus and its agents to accept payment in the form of cash or credit card. You must provide a debit or credit card \$100 nonrefundable deposit upon reservation, which applies toward the balance. The balance

must be paid the night of the event/party in cash to the driver before departure or by credit card at least 24 hours before departure. Credit card payments have to be processed the day before your ride unless agreed upon in advance with Blue Moon Party Bus and is noted on this contract.

Once deposit is accepted Blue Moon Party Bus is authorized to charge for any damages incurred by the responsible party and/or any guests of the responsible party, extra hours not contracted for, and cancellations per this agreement.

Contract Obligations (Please check each area)

The person who signs the contract agrees to thoroughly explain the above rules to all persons/passengers in their party and will be responsible for all damages. All damages are at the sole discretion of the driver. The contract signer is responsible to inspect the vehicle chartered prior to departure to determine any previous damages and note them on this contract.

I Agree

I agree to the above Blue Moon Party Bus Rules and Regulations. I understand and agree to pay the entire contract price if the 14 day cancellation policy is not followed. If we can rent the bus on the cancelled time/date you will only forfeit the deposit. Cancellations with 14 days or more notice will be allowed to use the deposit for a later date if that date is not already booked.
