BY-LAWS
MEMBERSHIP PROVISIONS
(See Directory for Complete By-Laws)

Section 1

Total membership may be restricted to a maximum number as determined from time to time by the Board of Directors.

Section 2

Before a person may be admitted to the Club, they must meet the following requirements:

- A. Be recommended by a Member in good standing; said Member may sponsor more than one person in any calendar year as determined by the current Board of Directors.
- B. Shall have attended at least one Club Party as a Guest within two months of time application is voted on by Board of Directors.
- C. Be approved by a majority vote of the Membership Screening Committee. This Committee will consist of all the elected Officers of the Club.
- D. Notice of pending application for membership shall be submitted to the membership at large prior to final approval of the Screening Committee.
- E. Shall have read the Club's By-Laws and agreed to abide by same.

Section 3

Membership in the Club shall be automatically revoked in the event of:

- A. Upon request of the Member.
- B. Upon a majority decision of the Board of Directors.
- C. Misconduct, as determined by a majority of the Board of Directors.

Section 4

Past members must submit an application for reinstatement. Reinstatement fee will be ten (\$10.00) dollars. Application will then be processed as a new member classification. Reinstatement requires majority approval of the Board of Directors, and provided there is an opening on the membership roll. If there is no opening, reinstatement application must be processed the same as a new member application and not receive preferential treatment.

ARTICLE IX DUES AND FEES

Section 1

New members (regardless of age), upon acceptance, shall pay annual dues of thirty-five (\$35.00) dollars per year.

Section 2

At dances open to guests, number of guests per member shall be determined by Board of Directors.

Section 3

Members who are single, may bring a date or an escort to all dances.

Section 4

Membership annual renewal dues shall be due from November 1 through December 31. Any member failing to renew their membership by that date shall be considered delinquent. Delinquent members may be reinstated by annual dues plus the payment of two (\$2.00) dollars reinstatement fee no later than January 31. Delinquent memberships shall be terminated after January 31.

ARTICLE X RULES AND REGULATIONS

- A. Gentlemen shall wear sport jacket with tie, dark suit with tie, or formal wear at all parties unless otherwise specified by the Board of Directors.
- B. Ladies shall wear "after-five" dress/ evening pants or formal wear at all parties unless otherwise specified by the Board of Directors.

ARTICLE XI RESPONSIBILITY DISCLAIMER

Social dancing constitutes physical activity in a variety of conditions. Members and guests will engage in these activities at their own risk. Tanglefoot Dance Club shall not be responsible for personal injury or loss of property. (REVISED October 1, 2007)
