The implementation of GASB 87 – Leases affected the financial statements. The statement cash flow has a positive operating cash flow for the third year. The auditors have an unmodified opinion on the financial statements and no material misstatements. The Nashua Airport Authority was subject to a uniform guidance audit (a single audit). The authority was in compliance with grant agreements.

AIRPORT ENGINEER'S REPORT

Nik Ippolito discussed on behalf of the airport's engineering consultant, Gale Associates, Inc.

REHABILITATE TAXIWAY 'A' AND ASSOCIATED TAXIWAYS

This Project is for the design and construction phases necessary to rehabilitate Taxiway 'A', install new taxiway edge lighting (MITLs), and to address the grading issues at the intersection of Taxiway 'A' and Taxiway 'D'.

Project Status:

- Bidding is now complete. The low bidder was Continental Paving, Inc. with a bid price of \$2,466,070.00.
- The grant application has been prepared, signed by the NAA, and was submitted to NHDOT/BA on March 8th, 2023.
- Because the Golf Ramp project was issued grant funding ahead of the Taxiway 'A' project, we
 must now process a change to each project to move Taxiway 'D' work that was originally
 intended to be done under this project over to the Golf Ramp project. This may require a revised
 grant application to be submitted. We're currently working with NHDOT/BA to finalize these
 changes.

 Because this project contains a lot of lighting materials, which are known to have longer lead times, the NAA may want to discuss entering contracts ahead of the grant funding. Doing so will allow the Contractor to begin ordering materials.

Recommended Actions:

REHABILITATE GOLF RAMP AND FOXTROT RAMP

This project is for the design and construction necessary to rehabilitate Golf and Foxtrot Ramps at the Airport.

Project Status:

- Construction is underway on Golf and Foxtrot Ramp. At the time of this meeting, the Contract is on Day 10 of 75. The Contractor's progress to date indicates an early finish. Possibly done by the middle of May.
- Gale has prepared and submitted a draft Change Order to NHDOT/BA for their concurrence. This
 Change Order will add in the Taxiway 'D' work needed to clear wingtips on larger aircraft taxiing
 up Delta. This work was originally intended to be done in the Taxiway 'A' project, but due to the
 delay in the grant award, it now must be done as part of this project.
- NHDOT/BA has authorized Gale to circulate the Change Order for signatures. The Change Order will add approximately \$23,000 in work to this Contract. We anticipate underruns from other areas of work will cover this additional cost.

Recommended Actions:

Please sign the Change Order No. 1 upon receipt.

RELOCATE AWOS/SAWS

This project is for the design, bidding, and construction phase services associated with relocating the existing AWOS/SAWS at the Airport. The weather equipment will be moved to a location between Taxiway 'A' on the 14 end, and Taxiway 'C' and Taxiway 'D' as depicted on the ALP. It is anticipated that this project will be funded using BIL funds.

Project Status:

- Gale has received comments on the draft Scope of Work from the NHDOT/BA and FAA. The
 edits have been made, and we're currently waiting for FAA to provide a draft Reimbursable
 Agreement for their services. Once received, we will review and revise our Scope/Fee as needed
 to make sure all project requirements are being met.
- No update on this project since last month's meeting.

Recommended Actions:

None at this time.

LAND ACQUISITION

This project is for the acquisition of one privately owned parcel.

Project Status:

- During the January Authority meeting, the Authority voted and authorized Gale solicit an Appraiser and Review Appraiser to commence work on the acquisition of one parcel.
- Following the January Authority meeting, Gale solicited proposals for Appraisal and Review Appraisal services.

- Appraisal and Review Appraisal tasks have been completed. A written offer, and purchase and sale agreement have been prepared and sent to the City's attorney for review and comment.
- Once comments are received from the attorney, a formal written offer will be made to the property owner.

Recommended Actions:

None at this time.

TOWER SITING STUDY

This project will evaluate up to three (3) possible locations for a new Air Traffic Control Tower, and make a final recommendation on the preferred location.

Project Status:

- A Project kickoff meeting was held on Thursday April 13th to discuss the project, project scope, and Gale's involvement in the project.
- The next step is to schedule a project discovery meeting with the Air Traffic Organization (ATO)
 and develop a reimbursable agreement for FAA's services to site a new ATCT. Gale will be
 coordinating this meeting this week.

 - o Gale is now under contract with a second developer for engineering services related to the construction of a hangar(s).
