

ORDINANCE NO. 368

ORDINANCE ANNEXING TERRITORY

AN ORDINANCE TO ANNEX CERTAIN TERRITORY AND TO
INCORPORATE THE SAME WITHIN THE CORPORATE
BOUNDARIES OF THE CITY OF ROLLA, COUNTY OF ROLETTE,
STATE OF NORTH DAKOTA, PURSUANT TO THE PROVISIONS OF
NDCC CHAPTER 40-51.2

Be it ordained by the City of Rolla, County of Rolette, State
of North Dakota as follows:

PREAMBLE

1. A petition in writing has been presented to the City Council
of the City of Rolla, signed by owners of real and personal property
of the territory herein described requesting annexation of their
properties to the City of Rolla.

2. Notice thereof was published in the Turtle Mountain Star on
April 8, 1985.

3. It appears that the prosperity of this city and of the
territory herein described will be materially retarded and the safety
and welfare of the inhabitants and property thereof endangered if such
territory is not annexed.

4. The annexation of such territory is deemed necessary for the
welfare of the residents and property owners thereof and of this
city as a whole.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of
Rolla, County of Rolette, State of North Dakota as follows:

SECTION ONE

There is hereby annexed to the City of Rolla, County of Rolette,
State of North Dakota, and incorporated within the corporate bound-
aries thereof, the following territory adjoining the present corpor-
ate boundaries of the City:

Beginning at the Northeast Corner of Block D, Parkview Third Addition to the City of Rolla; then West on the North line of Block D a distance of 145 feet; then North at a right angle a distance of 100 feet; then East at a right angle a distance of 145 feet; then South at a right angle a distance of 100 feet to the point of beginning. Said property comprising .34 acres more or less on Neameyer Drive North, in the S1/2SW1/4SW1/4 of Section Nine (9), Township One Hundred Sixty-Two (162), Range Sixty-Nine (69), Mt. Pleasant Township.

SECTION TWO

The corporate limits of the City of Rolla are hereby extended and increased so as to include and embrace within the corporate limits of the City of Rolla, the territory described in Section One hereof, and such territory is hereby declared to be a part of the City of Rolla.

SECTION THREE

The map attached to this ordinance is an accurate map of the territory annexed, and the same is hereby adopted as the official map of the territory annexed, and the Mayor of the City of Rolla, is hereby authorized and directed to certify that the map is an accurate map of the territory annexed under the provisions of this ordinance, and to record in the Office of the Register of Deeds, this ordinance together with a certified copy of the official map attached hereto.

This ordinance shall take effect immediately after its final passage, the public welfare requiring it.


