- Removes provision allowing release for stocking
- Transfer permit only for listed deer and only to 1 location
- Requires transport manifest of specific deer for multiple vehicles going to location, vehicle with multiple trips to a location and a trip with multiple stops along the way

- Requires getting permit online except may contact law enforcement communication center by phone or email if not working
- Possession at non-permitted facility requirements: facility identification number, complete permit within 48 hours of movement
- Permit not required for transport for emergency medical treatment only not just trip to vet AND must not be removed from transport vehicle at any time including during treatment OR not be housed with susceptible species OR get transfer permit before return AND any deaths during transfer must be reported

Prohibited:

- Holding at facility when not on herd inventory except fawn
- Possessing breeder deer in nursing facility longer than 120 days
- Hold more than 1 species at a time
- Facility inspectors from issuing letter of endorsement without inspection
- Violating any disease-testing plan
- Clone white-tailed or mule deer without special permit
- Allowing deer, livestock and exotic livestock in facility except deer on herd inventory and underage offspring

Transfer ownership: replaces sale or donation with transfer to those entities listed AND release must only be to certified release site

- Removes definitions for release to the wild, supervisory responsibility, transportation and volunteer
- Adds wildlife definition (protected wildlife)
- Activities must be done at the rehabilitation facility registered except for transport and retrieval
- Subpermittees may only do activities at the facility unless under direct supervision
- Prohibits allowing the wildlife to comingle with domestic pets, livestock, exotic livestock, exotic fowl or non-indigenous wildlife
- Changes permit holder to permittee
- May not rehabilitate animals on same property as deer breeding facility unless authorized in writing
- For non-releasable wildlife, requires vet statement that it is non-releasable and the reasons AND prohibits animals with diseases or conditions that endangered humans or other animals
- White-tailed and mule deer need 1) immediate 15 digit RFID or dangle tag AND prohibits removing them, 2) reporting of deaths within 24 hours, and 3) a transport permit to move them
- Vaccines must be under consult of vet in compliance with extra-label use
- Deceased wildlife must be transferred to authorized person or Type 1 landfill with white-tail and mule deer needing CWD testing
- Allows manual application if electronic is unavailable

- Prohibits rehabilitation unless permitted AND removes exemption for unprotected species since new wildlife definition already limits it to protected species
- Subpermittees no longer allowed to rehabilitate
- Allows applications to be on forms approved by Department instead of their forms
- Moves qualifications to applications for permits section
- Allows either 1) training course, 2) letter of recommendation which must be from vet or rehabilitator with 3 years' experience that knew person 2 years, or 3) 100% on exam (used to be 80%)
- Removes membership in state or national rehabilitation organization and attendance at a rehabilitation conference in last 3 years as options for applications
- Renewals require either 1) International Wildlife Rehabilitation Coalition or the National Wildlife Rehabilitator's Association training course in prior 3 years, 2) certification by International Wildlife Rehabilitation Coalition, 3) attend wildlife rehab conference in last 3 years
- White-tail and mule deer facilities must in department approved enclosure to prevent escape or contact with other deer or animals
- Prohibits transfer of receipt of white-tail or mule deer from other states
- Release of white-tail or mule deer may only be released within 7' fence, site owner agrees to be responsible for it, and release is registered
- Release requires written permission of landowner
- Requires daily log kept for 2 years of animals with age and sex, date & time, name, address, phone and email of person received from, geographic location where found and date & time of final disposition including method & disposal location if euthanized
