Special Board Meeting Minutes
February 17, 2009**

A MOTION was MADE, SECONDED and unanimously PASSED electing Marianne Bishop to serve as Secretary of the Board until the 2010 Annual Meeting.

The next order of business was to elect a Treasurer to serve until the 2010 Annual Meeting. Marianne Bishop was nominated by Bob Christensen.

A MOTION was MADE, SECONDED and unanimously PASSED electing Marianne Bishop to serve as Treasurer of the Board until the 2010 Annual Meeting.

The next order of business was to elect one or more Vice Presidents to serve until the 2010 Annual Meeting.

Ed Eick and Delores Leavitt were nominated by Marianne Bishop to serve as Vice President. Motion carried.

The next order of business was to appoint the Architectural Committee.

A MOTION was MADE by Marianne Bishop SECONDED and unanimously PASSED approving Jerry Larsen, Jerry LeTendre, Don Peterson and Susan Trecartin to serve as members of the Architectural Committee until the 2010 Annual Meeting and that Ed Eick will serve as Board Representative to this Committee.

The next order of business was to appoint the Maintenance Committee.

The next order of business was to appoint the members of the Security Committee to serve until the 2010 Annual Meeting. Marianne Bishop proposed the following appointments.

A MOTION was MADE, SECONDED and unanimously PASSED approving Chuck Catino, Jim MacLaren and Gary Raff to serve as members of the Security Committee until the 2010 Annual Meeting and that Jim MacLaren serve as the Chair to this Committee.

The meeting was adjourned at 11:45 AM.
