**Engineer's Report - Jack Kusek**

- A motion was made by Todd Anderson 2<sup>nd</sup> by Mark Zimmer to allow CICER to level and clear the old nursery property after removing cement, trees, buildings etc. The amount not to exceed \$25,000.
- A motion was made by Tom Goskusky and 2<sup>nd</sup> by Mike Supan Jr. to charge Connexus monthly rent in the amount of \$250 for the use of a village owned building.
