### **New Business:**

- a. Klocke reviewed the status of the project with the Council. Karl Peters Construction will be working on the point repairs in the next week or two. After that, SAK will be able to come in and complete the lining. The manholes are scheduled to be lined beginning October 8<sup>th</sup>. There is a 400' section that is a combination of pvc and cast iron that does not require lining at this time. There is also a 300' segment from manhole 2008 to 2004A that contains multiple bends and cannot be lined. The pipe would need to be replaced by open-cut methods. Klocke will check into adding this to the current loan. Locates and a survey of the area would most likely be done in the fall then put out for bids with work beginning in the spring.
  - Klocke also reported that two companies had contacted him regarding lining private service lines. DeGoey and Clark will contact residents to gather a list of interested people and contact the companies for estimated costs.
- Parsons moved and was seconded by DeGoey to approve the third reading of Ordinance No. 2013-002 amending provisions pertaining to installment payment of cost of abatement. Upon roll call vote, motion carried unanimously.
