(a) Metered Rates

(b) Minimum Charge

Each user shall pay a minimum charge based on the size of meter installed, for which the user will be entitled to the quantity of water set forth in the metered schedule of rates.

APPENDIX A

WHOLESALE WATER COST ADJUSTMENT TRACKING FACTOR

The Wholesale Water Cost Adjustment Tracking Factor is occasioned solely by changes in the cost of purchasing water from the Utility's wholesale water suppliers. The base cost of purchased water imbedded in the current base rates and charges amounts to an average cost of \$2.12 per 1,000 gallons.

APPENDIX B

NON-RECURRING CHARGES

Description of Charges

(d) Tap Fee

Each user shall pay a charge of \$1500 for a 5/8" meter to be set. For any meter larger than 5/8" the cost shall be \$1800 plus the additional cost of labor and materials. All tap on fees must be paid in advance before the installation of the meter.

(e) Reconnection Charge \$75.00

Accounts not paid in full by month's end are delinquent and will have services disconnected. Any customer whose service has been disconnected for reason of non-payment of monthly charges, and such service is subsequently restored, shall pay a reconnection fee.

(f) Late Payment Charge

A utility service bill shall be rendered as a net bill. If the net bill is not paid by the billing due date, it shall become delinquent and a late payment charge may be added in the amount of ten (10) percent of the current bill due.

(g) Insufficient Funds, Closed Accounts, Frozen Accounts, & Uncollected Funds \$25.00

Sewer rate is \$14.15 per thousand gallons with the minimum monthly bill being \$25.25

Sewer rate for Morgan School is \$11.86 per thousand gallons with the minimum monthly bill being \$355.45
