#### SOMETHING NEW HAS BEEN ADDED!

The Washington State Department of Fish and Wildlife is making an attempt to collect information from fly fishermen at Merrill Lake in order to better meet our requests for successful management of the lake's resources (fish). On Friday, June 21 an Angler Survey Box was installed, and all fly fishermen are asked to voluntarily take a few minutes to fill out the confidential surveys. There are some pencils provided, but you may need to provide your own writing instrument because they may disappear over time.

The survey simply asks for the date, the fisherman's postal zip code, whether you fished from boat or shore, what time you started and what time you stopped. There is a blank chart where you are asked to put in species caught, length, weight, and gear type (of course we know that's going to be fly fishing). There is also a space for your comments, and a space to put your contact information if you would like a response from WDFW.

After you've obtained the form from the box, which is installed on a support of CSF's Fly Fishing Only sign, fill it out and slip the completed form into the slot in the rear portion of the box. The forms will be collected periodically and used to help establish a data base from which intelligent stocking and management decisions can be made.

The cooperation of all members of CSF and their guests is needed, and it would also help if you would encourage any fly fishermen you encounter to participate. We can all profit from letting WDFW know what measure of success (or not) that we are having there on our fishing outings.
