**FINANCIAL:** You are responsible for the following fees during the dance year:

**Registration fee:** \$30 (for 1 student), \$50 (for 2 students), \$60 (for 3 or more)

**Monthly Tuition:** due by the **10<sup>th</sup> of Aug, Sept, Oct, Nov, Dec, Jan, Feb, Mar, Apr**

\$38 for 1 class, \$66 for 2, \$91 for 3, \$116 for 4, \$131 for 5 or more

\*\$10 Late fees will be accessed to all past due accounts on the last week of the each month.

**Annual Recital Fee:** due by November 25<sup>th</sup>: \$25 (3YO – 5<sup>th</sup> Grade) &  
\$35 (6<sup>th</sup> – 12<sup>th</sup> Grade)

**Spring Costume Fee:** due by November 25<sup>th</sup>: 3yo – Kindergarten T&B (\$50),  
1<sup>st</sup> – 5<sup>th</sup> T&B(\$55), 6<sup>th</sup> – 12<sup>th</sup> T&B(\$50), All Jazz (\$50),  
All Baton (\$45), All others HH, Jallet, Pointe, etc (\$25)

\*Costume fees will not be refunded if you drop after they have been ordered in December, please consider this when registering. You will be given the costume in March/April.

**ATTENDANCE:** DANCE IS A 9 MONTH COMMITMENT! You cannot learn or grow your talent if you are not here!! All students need to attend class each and every week. If you know of another activity or reason that will cause you to continually miss dance please carefully consider your participation as it does affect the class as a whole. We DO NOT have half year sessions at ASOD.

**ATTIRE:** For young ladies: tights or a spandex leg covering of any color, with a leotard of any color, shorts or short dance skirt, tank or cami top, ponytail or hair securely back from face, appropriate shoes for class; Students will be asked to step out of class if they are not appropriately dressed.

**ATTITUDE:** Is everything! And we will not allow bad attitudes and disrespect for other students and teachers to come through our door. I expect respect and positive attitudes out of both our students and teachers. Teachers will technically adjust, correct and call out students who are not getting a step or skill. THIS IS TECHNICAL not personal!!

**LIABILITY:** This student is physically able to safely participate in dance related activities and while rare, I understand that there is a risk of injury. I acknowledge that the registered student is covered under an adequate insurance policy and I release Armstrong School of Dance, Inc. officers, staff, owners, faculty of all injury or medical bills.
