Town Board Meeting 8-9-21

CALL TO ORDER: The meeting of the Town of Eaton was called to order by Chairman Rick Christel at 6:30 p.m., Monday, August 9, 2021 at the Eaton Town Hall. The Pledge Allegiance to the flag was recited by all.

MEETING NOTICES: Meeting notices were posted at the Eaton Town Hall and the Town Website

ROLL CALL: Rick Christel, Chairman; Adam Schetter, Supervisor, Lewy Schema, Supervisor, Paulette Vogt, Clerk, Pam Schneider, Treasurer, and Craig Zipperer, Road Superintendent, were in attendance along with Randy Knier.

AGENDA: The agenda had been emailed previously. Supervisor Schema made a motion to accept the agenda, Supervisor Schetter 2nd the same, and motion carried.

MINUTES: The minutes from the July 12, 2021 board meeting had been emailed to the Board previously. Supervisor Schetter made a motion to accept the minutes, Supervisor Schema 2nd the motion. Motion carried.

PUBLIC INPUT: There being no public input, Chairman Christel closed public input.

ROAD SUPERINTENDENT: Superintendent Craig Zipperer reported on the many jobs he has been doing this month to include cutting brush and spraying in the ditches, doing shouldering where washouts have taken place, doing some culvert work. Craig also got the 550 back from Truck Equipment.

SUPERVISOR 1: No report

SUPERVISOR 2: Supervisor Schema had questions on whether the mailbox issue and stone fence were taken care of on Lechler Lane.

TREASURER' REPORT: Treasurer Pam Schneider reported \$277,737.78 was the ending balance for July in the Bank First Elite Account. She further reported that there is \$9,999.36 in the Bank First Checking Account. The Road Maintenance Account has a \$25,378.61 balance, the Road Equipment has a \$10,000 balance, the Dog Fund has a \$1,025.56 balance, and the checking account interest has a balance of \$514.98. The ½ Recovery Money (\$43,123.44) that the Town received is now a separate line item.

Supervisor Schema made a motion to accept the treasurer's report and Supervisor Schetter 2nd the same. Motion carried.

CONSTABLE'S REPORT: Garbage is being found in the town ditches once again.

ASSESSOR'S REPORT: No Report

CHAIRMAN'S REPORT:

Garbage Disposal Contract: The garbage at the recycling center has not been picked up on a regular basis according to the contract the town has with Waste Management. Mr. Michael Thun came to represent Harter's Lakeside Disposal Services. After much discussion with Mr. Thun, and many questions that were asked and answered, Chairman Rick Christel made a motion to have the Clerk send the town's attorney a request to draft a letter to get a release from the town's contract with Waste Management as of December 31, 2021. Supervisor Schetter 2nd the same. Motion carried

St. Nazianz Fire Depart Drill Container Request: Chief Mike Hoffman came to the meeting to represent the St. Nazianz Fire Department and answer any questions about the training container to be placed at the Eaton Recycling center. The Fire Department will have the liability insurance on this container. It will be put as far away from the recycling area as possible. A pad will be made of gravel for the 20 foot shipping container to rest on and a decal with the Fire Department's name will be put on the container. After some discussion Supervisor Schema made a motion to allow the St. Nazianz Fire Department to set up a shipping container/training unit at the Eaton recycling center to include the St. Nazianz Fire Department proof of liability insurance. Supervisor Schetter 2nd said motion. Motion carried.

Approve Vouchers: July Vouchers were paid with a motion from Supervisor Schema and a 2nd from Supervisor Schetter in the amount of \$35,103.58. Motion carried.

MEETING REPORTS: No Report. Chairman Christel would like the Board to take a look at the intersection by Schulers and report back at next month's meeting.

MISCELLANEOUS: No report.

CLERKS REPORT: No report.

With no further business to report, Supervisor Schema made a motion to adjourn the meeting. Supervisor Schetter 2nd the same. Motion carried.
