Interlake Regional Water Utility Board Bylaw No. 2/2020

A BYLAW OF THE INTERLAKE REGIONAL WATER BOARD TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND THE RATES TO BE CHARGED FOR THE INFRASTRUCTURE.

The Board of the Interlake Regional Water Utility Board, in the Province of Saskatchewan, enacts as follows:

- 1. This Bylaw shall be known as the "Utility Rates Bylaw".
- 2. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Interlake Rates Schedule "A" attached; provided ,however, that the connection fee shall be payable in every case whether or not any water is consumed.
- 3. Accounts for water service shall cover a period of three consecutive months, and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be shut off. When the water service is shut off, it shall not be turned on until all arrears have been paid, together with the re-connect fees set out in Interlake Rates Schedule "A" attached, to cover expenses of turning off the water and turning it on again.
- 4. A late payment interest charge as set out in Interlake Rates Schedule "A" shall be added to all water accounts remaining outstanding thirty days after the quarterly billing date and shall be compounded monthly thereafter, to the amount in arrears. Accounts that remain in arrears for a period of 30 days or more may be subject to collection by authority under the Municipality Act.
- 5. The bulk water rate as set out in Interlake Rates Schedule "A" attached shall be charged only to persons obtaining water from the bulk distribution supply meter at the Interlake Water Plant.
- 6. Bylaw No 3/2019 adopted by resolution of Council on the 21st day of October 2019 is hereby repealed.

Interlake Rates Schedule "A" rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.



EXHIBIT "A"

AGREEMENT FOR THE ESTABLISHMENT OF A PUBLIC UTILITY BOARD

Whereas the parties to this agreement are municipalities, within the meaning of The Municipalities Act. S.S. 2005, c M-36:1("the Act");

And whereas the parties have the authority and, in some cases, the obligation to provide a system for the supply, meatment, storage, and distribution of water within all parts of the sumicipality;

And whereas a system to provide water for the public consumption, benefit, convenience or use is a public utility within the meaning of the Act;

And whereas the parties are desirous of jointly establishing a public utility board to manage and operate such a system for their mutual benefit;

Now therefore this agreement witnesses as follows:

ESTABLISHMENT OF PUBLIC UTILITY BOARD

- 1 A public utility board shall be established upon each of the municipalities listed ansering a bylaw authorizing the entering into of this agreement.
- 2 The public policy board shall be known as the Interlake Regional Water Board (the Board).

MANDATE OF THE BOARD

3 The Board is established for the purpose of planning, constructing, managing and operating a system for the supply, treatment, storage and distribution of water for the benefit of the participating municipalities.

ACCOUNTABILITY OF THE BOARD

- 4 The Board shall be accommable to the partner municipalities only at a joint meeting of the partner councils represented by the Mayor and two aldermen or alternatively farea aldermen from the Resort Village of Cookin and the Reeve and two Councillors or alternatively three Councillors from the R.M.of Meeta #468 herein after called a "proper meeting".
- 5 A "propor meeting" shall be chaired on a two year rotating basis by a representative of the R.M.of Meots #468 and a representative of the Resort Village of Cochin.
- 6 A "proper meeting" shall be held at least once per year on or before the 31st of March.
- 7 A "proper meeting" may be called at the pleasure of the chair of the "proper meeting" or the chair of "the Board".

THE BOARD

- 8 The Board shall consist of five (5) members.
- 9 Members of the Board will be appointed by a joint meeting of both councils.
- 10 Members of the Board will be chosen from at large provided they are meepayers in either of the partner municipalities.
- 11 No elected person, federal, provincial or municipal may sit on the Board.
- 12 Board members shall be entitled to a per diem for appropriate meetings and also to a travel allowance, both of which will be according to schedule "C" which forms part of this agreement. Schedule "C" may be amended by resolution of a "proper meeting".
